5 day, or pursuant to RCW 72.64.050 and 72.64.060, or community custody
6 as directed under RCW 9.94A.701 (1)(b) or (2) as a result of a

EFFECT: Prohibits persons on community custody for a violent offense or serious violent offense against a judge, sheriff, prosecutor, or law enforcement officer from being registered to vote before release from custody.
