14 The appropriation in this section is subject to the following  
15 conditions and limitations:

16 (1) The appropriation is subject to the provisions of RCW  
17 43.63A.750.

18 (2) Except as directed otherwise prior to the effective date of  
19 this section, the department may not expend the appropriation in this  
20 section unless and until the nonstate share of project costs have  
21 been either expended, or firmly committed, or both, in an amount  
22 sufficient to complete the project or a distinct phase of the project  
23 that is useable to the public for the purpose intended by this  
24 appropriation. This requirement does not apply to projects where a  
25 share of the appropriation is for design costs only.
