2 material through "41.12.100" on line 12 and insert "within four years  
3 of successful completion of the basic law enforcement academy"

4 On page 2, beginning on line 23, after "(4)" strike all material  
5 through "score." on line 35 and insert "Consistent with the scoring  
6 scheme outlined in RCW 41.04.010, a hiring law enforcement agency  
7 shall add a maximum of 10 percent to the passing mark, grade, or  
8 rating of any applicant for any of the following qualifications:

9 (a) Proficiency, as defined by the local jurisdiction, in a  
10 language other than English;

11 (b) Two or more years of professional or volunteer experience in

23 rating of any applicant for any of the following qualifications:

24 (a) Proficiency, as defined by the local jurisdiction, in a

5 through "score." on page 7, line 7 and insert "Consistent with the  
6 scoring scheme outlined in RCW 41.04.010, a hiring law enforcement  
7 agency shall add a maximum of 10 percent to the passing mark, grade,  
8 or rating of any applicant for any of the following qualifications:

9 (a) Proficiency, as defined by the local jurisdiction, in a  
10 language other than English;

11 (b) Two or more years of professional or volunteer experience in  
12 the peace corps, AmeriCorps, domestic violence counseling, mental or

19 On page 1, line 3 of the title, after "43.43.360;" strike "and  
20 creating new sections" and insert "creating new sections; and  
21 providing an effective date"

EFFECT: Extends the time period for a newly hired law enforcement officer to complete an associate of arts or science degree from two years after completion of BLEA to four years. Provides an implementation date of July 1, 2025, for the Washington State Patrol. Clarifies that an applicant for the position of law enforcement officer may add a maximum of 10 points for preferences outlined in the bill and service in the military as provided in RCW 41.04.010.
