On page 1, beginning on line 1 of the title, after "to" strike all material through "RCW;" at the beginning of line 4, and insert "equity and access in higher education; amending RCW 28B.96.010 and 28B.15.012;"

- <u>EFFECT:</u> (1) Retains the requirement that colleges create culturally appropriate outreach programs and makes required elements of program options.
- (2) Requires the state board to create a faculty diversity program and removes the requirement that individual colleges create faculty diversity programs.
- (3) Specifies that guided pathways implementation is within existing resources.
- (4) Modifies the goal for adding new full-time tenure-track positions to be 200 in the 2021-2023 biennium only.
- (5) Removes the requirement that the counselor pilot program include 8 colleges.
- (6) Specifies that the minimum counselor standards must be implemented within existing resources.
 - (7) Eliminates the Washington College Grant stipend program.
