- 1 AN ACT Relating to exempting biomarker testing from prior
- 2 authorization for patients with late stage cancer; and adding a new
- 3 section to chapter 48.43 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 48.43 6 RCW to read as follows:
- 7 (1) Health plans issued or renewed on or after January 1, 2023,

shall exempt an enrollee from biomarker testing prior authorization

- 9 requirements for either of the following:
- 10 (a) Stage 1, 2, 3, or 4 cancer; or
- 11 (b) Cancer progression or recurrence in the enrollee with stage
- 12 1, 2, 3, or 4 cancer.

- 13 (2) For purposes of this section, "biomarker test" means a single
- 14 or multigene diagnostic test of the cancer patient's biospecimen,
- 15 such as tissue, blood, or other bodily fluids, for DNA, RNA, or
- 16 protein alterations, including phenotypic characteristics of a
- 17 malignancy, to identify an individual with a subtype of cancer, in
- 18 order to guide patient treatment.
- 19 (3) For purposes of this section, biomarker testing must be:

- (a) Recommended in the latest version of nationally recognized guidelines or biomarker compendia, such as those published by the national comprehensive cancer network;
- (b) Approved by the United States food and drug administration or a validated clinical laboratory test performed in a clinical laboratory certified under the clinical laboratory improvement amendments or in an alternative laboratory program approved by the centers for medicare and medicaid services;
 - (c) A covered service; and

- (d) Prescribed by an in-network provider.
- (4) This section does not limit, prohibit, or modify an enrollee's rights to biomarker testing as part of an approved clinical trial under chapter 69.77 RCW.
- 14 (5) Nothing in this section may be construed to mandate coverage 15 of a health care service.
- 16 (6) This section does not limit an enrollee's rights to access 17 individual gene tests.
- 18 (7) If individual biomarker tests are included as part of larger 19 testing panels, nothing in this section prohibits a health plan from 20 requiring prior authorization for any tests included in the panel 21 that are in addition to the biomarker tests outlined in subsection 22 (3) of this section.
