1 AN ACT Relating to transportation resources; amending RCW

19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

20 **Part I**
21 **Climate Commitment Act Allocations**

1 **Sec. 101.** RCW 70A.65.240 and 2021 c 316 s 27 are each amended to
2 read as follows:

3 (1) The carbon emissions reduction account is created in the
4 state treasury. Moneys in the account may be spent only after
5 appropriation. Expenditures from the account are intended to affect
6 reductions in transportation sector carbon emissions through a
7 variety of carbon reducing investments. These can include, but are
8 not limited to: Transportation alternatives to single occupancy
9 passenger vehicles; reductions in single occupancy passenger vehicle
10 miles traveled; reductions in per mile emissions in vehicles,
11 including through the funding of alternative fuel infrastructure and
12 incentive programs; and emission reduction programs for freight
13 transportation, including motor vehicles and rail, as well as for
14 ferries and other maritime and port activities. Expenditures from the
15 account may only be made for transportation carbon emission reducing
16 purposes and may not be made for highway purposes authorized under
17 the 18th Amendment of the Washington state Constitution, other than
18 specified in this section, and shall be made in accordance with
19 subsection (2) of this section. It is the legislature's intent that
20 expenditures from the account used to reduce carbon emissions be made
21 with the goal of achieving equity for communities that historically
22 have been omitted or adversely impacted by past transportation
23 policies and practices.

24 (2) Appropriations in an omnibus transportation appropriations
25 act from the carbon emissions reduction account shall be made
26 exclusively to fund the following activities:

27 (a) Active transportation;

28 (b) Transit programs and projects;

29 (c) Alternative fuel and electrification;

30 (d) Ferries; and

31 (e) Rail.

32 NEW SECTION. **Sec. 102.** The legislature intends to program
33 funding from the carbon emissions reduction account, the climate
34 active transportation account, and the climate transit programs
35 account for the activities identified in LEAP Transportation Document
36 2022-A as developed February 8, 2022.

37 NEW SECTION. **Sec. 103.** A new section is added to chapter 46.68
38 RCW to read as follows:

1 (1) The climate active transportation account is hereby created
2 in the state treasury. Moneys in the account may be spent only after
3 appropriation. Expenditures from the account may be used only for the
4 following active transportation grant programs: Safe routes to
5 schools, school-based bike program, bicycle and pedestrian grant
6 program, complete streets grants program, and connecting communities
7 grant program, as well as pedestrian and bicycle or other active
8 transportation projects identified in an omnibus transportation
9 appropriations act as move ahead WA projects.

10 (2) Beginning July 1, 2022, the state treasurer shall annually
11 transfer 24 percent of the revenues accruing annually to the carbon
12 emissions reduction account created in RCW 70A.65.240 to the climate
13 active transportation account.

14 NEW SECTION. **Sec. 104.** A new section is added to chapter 46.68
15 RCW to read as follows:

16 (1) The climate transit programs account is hereby created in the
17 state treasury. Moneys in the account may be spent only after
18 appropriation. Expenditures from the account may be used only for the
19 following transit grant programs: Transit support grant program,
20 tribal transit mobility grants, transit coordination grants, special
21 needs transit grants, bus and bus facility grant program, green
22 transit grants, and transportation demand management grants, as well
23 as transit projects identified in an omnibus transportation
24 appropriations act as move ahead WA projects.

25 (2) Beginning July 1, 2022, the state treasurer shall annually
26 transfer 56 percent of the revenues accruing annually to the carbon
27 emissions reduction account created in RCW 70A.65.240 to the climate
28 transit programs account.

29 **Sec. 105.** RCW 70A.65.030 and 2021 c 316 s 4 are each amended to
30 read as follows:

31 (1) Each year or biennium, as appropriate, when allocating funds
32 from the carbon emissions reduction account created in RCW
33 70A.65.240, the climate investment account created in RCW 70A.65.250,
34 ~~((~~o~~))~~ the air quality and health disparities improvement account
35 created in RCW 70A.65.280, the climate transit programs account
36 created in section 104 of this act, or the climate active
37 transportation account created in section 103 of this act, or
38 administering grants or programs funded by the accounts, agencies

1 shall conduct an environmental justice assessment consistent with the
2 requirements of RCW 70A.02.060 and establish a minimum of not less
3 than 35 percent and a goal of 40 percent of total investments that
4 provide direct and meaningful benefits to vulnerable populations
5 within the boundaries of overburdened communities through: (a) The
6 direct reduction of environmental burdens in overburdened
7 communities; (b) the reduction of disproportionate, cumulative risk
8 from environmental burdens, including those associated with climate
9 change; (c) the support of community led project development,
10 planning, and participation costs; or (d) meeting a community need
11 identified by the community that is consistent with the intent of
12 this chapter or RCW 70A.02.010.

13 (2) The allocation of funding under subsection (1) of this
14 section must adhere to the following principles, additional to the
15 requirements of RCW 70A.02.080: (a) Benefits and programs should be
16 directed to areas and targeted to vulnerable populations and
17 overburdened communities to reduce statewide disparities; (b)
18 investments and benefits should be made roughly proportional to the
19 health disparities that a specific community experiences, with a goal
20 of eliminating the disparities; (c) investments and programs should
21 focus on creating environmental benefits, including eliminating
22 health burdens, creating community and population resilience, and
23 raising the quality of life of those in the community; and (d)
24 efforts should be made to balance investments and benefits across the
25 state and within counties, local jurisdictions, and unincorporated
26 areas as appropriate to reduce disparities by location and to ensure
27 efforts contribute to a reduction in disparities that exist based on
28 race or ethnicity, socioeconomic status, or other factors.

29 (3) State agencies allocating funds or administering grants or
30 programs from the carbon emissions reduction account created in RCW
31 70A.65.240, the climate investment account created in RCW 70A.65.250,
32 ~~((~~o~~))~~ the air quality and health disparities improvement account
33 created in RCW 70A.65.280, the climate transit programs account
34 created in section 104 of this act, or the climate active
35 transportation account created in section 103 of this act, must:

36 (a) Report annually to the environmental justice council created
37 in RCW 70A.02.110 regarding progress toward meeting environmental
38 justice and environmental health goals;

39 (b) Consider recommendations by the environmental justice
40 council; and

1 (c)(i) If the agency is not a covered agency subject to the
2 requirements of chapter 314, Laws of 2021, create and adopt a
3 community engagement plan to describe how it will engage with
4 overburdened communities and vulnerable populations in allocating
5 funds or administering grants or programs from the climate investment
6 account.

7 (ii) The plan must include methods for outreach and communication
8 with those who face barriers, language or otherwise, to
9 participation.

10 **Sec. 106.** RCW 70A.65.040 and 2021 c 316 s 5 are each amended to
11 read as follows:

12 (1) The environmental justice council created in RCW 70A.02.110
13 must provide recommendations to the legislature, agencies, and the
14 governor in the development and implementation of the program
15 established in RCW 70A.65.060 through 70A.65.210, and the programs
16 funded from the carbon emissions reduction account created in RCW
17 70A.65.240 (~~and from~~), the climate investment account created in
18 RCW 70A.65.250, the climate transit programs account created in
19 section 104 of this act, and the climate active transportation
20 account created in section 103 of this act.

21 (2) In addition to the duties and authorities granted in chapter
22 70A.02 RCW to the environmental justice council, the environmental
23 justice council must:

24 (a) Provide recommendations to the legislature, agencies, and the
25 governor in the development of:

26 (i) The program established in RCW 70A.65.060 through 70A.65.210
27 including, but not limited to, linkage with other jurisdictions,
28 protocols for establishing offset projects and securing offset
29 credits, designation of emissions-intensive and trade-exposed
30 industries under RCW 70A.65.110, and administration of allowances
31 under the program; and

32 (ii) Investment plans and funding proposals for the programs
33 funded from the climate investment account created in RCW 70A.65.250
34 for the purpose of providing environmental benefits and reducing
35 environmental health disparities within overburdened communities;

36 (b) Provide a forum to analyze policies adopted under this
37 chapter to determine if the policies lead to improvements within
38 overburdened communities;

1 (c) Recommend procedures and criteria for evaluating programs,
2 activities, or projects;

3 (d) Recommend copollutant emissions reduction goals in
4 overburdened communities;

5 (e) Evaluate the level of funding provided to assist vulnerable
6 populations, low-income individuals, and impacted workers and the
7 funding of projects and activities located within or benefiting
8 overburdened communities;

9 (f) Recommend environmental justice and environmental health
10 goals for programs, activities, and projects funded from the climate
11 investment account, and review agency annual reports on outcomes and
12 progress toward meeting these goals;

13 (g) Provide recommendations to implementing agencies for
14 meaningful consultation with vulnerable populations, including
15 community engagement plans under RCW 70A.65.020 and 70A.65.030; and

16 (h) Recommend how to support public participation through
17 capacity grants for participation.

18 (3) For the purpose of performing the duties under subsection (2)
19 of this section, two additional tribal members are added to the
20 council.

21 **Part II**

22 **Exported Fuel Tax, Aircraft Fuel Tax, Stolen Vehicle Check, Dealer**
23 **Temporary Permit, Enhanced Driver's License and Identocard, Driver's**
24 **Abstract, License Plate, Documentary Service, and Other**
25 **Driver and Vehicle Fees**

26 NEW SECTION. **Sec. 201.** FINDINGS AND INTENT. (1) The legislature
27 finds that a portion of the state's greenhouse gas emissions are
28 directly related to petroleum fuel products produced by the state's
29 five refineries that are exported to other states and jurisdictions.
30 These carbon emissions have a real impact on the citizens of the
31 state of Washington and these impacts are not adequately compensated
32 for under the existing taxing structures.

33 (2) The legislature further finds that carbon emissions directly
34 attributable to just the refining process associated with petroleum
35 fuel products that are subsequently exported has been estimated at
36 3,300,000 metric tons per year.

37 (3) The legislature further finds that the costs associated with
38 carbon emissions are global in nature and the impacts associated with

1 carbon emissions are not simply felt by those within a state's
2 geographic boundary. However, applying a standard societal costs of
3 carbon method results in estimated annual impacts over \$250,000,000
4 associated with the current amount of exported petroleum fuel
5 products.

6 (4) Therefore, the legislature intends to modify state fuel tax
7 law in a manner that compensates the state for a portion of the
8 societal costs of carbon attributable to the refining process
9 associated with petroleum fuel products that are subsequently
10 exported, but also ensures that the current favorable tax treatment
11 for petroleum fuel products that are exported continues.

12 **Sec. 202.** RCW 82.38.020 and 2013 c 225 s 102 are each amended to
13 read as follows:

14 The definitions in this section apply throughout this chapter
15 unless the context clearly requires otherwise.

16 (1) "Biofuel" means fuel derived from biomass that has at least
17 40 percent lower greenhouse gas emissions based on a full life-cycle
18 analysis when compared to petroleum fuel for which biofuel is capable
19 of serving as a substitute.

20 (2) "Blended fuel" means a mixture of fuel and another liquid,
21 other than a de minimis amount of the liquid.

22 ((+2)) (3) "Blender" means a person who produces blended fuel
23 outside the bulk transfer-terminal system.

24 ((+3)) (4) "Bond" means a bond duly executed with a corporate
25 surety qualified under chapter 48.28 RCW payable to the state of
26 Washington conditioned upon faithful performance of all requirements
27 of this chapter.

28 ((+4)) (5) "Bulk transfer-terminal system" means the fuel
29 distribution system consisting of refineries, pipelines, vessels, and
30 terminals. Fuel in a refinery, pipeline, vessel, or terminal is in
31 the bulk transfer-terminal system.

32 ((+5)) (6) "Bulk transfer" means a transfer of fuel by pipeline
33 or vessel.

34 ((+6)) (7) "Bulk storage" means the placing of fuel into a
35 receptacle other than the fuel supply tank of a motor vehicle.

36 ((+7)) (8) "Department" means the department of licensing.

37 ((+8)) (9) "Distributor" means a person who acquires fuel
38 outside the bulk transfer-terminal system for importation into
39 Washington, from a terminal or refinery rack located within

1 Washington for distribution within Washington, or for immediate
2 export outside the state of Washington.

3 ~~((9))~~ (10) "Dyed special fuel user" means a person authorized
4 by the internal revenue code to operate a motor vehicle on the
5 highway using dyed special fuel, in which the use is not exempt from
6 the fuel tax.

7 ~~((10))~~ (11) "Evasion" or "evade" means to diminish or avoid the
8 computation, assessment, or payment of authorized taxes or fees
9 through:

10 (a) A knowing: False statement; omission; misrepresentation of
11 fact; or other act of deception;

12 (b) An intentional: Failure to file a return or report; or other
13 act of deception; or

14 (c) The unlawful use of dyed special fuel.

15 ~~((11))~~ (12) "Exempt sale" means the sale of fuel to a person
16 whose use of fuel is exempt from the fuel tax.

17 ~~((12))~~ (13) "Export" means to obtain fuel in this state for
18 sales or distribution outside the state. Fuel distributed to a
19 federally recognized Indian tribal reservation located within the
20 state of Washington is not considered exported outside this state.

21 ~~((13))~~ (14) "Exporter" means a person who purchases fuel
22 physically located in this state at the time of purchase and directly
23 exports the fuel by a means other than the bulk transfer-terminal
24 system to a destination outside of the state. If the exporter of
25 record is acting as an agent, the person for whom the agent is acting
26 is the exporter. If there is no exporter of record, the owner of the
27 fuel at the time of exportation is the exporter.

28 ~~((14))~~ (15) "Fuel" means motor vehicle fuel or special fuel.

29 ~~((15))~~ (16) "Fuel user" means a person engaged in uses of fuel
30 that are not specifically exempted from the fuel tax imposed under
31 this chapter.

32 ~~((16))~~ (17) "Highway" means every way or place open to the use
33 of the public, as a matter of right, for the purpose of vehicular
34 travel.

35 ~~((17))~~ (18) "Import" means to bring fuel into this state by a
36 means of conveyance other than the fuel supply tank of a motor
37 vehicle.

38 ~~((18))~~ (19) "Importer" means a person who imports fuel into the
39 state by a means other than the bulk transfer-terminal system. If the
40 importer of record is acting as an agent, the person for whom the

1 agent is acting is the importer. If there is no importer of record,
2 the owner of the fuel at the time of importation is the importer.

3 ~~((19))~~ (20) "International fuel tax agreement licensee" means a
4 fuel user operating qualified motor vehicles in interstate commerce
5 and licensed by the department under the international fuel tax
6 agreement.

7 ~~((20))~~ (21) "Licensee" means a person holding a license issued
8 under this chapter.

9 ~~((21))~~ (22) "Motor vehicle" means a self-propelled vehicle
10 utilizing fuel as a means of propulsion.

11 ~~((22))~~ (23) "Motor vehicle fuel" means gasoline and any other
12 inflammable gas or liquid, by whatsoever name the gasoline, gas, or
13 liquid may be known or sold the chief use of which is as a fuel for
14 the propulsion of motor vehicles or vessels.

15 ~~((23))~~ (24) "Natural gas" means naturally occurring mixtures of
16 hydrocarbon gases and vapors consisting principally of methane,
17 whether in gaseous or liquid form.

18 ~~((24))~~ (25) "Person" means any individual, partnership,
19 association, public or private corporation, limited liability
20 company, or any other type of legal or commercial entity, including
21 their members, managers, partners, directors, or officers.

22 ~~((25))~~ (26) "Position holder" means a person who holds the
23 inventory position in fuel, as reflected by the records of the
24 terminal operator. A person holds the inventory position if the
25 person has a contractual agreement with the terminal for the use of
26 storage facilities and terminating services. "Position holder"
27 includes a terminal operator that owns fuel in their terminal.

28 ~~((26))~~ (27) "Rack" means a mechanism for delivering fuel from a
29 refinery or terminal into a truck, trailer, railcar, or other means
30 of nonbulk transfer.

31 ~~((27))~~ (28) "Refiner" means a person who owns, operates, or
32 otherwise controls a refinery.

33 ~~((28))~~ (29) "Removal" means a physical transfer of fuel other
34 than by evaporation, loss, or destruction.

35 ~~((29))~~ (30) "Special fuel" means diesel fuel, propane, natural
36 gas, kerosene, biodiesel, and any other combustible liquid or gas by
37 whatever name the liquid or gas may be known or sold for the
38 generation of power to propel a motor vehicle on the highways, except
39 it does not include motor vehicle fuel.

1 (~~(30)~~) (31) "Supplier" means a person who holds a federal
2 certificate of registry issued under the internal revenue code and
3 authorizes the person to engage in tax-free transactions of fuel in
4 the bulk transfer-terminal system.

5 (~~(31)~~) (32) "Terminal" means a fuel storage and distribution
6 facility that has been assigned a terminal control number by the
7 internal revenue service.

8 (~~(32)~~) (33) "Terminal operator" means a person who owns,
9 operates, or otherwise controls a terminal.

10 (~~(33)~~) (34) "Two-party exchange" or "buy-sell agreement" means
11 a transaction in which taxable fuel is transferred from one licensed
12 supplier to another licensed supplier whereby the supplier that is
13 the position holder agrees to deliver taxable fuel to the other
14 supplier or the other supplier's customer at the terminal at which
15 the delivering supplier is the position holder.

16 (35) "United States" means a state of the United States, the
17 District of Columbia, the Commonwealth of Puerto Rico, or a territory
18 or insular possession subject to the jurisdiction of the United
19 States. "United States" also includes all federally recognized tribal
20 reservations and federal trust lands within the geographic boundaries
21 of the United States as they exist now or in the future.

22 **Sec. 203.** RCW 82.38.030 and 2015 3rd sp.s. c 44 s 103 are each
23 amended to read as follows:

24 (1) There is levied and imposed upon fuel licensees a tax at the
25 rate of (~~(twenty-three)~~) 23 cents per gallon of fuel.

26 (2) Beginning July 1, 2003, an additional and cumulative tax rate
27 of five cents per gallon of fuel is imposed on fuel licensees. This
28 subsection (2) expires when the bonds issued for transportation 2003
29 projects are retired.

30 (3) Beginning July 1, 2005, an additional and cumulative tax rate
31 of three cents per gallon of fuel is imposed on fuel licensees.

32 (4) Beginning July 1, 2006, an additional and cumulative tax rate
33 of three cents per gallon of fuel is imposed on fuel licensees.

34 (5) Beginning July 1, 2007, an additional and cumulative tax rate
35 of two cents per gallon of fuel is imposed on fuel licensees.

36 (6) Beginning July 1, 2008, an additional and cumulative tax rate
37 of one and one-half cents per gallon of fuel is imposed on fuel
38 licensees.

1 (7) Beginning August 1, 2015, an additional and cumulative tax
2 rate of seven cents per gallon of fuel is imposed on fuel licensees.

3 (8) Beginning July 1, 2016, an additional and cumulative tax rate
4 of four and nine-tenths cents per gallon of fuel is imposed on fuel
5 licensees.

6 (9) ~~((Taxes))~~ Except as provided in subsection (10) of this
7 section, taxes are imposed when:

8 (a) Fuel is removed in this state from a terminal ~~((if the fuel~~
9 ~~is removed at the rack))~~ unless the removal is by a licensed supplier
10 or distributor for direct delivery to a destination outside of the
11 ~~((state))~~ United States, or the removal is by a fuel supplier for
12 direct delivery to an international fuel tax agreement licensee under
13 RCW 82.38.320;

14 (b) Fuel is removed in this state from a refinery if either of
15 the following applies:

16 (i) The removal is by bulk transfer and the refiner or the owner
17 of the fuel immediately before the removal is not a licensed
18 supplier; or

19 (ii) The removal is at the refinery rack or by bulk transfer
20 unless the removal is to a licensed supplier or distributor for
21 direct delivery to a destination outside of the ~~((state))~~ United
22 States, or the removal is to a licensed supplier for direct delivery
23 to an international fuel tax agreement licensee under RCW 82.38.320;

24 (c) Fuel enters into this state for sale, consumption, use, or
25 storage, unless the fuel enters this state for direct delivery to an
26 international fuel tax agreement licensee under RCW 82.38.320, if
27 either of the following applies:

28 (i) The entry is by bulk transfer and the importer is not a
29 licensed supplier; or

30 (ii) The entry is not by bulk transfer;

31 (d) Fuel enters this state by means outside the bulk transfer-
32 terminal system and is delivered directly to a licensed terminal
33 unless the owner is a licensed distributor or supplier;

34 (e) Fuel is sold or removed in this state to an unlicensed entity
35 unless there was a prior taxable removal, entry, or sale of the fuel;

36 (f) Blended fuel is removed or sold in this state by the blender
37 of the fuel. The number of gallons of blended fuel subject to tax is
38 the difference between the total number of gallons of blended fuel
39 removed or sold and the number of gallons of previously taxed fuel
40 used to produce the blended fuel;

1 (g) Dyed special fuel is used on a highway, as authorized by the
2 internal revenue code, unless the use is exempt from the fuel tax;

3 (h) Dyed special fuel is held for sale, sold, used, or is
4 intended to be used in violation of this chapter;

5 (i) Special fuel purchased by an international fuel tax agreement
6 licensee under RCW 82.38.320 is used on a highway; and

7 (j) Fuel is sold by a licensed fuel supplier to a fuel
8 distributor or fuel blender and the fuel is not removed from the bulk
9 transfer-terminal system.

10 (10) Taxes are not imposed under subsection (9) of this section
11 when the fuel is a biofuel and the removal is for export.

12 **Sec. 204.** RCW 82.38.035 and 2013 c 225 s 105 are each amended to
13 read as follows:

14 (1) A licensed supplier is liable for and must pay tax on fuel as
15 provided in RCW 82.38.030(~~((7))~~) (9) (a) and (i). On a two-party
16 exchange, or buy-sell agreement between two licensed suppliers, the
17 receiving exchange partner or buyer shall be liable for and pay the
18 tax.

19 (2) A refiner is liable for and must pay tax on fuel removed from
20 a refinery as provided in RCW 82.38.030(~~((7))~~) (9) (b).

21 (3) A licensed distributor is liable for and must pay tax on fuel
22 as provided in RCW 82.38.030(~~((7))~~) (9) (c).

23 (4) A licensed blender is liable for and must pay tax on fuel as
24 provided in RCW 82.38.030(~~((7))~~) (9) (f).

25 (5) A licensed dyed special fuel user is liable for and must pay
26 tax on fuel as provided in RCW 82.38.030(~~((7))~~) (9) (g).

27 (6) A terminal operator is jointly and severally liable for and
28 must pay tax on fuel if, at the time of removal:

29 (a) The position holder of the fuel is a person other than the
30 terminal operator and is not a licensee;

31 (b) The terminal operator is not a licensee;

32 (c) The position holder has an expired internal revenue
33 notification certificate;

34 (d) The terminal operator has reason to believe that information
35 on the internal revenue notification certificate is false.

36 (7) A terminal operator is jointly and severally liable for and
37 must pay tax on special fuel if the special fuel is removed and is
38 not dyed or marked in accordance with internal revenue service
39 requirements, and the terminal operator provides a person with a bill

4 (ii) Nothing in this section prevents a court from providing a
5 copy of the driver's abstract to the individual named in the abstract
6 or that named individual's attorney, provided that the named
7 individual has a pending or open infraction or criminal case in that
8 court. A pending case includes criminal cases that have not reached a
9 disposition by plea, stipulation, trial, or amended charge. An open
10 infraction or criminal case includes cases on probation, payment
11 agreement or subject to, or in collections. Courts may charge a
12 reasonable fee for the production and copying of the abstract for the
13 individual.

14 (b) **Employers or prospective employers.** (i) An abstract of the
15 full driving record maintained by the department may be furnished to
16 an employer or prospective employer or agents acting on behalf of an
17 employer or prospective employer of the named individual for purposes
18 related to driving by the individual as a condition of employment or
19 otherwise at the direction of the employer.

20 (ii) The department may provide employers or their agents a
21 three-year insurance carrier driving record of existing employees
22 only for the purposes of sharing the driving record with its
23 insurance carrier for underwriting. Employers may not provide the
24 employees' full driving records to its insurance carrier.

25 (iii) An abstract of the full driving record maintained by the
26 department may be furnished to an employer or prospective employer or
27 the agent(s) acting on behalf of an employer or prospective employer
28 of the named individual for purposes unrelated to driving by the
29 individual when a driving record is required by federal or state law,
30 or the employee or prospective employee will be handling heavy
31 equipment or machinery.

32 (iv) Release of an abstract of the driving record of an employee
33 or prospective employee requires a statement signed by: (A) The
34 employee or prospective employee that authorizes the release of the
35 record; and (B) the employer attesting that the information is
36 necessary for employment purposes related to driving by the
37 individual as a condition of employment or otherwise at the direction
38 of the employer. If the employer or prospective employer authorizes
39 agents to obtain this information on their behalf, this must be noted
40 in the statement. The statement must also note that any information

1 contained in the abstract related to an adjudication that is subject
2 to a court order sealing the juvenile record of an employee or
3 prospective employee may not be used by the employer or prospective
4 employer, or an agent authorized to obtain this information on their
5 behalf, unless required by federal regulation or law. The employer or
6 prospective employer must afford the employee or prospective employee
7 an opportunity to demonstrate that an adjudication contained in the
8 abstract is subject to a court order sealing the juvenile record.

9 (v) Upon request of the person named in the abstract provided
10 under this subsection, and upon that same person furnishing copies of
11 court records ruling that the person was not at fault in a motor
12 vehicle accident, the department must indicate on any abstract
13 provided under this subsection that the person was not at fault in
14 the motor vehicle accident.

15 (vi) No employer or prospective employer, nor any agents of an
16 employer or prospective employer, may use information contained in
17 the abstract related to an adjudication that is subject to a court
18 order sealing the juvenile record of an employee or prospective
19 employee for any purpose unless required by federal regulation or
20 law. The employee or prospective employee must furnish a copy of the
21 court order sealing the juvenile record to the employer or
22 prospective employer, or the agents of the employer or prospective
23 employer, as may be required to ensure the application of this
24 subsection.

25 (c) **Volunteer organizations.** (i) An abstract of the full driving
26 record maintained by the department may be furnished to a volunteer
27 organization or an agent for a volunteer organization for which the
28 named individual has submitted an application for a position that
29 would require driving by the individual at the direction of the
30 volunteer organization.

31 (ii) Release of an abstract of the driving record of a
32 prospective volunteer requires a statement signed by: (A) The
33 prospective volunteer that authorizes the release of the record; and
34 (B) the volunteer organization attesting that the information is
35 necessary for purposes related to driving by the individual at the
36 direction of the volunteer organization. If the volunteer
37 organization authorizes an agent to obtain this information on their
38 behalf, this must be noted in the statement.

39 (d) **Transit authorities.** An abstract of the full driving record
40 maintained by the department may be furnished to an employee or

1 agents of a transit authority checking prospective or existing
2 volunteer vanpool drivers for insurance and risk management needs.

3 (e) **Insurance carriers.** (i) An abstract of the driving record
4 maintained by the department covering the period of not more than the
5 last three years may be furnished to an insurance company or its
6 agents:

7 (A) That has motor vehicle or life insurance in effect covering
8 the named individual;

9 (B) To which the named individual has applied; or

10 (C) That has insurance in effect covering the employer or a
11 prospective employer of the named individual.

12 (ii) The abstract provided to the insurance company must:

13 (A) Not contain any information related to actions committed by
14 law enforcement officers or firefighters, as both terms are defined
15 in RCW 41.26.030, or by Washington state patrol officers, while
16 driving official vehicles in the performance of their occupational
17 duty, or by registered tow truck operators as defined in RCW
18 46.55.010 in the performance of their occupational duties while at
19 the scene of a roadside impound or recovery so long as they are not
20 issued a citation. This does not apply to any situation where the
21 vehicle was used in the commission of a misdemeanor or felony;

22 (B) Include convictions under RCW 46.61.5249 and 46.61.525,
23 except that the abstract must report the convictions only as
24 negligent driving without reference to whether they are for first or
25 second degree negligent driving; and

26 (C) Exclude any deferred prosecution under RCW 10.05.060, except
27 that if a person is removed from a deferred prosecution under RCW
28 10.05.090, the abstract must show the deferred prosecution as well as
29 the removal.

30 (iii) Any policy of insurance may not be canceled, nonrenewed,
31 denied, or have the rate increased on the basis of information
32 regarding an accident included in the abstract of a driving record,
33 unless the policyholder was determined to be at fault.

34 (iv) Any insurance company or its agents, for underwriting
35 purposes relating to the operation of commercial motor vehicles, may
36 not use any information contained in the abstract relative to any
37 person's operation of motor vehicles while not engaged in such
38 employment. Any insurance company or its agents, for underwriting
39 purposes relating to the operation of noncommercial motor vehicles,
40 may not use any information contained in the abstract relative to any

1 person's operation of commercial motor vehicles. For the purposes of
2 this subsection, "commercial motor vehicle" has the same meaning as
3 in RCW 46.25.010(6).

4 (f) **Alcohol/drug assessment or treatment agencies.** An abstract of
5 the driving record maintained by the department covering the period
6 of not more than the last five years may be furnished to an alcohol/
7 drug assessment or treatment agency approved by the department of
8 health to which the named individual has applied or been assigned for
9 evaluation or treatment, for purposes of assisting employees in
10 making a determination as to what level of treatment, if any, is
11 appropriate, except that the abstract must:

12 (i) Also include records of alcohol-related offenses, as defined
13 in RCW 46.01.260(2), covering a period of not more than the last ten
14 years; and

15 (ii) Indicate whether an alcohol-related offense was originally
16 charged as a violation of either RCW 46.61.502 or 46.61.504.

17 (g) **Attorneys—City attorneys, county prosecuting attorneys, and**
18 **named individual's attorney of record.** An abstract of the full
19 driving record maintained by the department, including whether a
20 recorded violation is an alcohol-related offense, as defined in RCW
21 46.01.260(2), that was originally charged as a violation of either
22 RCW 46.61.502 or 46.61.504, may be furnished to city attorneys,
23 county prosecuting attorneys, or the named individual's attorney of
24 record. City attorneys, county prosecuting attorneys, or the named
25 individual's attorney of record may provide the driving record to
26 alcohol/drug assessment or treatment agencies approved by the
27 department of social and health services to which the named
28 individual has applied or been assigned for evaluation or treatment.

29 (h) **State colleges, universities, or agencies, or units of local**
30 **government.** An abstract of the full driving record maintained by the
31 department may be furnished to (i) state colleges, universities, or
32 agencies for employment and risk management purposes or (ii) units of
33 local government authorized to self-insure under RCW 48.62.031, or
34 their agents, for employment and risk management purposes. "Unit of
35 local government" includes an insurance pool established under RCW
36 48.62.031.

37 (i) **Superintendent of public instruction.** (i) An abstract of the
38 full driving record maintained by the department may be furnished to
39 the superintendent of public instruction for review of public school
40 bus driver records. The superintendent or superintendent's designee

1 may discuss information on the driving record with an authorized
2 representative of the employing school district for employment and
3 risk management purposes.

4 (ii) The superintendent of public instruction is exempt from
5 paying the fees related to the reviewing of records and the fee
6 required in subsection (5) of this section.

7 (j) **State and federal agencies.** An abstract of the driving record
8 maintained by the department may be furnished to state and federal
9 agencies, or their agents, in carrying out its functions.

10 (k) **Transportation network companies.** An abstract of the full
11 driving record maintained by the department may be furnished to a
12 transportation network company or its agents acting on its behalf of
13 the named individual for purposes related to driving by the
14 individual as a condition of being a contracted driver.

15 (l) **Research.** (i) The department may furnish driving record data
16 to state agencies and bona fide scientific research organizations.
17 The department may require review and approval by an institutional
18 review board. For the purposes of this subsection, "research" means a
19 planned and systematic sociological, psychological, epidemiological,
20 biomedical, or other scientific investigation carried out by a state
21 agency, or by a scientific research professional associated with a
22 bona fide scientific research organization with an objective to
23 contribute to scientific knowledge, the solution of social and health
24 problems, or the evaluation of public benefit and service programs.
25 This definition excludes methods of record analysis and data
26 collection that are subjective, do not permit replication, and are
27 not designed to yield reliable and valid results.

28 (ii) The state agency, or a scientific research professional
29 associated with a bona fide scientific research organization, are
30 exempt from paying the fees related to the reviewing of records and
31 the fee required in subsection (5) of this section. However, the
32 department may charge a cost-recovery fee for the actual cost of

34 (3) **Reviewing of driving records.** (a) In addition to the methods
35 described herein, the director may enter into a contractual agreement
36 for the purpose of reviewing the driving records of existing
37 employees for changes to the record during specified periods of time.
38 The department shall establish a fee for this service, which must be
39 deposited in the highway safety fund. The fee for this service must
40 be set at a level that does not result in a net revenue loss to the

1 state. Any information provided under this subsection must be treated
2 in the same manner and is subject to the same restrictions as driving

6 (i) Employers for existing employees, or their agents;

11 (iv) State colleges, universities, or agencies, or units of local
12 government, or their agents;

13 (v) The office of the superintendent of public instruction for
14 school bus drivers statewide; and

15 (vi) Transportation network companies, or their agents.

16 (4) **Release to third parties prohibited.** (a) Any person or entity
17 receiving an abstract of a person's driving record under subsection
18 (2)(b) through (l) of this section shall use the abstract exclusively
19 for his, her, or its own purposes or as otherwise expressly permitted
20 under this section, and shall not divulge any information contained
21 in the abstract to a third party.

22 (b) The following release of records to third parties are hereby
23 authorized:

24 (i) Employers may divulge driving records to regulatory bodies,
25 as defined by the department by rule, such as the United States
26 department of transportation and the federal motor carrier safety
27 administration.

28 (ii) Employers may divulge a three-year driving record to their
29 insurance carrier for underwriting purposes.

30 (iii) Employers may divulge driving records to contracted motor
31 carrier consultants for the purposes of ensuring driver compliance
32 and risk management.

33 (5) (~~Fee~~) **Fees.** (a) The director shall collect a (~~thirteen~~
34 ~~dollar~~) \$15 fee for each abstract of a person's driving record
35 furnished by the department. After depositing \$2 of the driver's
36 abstract fee in the move ahead WA flexible account created in section
37 402 of this act, the remainder shall be distributed as follows:

38 (i) Fifty percent (~~of the fee~~) must be deposited in the highway
39 safety fund(~~(7)~~); and (~~fifty~~)

1 (ii) Fifty percent ((of the fee)) must be deposited according to
2 RCW 46.68.038.

3 (b) Beginning July 1, 2029, the director shall collect an
4 additional \$2 fee for each abstract of a person's driving record
5 furnished by the department. The \$2 additional driver's abstract fee
6 must be deposited in the move ahead WA flexible account created in
7 section 402 of this act.

8 (c) City attorneys and county prosecuting attorneys are exempt
9 from paying the fees specified in (a) and (b) of this subsection for
10 an abstract of a person's driving record furnished by the department
11 for use in criminal proceedings.

12 (6) **Violation.** (a) Any negligent violation of this section is a
13 gross misdemeanor.

14 (b) Any intentional violation of this section is a class C
15 felony.

16 (7) Effective July 1, 2019, the contents of a driving abstract
17 pursuant to this section shall not include any information related to
18 sealed juvenile records unless that information is required by
19 federal law or regulation.

19 (e) That a vehicle will be sold upon a monthly payment of a
20 certain amount, without including in the statement the number of
21 payments of that same amount which are required to liquidate the
22 unpaid purchase price.

23 (2) (a) (i) To incorporate within the terms of any purchase and
24 sale or lease agreement any statement or representation with regard
25 to the sale, lease, or financing of a vehicle which is false,
26 deceptive, or misleading, including but not limited to terms that
27 include as an added cost to the selling price or capitalized cost of
28 a vehicle an amount for licensing or transfer of title of that
29 vehicle which is not actually due to the state, unless such amount
30 has in fact been paid by the dealer prior to such sale.

7 that the documentary service fee is a negotiable fee. The disclosure

12 conspicuous. The dealer shall not represent to the purchaser or

11 the return of the subject vehicle and any physical damage, excessive
12 mileage after the demand for return of the vehicle, and attorneys'
13 fees authorized by law, and tenders the refund of any initial payment
14 or security made or given by the buyer or lessee, including, but not
15 limited to, any down payment, and tenders return of the trade-in
16 vehicle, key, other trade-in, or certificate of title to a trade-in.
17 Tender may be conditioned on return of the subject vehicle if
18 previously delivered to the buyer or lessee.

19 The provisions of this subsection (4)(a) do not impair,
20 prejudice, or abrogate the rights of a dealer to assert a claim
21 against the buyer or lessee for misrepresentation or breach of
22 contract and to exercise all remedies available at law or in equity,
23 including those under chapter 62A.9A RCW, if the dealer, bank, or
24 other lender or leasing company discovers that approval of the
25 contract or financing or approval of the lease was based upon
26 material misrepresentations made by the buyer or lessee, including,
27 but not limited to, misrepresentations regarding income, employment,

29 staff, has not, with knowledge of the material misrepresentation,

2 by the buyer or lessee, by in-person oral communication, by mailing a
3 letter by first-class mail if the buyer or lessee expresses a

30 statement and the actual mileage on the vehicle; or

31 (c) Fails to comply with the obligation of any written warranty
32 or guarantee given by the dealer requiring the furnishing of services

10 (a) The lienholder fails to deliver the vehicle title to the
11 dealer within the required time period;

6 unit including but not limited to the undercarriage, and all items
7 specified in the terms of a sales or lease agreement signed by the
8 seller and buyer or lessee.

9 (11) For a vehicle dealer to pay to or receive from any person,
10 firm, partnership, association, or corporation acting, either
11 directly or through a subsidiary, as a buyer's agent for consumers,
12 any compensation, fee, purchase moneys or funds that have been
13 deposited into or withdrawn out of any account controlled or used by
14 any buyer's agent, gratuity, or reward in connection with the
15 purchase, sale, or lease of a new motor vehicle.

16 (12) For a buyer's agent, acting directly or through a
17 subsidiary, to pay to or to receive from any motor vehicle dealer any
18 compensation, fee, gratuity, or reward in connection with the
19 purchase, sale, or lease of a new motor vehicle. In addition, it is
20 unlawful for any buyer's agent to engage in any of the following acts
21 on behalf of or in the name of the consumer:

22 (a) Receiving or paying any purchase moneys or funds into or out
23 of any account controlled or used by any buyer's agent;

24 (b) Signing any vehicle purchase orders, sales contracts, leases,
25 odometer statements, or title documents, or having the name of the
26 buyer's agent appear on the vehicle purchase order, sales contract,
27 lease, or title; or

28 (c) Signing any other documentation relating to the purchase,
29 sale, lease, or transfer of any new motor vehicle.

30 It is unlawful for a buyer's agent to use a power of attorney
31 obtained from the consumer to accomplish or effect the purchase,

18 (6) Beginning with the program year beginning in calendar year
19 2028, the department may not increase the carbon intensity reductions
20 required by the applicable clean fuels program standard adopted by
21 the department under subsection (5) of this section beyond a 10
22 percent reduction in carbon intensity until the department
23 demonstrates that the following have occurred:

24 (a) At least a 15 percent net increase in the volume of in-state
25 liquid biofuel production and the use of feedstocks grown or produced
26 within the state relative to the start of the program; and

27 (b) At least one new or expanded biofuel production facility
28 representing an increase in production capacity or producing, in
29 total, in excess of 60,000,000 gallons of biofuels per year has or
30 have received after July 1, 2021, all necessary siting, operating,
31 and environmental permits post all timely and applicable appeals. As
32 part of the threshold of 60,000,000 gallons of biofuel under this
33 subsection, at least one new facility producing at least 10,000,000
34 gallons per year must have received all necessary siting, operating,
35 and environmental permits. Timely and applicable appeals must be
36 determined by the attorney general's office.

37 (7) Beginning with the program year beginning in calendar year
38 2031, the department may not increase the carbon intensity reductions
39 required by the applicable clean fuels program standard adopted by

1 the department under subsection (5) of this section beyond a 10
2 percent reduction in carbon intensity until the:

3 (a) Joint legislative audit and review committee report required
4 in RCW 70A.535.140 has been completed; and

5 (b) 2033 regular legislative session has adjourned, in order to
6 allow an opportunity for the legislature to amend the requirements of
7 this chapter in light of the report required in (a) of this
8 subsection.

9 (8) Transportation fuels exported from Washington are not subject
10 to the greenhouse gas emissions reduction requirements in this
11 section.

12 (9) To the extent the requirements of this chapter conflict with
13 the requirements of chapter 19.112 RCW, the requirements of this
14 chapter prevail.

1 dispensed for use in Washington, such that one deficit is equal to
2 one metric ton of carbon dioxide equivalents.

3 (7) "Department" means the department of ecology.

4 (8) "Electric utility" means a consumer-owned utility or
5 investor-owned utility, as those terms are defined in RCW 19.29A.010.

6 (9) "Greenhouse gas" has the same meaning as defined in RCW
7 70A.45.010.

8 (10) "Military tactical vehicle" means a motor vehicle owned by
9 the United States department of defense or the United States military
10 services and that is used in combat, combat support, combat service
11 support, tactical or relief operations, or training for such
12 operations.

13 (11) "Motor vehicle" has the same meaning as defined in RCW
14 46.04.320.

15 (12) "Price" means the amount of payment or compensation provided
16 as consideration for a specified quantity of transportation fuel by a
17 consumer or end user of the transportation fuel.

18 (13) "Regulated party" means a producer or importer of any amount
19 of a transportation fuel that is ineligible to generate credits under
20 this chapter.

21 (14)(a) "Tactical support equipment" means equipment using a
22 portable engine, including turbines, that meets military
23 specifications, owned by the United States military services or its
24 allies, and that is used in combat, combat support, combat service
25 support, tactical or relief operations, or training for such
26 operations.

27 (b) "Tactical support equipment" includes, but is not limited to,
28 engines associated with portable generators, aircraft start carts,
29 heaters, and lighting carts.

30 (15) "Transportation fuel" means electricity and any liquid or
31 gaseous fuel sold, supplied, offered for sale, or used for the
32 propulsion of a motor vehicle or that is intended for use for
33 transportation purposes.

36 The rules adopted by the department to achieve the greenhouse gas
37 emissions reductions per unit of fuel energy specified in ((RCW
38 70A.535.020)) section 408 of this act must include, but are not

1 (1) Standards for greenhouse gas emissions attributable to the
2 transportation fuels throughout their life cycles, including but not
3 limited to emissions from the production, storage, transportation,

18 (8)(a)(i) A credit clearance market for any compliance period in
19 which at least one regulated party reports that the regulated party
20 has a net deficit balance at the end of the compliance period, after
21 retirement of all credits held by the regulated party, that is
22 greater than a small deficit. A regulated party described by this
23 subsection is required to participate in the credit clearance market.

24 (ii) If a regulated party has a small deficit at the end of a
25 compliance period, the regulated party shall notify the department

37 (1) The rules adopted under RCW (~~70A.535.020 and~~) 70A.535.030
38 and section 408 of this act may allow the generation of credits from
39 activities that support the reduction of greenhouse gas emissions

1 associated with transportation in Washington, including but not
2 limited to:

3 (a) Carbon capture and sequestration projects, including but not
4 limited to:

5 (i) Innovative crude oil production projects that include carbon
6 capture and sequestration;

7 (ii) Project-based refinery greenhouse gas mitigation including,
8 but not limited to, process improvements, renewable hydrogen use, and
9 carbon capture and sequestration; or

10 (iii) Direct air capture projects;

11 (b) Investments and activities that support deployment of
12 machinery and equipment used to produce gaseous and liquid fuels from
13 nonfossil feedstocks, and derivatives thereof;

14 (c) The fueling of battery or fuel cell electric vehicles by a
15 commercial, nonprofit, or public entity that is not an electric
16 utility, which may include, but is not limited to, the fueling of
17 vehicles using electricity certified by the department to have a
18 carbon intensity of zero; and

19 (d) The use of smart vehicle charging technology that results in
20 the fueling of an electric vehicle during times when the carbon
21 intensity of grid electricity is comparatively low.

22 (2) (a) The rules adopted under RCW (~~(70A.535.020 and)~~)

24 credits based on capacity for zero emission vehicle refueling
25 infrastructure, including DC fast charging infrastructure and
26 hydrogen refueling infrastructure.

1 (2) If the director of the department makes the determination

7 period the director of the department determines necessary to permit

3 department may renew issued deferrals. In evaluating whether to issue
4 a deferral under this subsection, the department may consider the
5 results of the fuel supply forecast in RCW 70A.535.100, but is not
6 bound in its decision-making discretion by the results of the
7 forecast.

8 (b) If the department issues a deferral pursuant to this
9 subsection, the department may:

10 (i) Direct the person subject to the deferral to file a progress
11 report on achieving full compliance with the requirements of this
12 chapter within an amount of time determined to be reasonable by the
13 department; and

14 (ii) Direct the person to take specific actions to achieve full
15 compliance with the requirements of this chapter.

16 (c) The issuance of a deferral under this subsection does not
17 permanently relieve the deferral recipient of the obligation to
18 comply with the requirements of this chapter.

19 NEW SECTION. **Sec. 414.** RCW 70A.535.020 (Carbon intensity of
20 transportation fuels—Standards to reduce carbon intensity—Adoption
21 of rules) and 2021 c 317 s 3 are each repealed.

22 NEW SECTION. **Sec. 415.** (1) A target is established for the
23 state that all publicly owned and privately owned passenger and light
24 duty vehicles of model year 2030 or later that are sold, purchased,
25 or registered in Washington state be electric vehicles.

26 (2) On or before December 31, 2023, the interagency electric
27 vehicle coordinating council created in section 428 of this act shall
28 complete a scoping plan for achieving the 2030 target.

29 NEW SECTION. **Sec. 416.** A new section is added to chapter 47.66
30 RCW to read as follows:

31 (1) The department shall establish a bus and bus facilities grant
32 program. The purpose of this competitive grant program is to provide
33 grants to any transit authority for the replacement, expansion,
34 rehabilitation, and purchase of transit rolling stock; construction,
35 modification, or rehabilitation of transit facilities; and funding to
36 adapt to technological change or innovation through the retrofitting
37 of transit rolling stock and facilities.

1 (2) (a) The department must incorporate environmental justice
2 principles into the grant selection process, with the goal of
3 increasing the distribution of funding to communities based on
4 addressing environmental harms and provide environmental benefits for
5 overburdened communities, as defined in RCW 70A.02.010, and
6 vulnerable populations.

7 (b) The department must incorporate geographic diversity into the
8 grant selection process.

9 (c) No grantee may receive more than 35 percent of the amount
10 appropriated for the grant program in a particular biennium.

11 (d) Fuel type may not be a factor in the grant selection process.

12 (3) The department must establish an advisory committee to carry
13 out the mandates of this section, including assisting with the
14 establishment of grant criteria.

15 (4) The department must report annually to the transportation
16 committees of the legislature on the status of any grant projects
17 funded by the program created under this section.

18 (5) For the purposes of this section:

19 (a) "Transit authority" means a city transit system under RCW
20 35.58.2721 or chapter 35.95A RCW, a county public transportation
21 authority under chapter 36.57 RCW, a metropolitan municipal
22 corporation transit system under chapter 36.56 RCW, a public
23 transportation benefit area under chapter 36.57A RCW, an
24 unincorporated transportation benefit area under RCW 36.57.100, or
25 any special purpose district formed to operate a public
26 transportation system.

27 (b) "Transit rolling stock" means transit vehicles including, but
28 not limited to, buses, ferries, and vans.

29 NEW SECTION. **Sec. 417.** A new section is added to chapter 47.04
30 RCW to read as follows:

31 (1) The legislature finds that many communities across Washington
32 state have not equitably benefited from investments in the active
33 transportation network. The legislature also finds that legacy state
34 transportation facilities designed primarily for vehicle use caused
35 disconnections in safe routes for people who walk, bike, and roll to
36 work and to carry out other daily activities.

37 (2) To address these investment gaps, the connecting communities
38 program is established within the department. The purpose of the

1 program is to improve active transportation connectivity in
2 communities by:

3 (a) Providing safe, continuous routes for pedestrians,
4 bicyclists, and other nonvehicle users carrying out their daily

6 (b) Mitigating for the health, safety, and access impacts of
7 transportation infrastructure that bisects communities and creates
8 obstacles in the local active transportation network;

11 (d) Facilitating the planning, development, and implementation of
12 projects and activities that will improve the connectivity and safety
13 of the active transportation network.

14 (3) The department must select projects to propose to the
15 legislature for funding. In selecting projects, the department must
16 consider, at a minimum, the following criteria:

17 (a) Access to a transit facility, community facility, commercial
18 center, or community-identified assets;

19 (b) The use of minority and women-owned businesses and community-
20 based organizations in planning, community engagement, design, and
21 construction of the project;

22 (c) Whether the project will serve:

23 (i) Overburdened communities as defined in RCW 70A.02.010 to mean
24 a geographic area where vulnerable populations face combined,
25 multiple environmental harms and health impacts, and includes, but is
26 not limited to, highly impacted communities as defined in RCW
27 19.405.020;

28 (ii) Vulnerable populations as defined in RCW 70A.02.010 to mean
29 population groups that are more likely to be at higher risk for poor
30 health outcomes in response to environmental harms, due to adverse
31 socioeconomic factors, such as unemployment, high housing, and
32 transportation costs relative to income, limited access to nutritious
33 food and adequate health care, linguistic isolation, and other
34 factors that negatively affect health outcomes and increase
35 vulnerability to the effects of environmental harms; and sensitivity
36 factors, such as low birth weight and higher rates of
37 hospitalization. Vulnerable populations include, but are not limited
38 to: Racial or ethnic minorities, low-income populations, populations
39 disproportionately impacted by environmental harms, and populations
40 of workers experiencing environmental harms;

1 (iii) Household incomes at or below 200 percent of the federal
2 poverty level; and

3 (iv) People with disabilities;

4 (d) Environmental health disparities, such as those indicated by
5 the diesel pollution burden portion of the Washington environmental
6 health disparities map developed by the department of health, or
7 other similar indicators;

8 (e) Location on or adjacent to tribal lands or locations
9 providing essential services to tribal members;

10 (f) Crash experience involving pedestrians and bicyclists; and

11 (g) Identified need by the community, for example in the state
12 active transportation plan or a regional, county, or community plan.

13 (4) It is the intent of the legislature that the connecting
14 communities program comply with the requirements of chapter 314, Laws
15 of 2021.

16 (5) The department shall submit a report to the transportation
17 committees of the legislature by December 1, 2022, and each December
18 1st thereafter identifying the selected connecting communities
19 projects for funding by the legislature. The report must also include
20 the status of previously funded projects.

21 (6) This section expires July 1, 2027.

22 NEW SECTION. **Sec. 418.** A new section is added to chapter 47.24
23 RCW to read as follows:

24 (1) In order to improve the safety, mobility, and accessibility
25 of state highways, it is the intent of the legislature that the
26 department must incorporate the principles of complete streets with
27 facilities that provide street access with all users in mind,
28 including pedestrians, bicyclists, and public transportation users,
29 notwithstanding the provisions of RCW 47.24.020 concerning
30 responsibility beyond the curb of state rights-of-way. As such, state
31 transportation projects starting design on or after July 1, 2022, and
32 that are \$500,000 or more, must:

33 (a) Identify those locations on state rights-of-way that do not
34 have a complete and Americans with disabilities act accessible
35 sidewalk or shared-use path, that do not have bicycle facilities in
36 the form of a bike lane or adjacent parallel trail or shared-use
37 path, that have such facilities on a state route within a population
38 center that has a posted speed in excess of 30 miles per hour and no
39 buffer or physical separation from vehicular traffic for pedestrians

1 and bicyclists, and/or that have a design that hampers the ability of
2 motorists to see a crossing pedestrian with sufficient time to stop
3 given posted speed limits and roadway configuration;

4 (b) Consult with local jurisdictions to confirm existing and
5 planned active transportation connections along or across the
6 location; identification of connections to existing and planned
7 public transportation services, ferry landings, commuter and
8 passenger rail, and airports; the existing and planned facility
9 type(s) within the local jurisdiction that connect to the location;
10 and the potential use of speed management techniques to minimize
11 crash exposure and severity;

12 (c) Adjust the speed limit to a lower speed with appropriate
13 modifications to roadway design and operations to achieve the desired
14 operating speed in those locations where this speed management
15 approach aligns with local plans or ordinances, particularly in those
16 contexts that present a higher possibility of serious injury or fatal
17 crashes occurring based on land use context, observed crash data,
18 crash potential, roadway characteristics that are likely to increase
19 exposure, or a combination thereof, in keeping with a safe system
20 approach and with the intention of ultimately eliminating serious and
21 fatal crashes; and

22 (d) Plan, design, and construct facilities providing context-
23 sensitive solutions that contribute to network connectivity and
24 safety for pedestrians, bicyclists, and people accessing public
25 transportation and other modal connections, such facilities to
26 include Americans with disabilities act accessible sidewalks or
27 shared-use paths, bicyclist facilities, and crossings as needed to
28 integrate the state route into the local network.

29 (2) Projects undertaken for emergent work required to reopen a
30 state highway in the event of a natural disaster or other emergency
31 repair are not required to comply with the provisions of this
32 section.

33 (3) Maintenance of facilities constructed under this provision
34 shall be as provided under existing law.

35 (4) This section does not create a private right of action.

36 NEW SECTION. **Sec. 419.** A new section is added to chapter 47.04
37 RCW to read as follows:

38 (1) The department shall establish a statewide school-based
39 bicycle education grant program. The grant will support two programs:

1 One for elementary and middle school; and one for junior high and
2 high school aged youth to develop the skills and street safety
3 knowledge to be more confident bicyclists for transportation and/or
4 recreation. In development of the grant program, the department is
5 encouraged to consult with the environmental justice council and the
6 office of equity.

7 (2) (a) For the elementary and middle school program, the
8 department shall contract with a nonprofit organization with relevant
9 reach and experience, including a statewide footprint and
10 demonstrable experience deploying bicycling and road safety education
11 curriculum via a train the trainer model in schools. The selected
12 nonprofit shall identify partner schools that serve target
13 populations, based on the criteria in subsection (3) of this section.
14 Partner schools shall receive from the nonprofit: In-school bike and
15 pedestrian safety education curriculum, materials, equipment guidance
16 and consultation, and physical education teacher trainings. Youth
17 grades three through eight are eligible for the program.

18 (b) Selected school districts shall receive and maintain a fleet
19 of bicycles for the youth in the program. Youth and families
20 participating in the school-base bicycle education grant program
21 shall have an opportunity to receive a bike, lock, helmet, and lights
22 free of cost.

23 (3) For the junior high and high school program, the department
24 shall contract with a nonprofit organization with relevant reach and
25 experience, including a statewide footprint; demonstrable experience
26 developing and managing youth-based programming serving youth of
27 color in an after-school and/or community setting; and deploying
28 bicycling and road safety education curriculum via a train the
29 trainer model. The selected nonprofit shall use the equity-based
30 criteria in subsection (4) of this section to identify target
31 populations and partner organizations including, but not limited to,
32 schools, community-based organizations, housing authorities, and
33 parks and recreation departments, that work with the eligible
34 populations of youth ages 14 to 18. Partner organizations shall
35 receive from the nonprofit: Education curriculum, materials,
36 equipment guidance and consultation, and initial instructor/volunteer
37 training, as well as ongoing support.

38 (4) In selecting schools and partner organizations for the
39 school-based bicycle education grant program, the department and
40 nonprofit must consider, at a minimum, the following criteria:

- 1 (a) Population impacted by poverty, as measured by free and
2 reduced lunch population or 200 percent federal poverty level;
3 (b) People of color;
4 (c) People of Hispanic heritage;
5 (d) People with disabilities;
6 (e) Environmental health disparities, such as those indicated by
7 the diesel pollution burden portion of the Washington environmental
8 health disparities map developed by the department of health, or
9 other similar indicators;
10 (f) Location on or adjacent to an Indian reservation;
11 (g) Geographic location throughout the state;
12 (h) Crash experience involving pedestrians and bicyclists;
13 (i) Access to a community facility or commercial center; and
14 (j) Identified need in the state active transportation plan or a
15 regional, county, or community plan.

16 (5) The department shall submit a report for both programs to the
17 transportation committees of the legislature by December 1, 2022, and
18 each December 1st thereafter identifying the selected programs and
19 school districts for funding by the legislature. The report must also
20 include the status of previously funded programs.

21 NEW SECTION. **Sec. 420.** A new section is added to chapter 47.04
22 RCW to read as follows:

23 For the purposes of submitting a request by October 1, 2022, to
24 Amtrak to adopt a fare policy change, the department shall negotiate
25 with the Oregon department of transportation to determine ridership,
26 revenue, and policy impacts relating to elimination of fares for
27 Amtrak Cascades passengers 18 years of age and younger. It is the
28 intent of the legislature that fares for passengers 18 years of age
29 and younger for service on the Amtrak Cascades corridor be
30 eliminated. The department shall report back to the transportation
31 committees of the legislature with results of negotiations with the
32 Oregon department of transportation and the status of fare policy
33 requests submitted to Amtrak by December 1, 2022.

34 NEW SECTION. **Sec. 421.** A new section is added to chapter 47.60
35 RCW to read as follows:

36 Consistent with RCW 47.60.315(1)(b), the commission shall adopt
37 an annual fare policy for Washington state ferries to allow all
38 riders 18 years of age and younger to ride free of charge on all

1 system routes. This fare change must apply to both walk-on passengers
2 and passengers in vehicles. The commission is directed to make the
3 initial fare policy change effective no later than October 1, 2022.

4 NEW SECTION. **Sec. 422.** A new section is added to chapter 47.66
5 RCW to read as follows:

6 (1) The department shall establish a transit support grant
7 program for the purpose of providing financial support to transit
8 agencies for operating and capital expenses only. Public transit
9 agencies must maintain or increase their local sales tax authority on
10 or after January 1, 2022, in order to qualify for the grants.

11 (a) Grants for transit agencies must be prorated based on the
12 amount expended for operations in the most recently published report
13 of "Summary of Public Transportation" published by the department.

17 (2) To be eligible to receive a grant, the transit agency must
18 have adopted, at a minimum, a zero-fare policy that allows passengers
19 18 years of age and younger to ride free of charge on all modes
20 provided by the agency.

21 (3) The department shall, for the purposes of the "Summary of
22 Public Transportation" report, require grantees to report the number
23 of trips that were taken under this program.

24 (4) For the purposes of this section, "transit agency" or
25 "agency" means a city transit system under RCW 35.58.2721 or chapter
26 35.95A RCW, a county public transportation authority under chapter
27 36.57 RCW, a metropolitan municipal corporation transit system under
28 chapter 36.56 RCW, a public transportation benefit area under chapter
29 36.57A RCW, an unincorporated transportation benefit area under RCW
30 36.57.100, or any special purpose district formed to operate a public
31 transportation system.

32 **Sec. 423.** RCW 46.63.170 and 2020 c 224 s 1 are each amended to
33 read as follows:

34 (1) The use of automated traffic safety cameras for issuance of
35 notices of infraction is subject to the following requirements:

36 (a) Except for proposed locations used solely for the pilot
37 program purposes permitted under subsection (6) of this section, the
38 appropriate local legislative authority must prepare an analysis of

1 the locations within the jurisdiction where automated traffic safety
2 cameras are proposed to be located: (i) Before enacting an ordinance
3 allowing for the initial use of automated traffic safety cameras; and
4 (ii) before adding additional cameras or relocating any existing
5 camera to a new location within the jurisdiction. Automated traffic
6 safety cameras may be used to detect one or more of the following:
7 Stoplight, railroad crossing, ~~((+))~~ school speed zone
8 violations~~((+))~~, speed violations on any roadway identified in a
9 school walk area as defined in RCW 28A.160.160, speed violations in
10 public park speed zones, hospital speed zones, speed violations

12 in subsection (6) of this section for the duration of the pilot
13 program authorized under subsection (6) of this section. At a
14 minimum, the local ordinance must contain the restrictions described

3 (B) "Hospital speed zone" means the marked area within hospital
4 property and extending 300 feet from the border of hospital property
5 (I) consistent with hospital use; and (II) where signs are posted to
6 indicate the location is within a hospital speed zone, where
7 "hospital" has the same meaning as in RCW 70.41.020.

8 (c) ((Any)) In addition to the automated traffic safety cameras
9 authorized under (d) of this subsection, any city west of the Cascade
10 mountains with a population of more than ((one hundred ninety-five
11 thousand)) 195,000 located in a county with a population of fewer
12 than ((one million five hundred thousand)) 1,500,000 may operate an
13 automated traffic safety camera to detect speed violations subject to

4 (e) All locations where an automated traffic safety camera is
5 used to detect speed violations on roadways identified in a school

8 this subsection must be clearly marked by placing signs in locations
9 that clearly indicate to a driver either: (i) That the driver is
10 within a school walk area, public park speed zone, or hospital speed

22 infraction is occurring. Cities and counties shall consider
23 installing cameras in a manner that minimizes the impact of camera
24 flash on drivers.

25 ~~((e))~~ (g) A notice of infraction must be mailed to the
26 registered owner of the vehicle within (~~fourteen~~) 14 days of the
27 violation, or to the renter of a vehicle within (~~fourteen~~) 14 days
28 of establishing the renter's name and address under subsection (3)(a)
29 of this section. The law enforcement officer issuing the notice of
30 infraction shall include with it a certificate or facsimile thereof,
31 based upon inspection of photographs, microphotographs, or electronic
32 images produced by an automated traffic safety camera, stating the
33 facts supporting the notice of infraction. This certificate or
34 facsimile is prima facie evidence of the facts contained in it and is

6 rental car business, satisfies the conditions under subsection (3) of
7 this section. If appropriate under the circumstances, a renter
8 identified under subsection (3)(a) of this section is responsible for
9 an infraction.

10 ~~((g))~~ (i) Notwithstanding any other provision of law, all
11 photographs, microphotographs, or electronic images, or any other
12 personally identifying data prepared under this section are for the
13 exclusive use of law enforcement in the discharge of duties under
14 this section and are not open to the public and may not be used in a
15 court in a pending action or proceeding unless the action or
16 proceeding relates to a violation under this section. No photograph,
17 microphotograph, or electronic image, or any other personally
18 identifying data may be used for any purpose other than enforcement
19 of violations under this section nor retained longer than necessary
20 to enforce this section.

21 ~~((h))~~ (j) All locations where an automated traffic safety
22 camera is used must be clearly marked at least ~~((thirty))~~ 30 days

19 NEW SECTION. **Sec. 429.** (1) Interagency electric vehicle

20 coordinating council responsibilities include, but are not limited

21 to:

22 (a) Development of a statewide transportation electrification

23 strategy to ensure market and infrastructure readiness for all new

24 vehicle sales;

25 (b) Identification of all electric vehicle infrastructure grant-

26 related funding to include existing and future opportunities,

27 including state, federal, and other funds;

28 (c) Coordination of grant funding criteria across agency grant

29 programs to most efficiently distribute state and federal electric

30 vehicle-related funding in a manner that is most beneficial to the

31 state, advances best practices, and recommends additional criteria

32 that could be useful in advancing transportation electrification;

33 (d) Development of a robust public and private outreach plan that

34 includes engaging with:

35 (i) Community organizers and the environmental justice council to

36 develop community-driven programs to address zero emissions

37 transportation needs and priorities in overburdened communities; and

1 (ii) Local governments to explore procurement opportunities and
2 work with local government and community programs to support
3 electrification;

4 (e) Creation of an industry electric vehicle advisory committee;
5 and

6 (f) Ensuring the statewide transportation electrification
7 strategy, grant distribution, programs, and activities associated
8 with advancing transportation electrification benefit vulnerable and
9 overburdened communities.

10 (2) The council shall provide an annual report to the appropriate
11 committees of the legislature summarizing electric vehicle
12 implementation progress, gaps, and resource needs.

13 **Sec. 430.** RCW 46.68.480 and 2020 c 224 s 2 are each amended to
14 read as follows:

15 The Cooper Jones active transportation safety account is created
16 in the state treasury. All receipts from penalties collected under
17 RCW 46.63.170(~~(+6)(e)~~) shall be deposited into the account.
18 Expenditures from the account may be used only to fund grant projects
19 or programs for bicycle, pedestrian, and nonmotorist safety
20 improvement (~~administered by the Washington traffic safety~~
21 ~~commission~~). The account is subject to allotment procedures under
22 chapter 43.88 RCW. Moneys in the account may be spent only after
23 appropriation.

24 NEW SECTION. **Sec. 431.** A new section is added to chapter 47.60
25 RCW to read as follows:

26 It is the intent of the legislature to fully fund the vessel and
27 terminal electrification program in accordance with the Washington
28 state ferries 2040 long range plan. The legislature finds that to
29 attain the 2040 target fleet size of 26 vessels, a biennial
30 replacement schedule is necessary to ensure the level of ferry
31 service and reliability expected by the public. Therefore, by June
32 30, 2025, the legislature will secure funding options, including but
33 not limited to a vessel surcharge, to devote the resources necessary
34 to fulfill the vessel and terminal needs outlined in the 2040 long
35 range plan.

36 NEW SECTION. **Sec. 432.** Washington state's target zero program
37 envisions Washington having policies that will lead to zero deaths of

1 people using the transportation system. For almost two decades more
2 than 200 people have lost their lives annually in circumstances where
3 a vehicle unintentionally left its lane of travel. Such fatalities
4 made up 48 percent of all traffic-related fatalities in 2019. There
5 are multiple ways to make improvements on the highway system that
6 have been proven in other locations to help reduce lane departures
7 and fatalities. Sections 433 and 434 of this act are intended to
8 direct resources towards deploying such improvements by requiring the
9 Washington state department of transportation to create a program
10 that is focused on addressing this specific safety concern.

11 NEW SECTION. **Sec. 433.** A new section is added to chapter 47.04
12 RCW to read as follows:

13 (1)(a) When an appropriation is made for this purpose, the
14 department shall establish a reducing rural roadway departures
15 program to provide funding for safety improvements specific to
16 preventing lane departures in areas where the departure is likely to
17 cause serious injuries or death. Funding under this program may be
18 used to:

19 (i) Widen roadway shoulders or modify roadway design to improve
20 visibility or reduce lane departure risks;

21 (ii) Improve markings and paint on roadways, including making
22 markings on roads more visible for vehicles with lane departure
23 technology;

24 (iii) Apply high friction surface treatments;

25 (iv) Install rumble strips, signage, lighting, raised barriers,
26 medians, guardrails, cable barriers, or other safety equipment,
27 including deployment of innovative technology and connected
28 infrastructure devices;

29 (v) Remove or relocate fixed objects from rights-of-way that pose
30 a significant risk of serious injury or death if a vehicle were to
31 collide with the object due to a lane departure;

32 (vi) Repair or replace existing barriers that are damaged or
33 nonfunctional; or

34 (vii) Take other reasonable actions that are deemed likely to
35 address or prevent vehicle lane departures in specific areas of
36 concern.

37 (b) The department must create a program whereby it can
38 distribute funding or install safety improvements listed in (a) of
39 this subsection on state, county, small city, or town roads in rural

1 areas that have a high risk of having or actually have incidents of
2 serious injuries or fatalities due to vehicle lane departures. Any
3 installation of safety measures that are not under the jurisdiction
4 of the department must be done with permission from the entity that
5 is responsible for operation and maintenance of the roadway.

6 (c) The department's program must create a form and application
7 process whereby towns, small cities, counties, and transportation
8 benefit districts may apply for program funding for high risk areas
9 in their jurisdictions in need of safety improvements.

10 (d) Subject to the availability of amounts appropriated for this
11 specific purpose, the department must issue program funding for
12 purposes defined in (a) and (b) of this subsection in a
13 geographically diverse manner throughout the state. Criteria used to
14 assess a location can include the communities inability or lack of
15 resources to make the corrections themselves and to make corrections
16 where there has been historic disparate impacts.

17 (e) By December 31st of each year when there is funding
18 distributed in accordance with this program, the department must
19 provide the transportation committees of the legislature and the
20 traffic safety commission with a list of locations that received
21 funding and a description of the safety improvements installed there.

22 (2) During the first five years of the program, the department
23 must track incidence of lane departures at the locations where the
24 new infrastructure is installed and evaluate the effectiveness of the
25 safety improvements.

26 **Sec. 434.** RCW 46.68.060 and 2021 c 333 s 706 are each amended to
27 read as follows:

28 There is hereby created in the state treasury a fund to be known
29 as the highway safety fund to the credit of which must be deposited
30 all moneys directed by law to be deposited therein. This fund must be
31 used for carrying out the provisions of law relating to driver
32 licensing, driver improvement, financial responsibility, cost of
33 furnishing abstracts of driving records and maintaining such case
34 records, and to carry out the purposes set forth in RCW 43.59.010,
35 ~~((and))~~ chapters 46.72 and 46.72A RCW, and section 433 of this act.
36 During the 2013-2015 and 2015-2017 fiscal biennia, the legislature
37 may transfer from the highway safety fund to the Puget Sound ferry
38 operations account, the motor vehicle fund, and the multimodal
39 transportation account such amounts as reflect the excess fund

1 balance of the highway safety fund. During the 2017-2019, 2019-2021,
2 and 2021-2023 fiscal biennia, the legislature may direct the state
3 treasurer to make transfers of moneys in the highway safety fund to
4 the multimodal transportation account and the state patrol highway
5 account.

8 NEW SECTION. **Sec. 501.** Sections 415 and 427 through 429 of this
9 act constitute a new chapter in Title 43 RCW.

10 NEW SECTION. **Sec. 502.** If any provision of this act or its
11 application to any person or circumstance is held invalid, the
12 remainder of the act or the application of the provision to other
13 persons or circumstances is not affected.

14 NEW SECTION. **Sec. 503.** Sections 310 and 403 of this act expire
15 July 1, 2024.

16 NEW SECTION. **Sec. 504.** Section 404 of this act takes effect
17 July 1, 2024.

18 **Sec. 505.** 2020 c 224 s 3 (uncodified) is amended to read as
19 follows:

20 Section 1 of this act expires June 30, (~~2023~~) 2025.

21 NEW SECTION. **Sec. 506.** Section 423 of this act expires June 30,
22 2025.

23 NEW SECTION. **Sec. 507.** Section 424 of this act takes effect
24 June 30, 2025.

25 NEW SECTION. **Sec. 508.** Sections 312, 408 through 414, and 421
26 of this act are necessary for the immediate preservation of the
27 public peace, health, or safety, or support of the state government
28 and its existing public institutions, and take effect immediately.

29 NEW SECTION. **Sec. 509.** Sections 212, 213, 216, and 217 of this
30 act take effect October 1, 2022.

1 NEW SECTION. **Sec. 510.** Sections 214 and 215 of this act take
2 effect January 1, 2023, and apply to registrations that become due on
3 or after that date.

4 NEW SECTION. **Sec. 511.** Sections 201 through 206 of this act
5 take effect July 1, 2023.

6 NEW SECTION. **Sec. 512.** Sections 101 through 106, 208 through
7 211, 218, 301 through 311, 401 through 403, 405 through 407, 415
8 through 420, 422, 423, 425 through 430, and 505 of this act take
9 effect July 1, 2022.
