1 Strike everything after the enacting clause and insert the 2 following: Sec. 1. RCW 1.04.010 and 1951 c 5 s 2 are each amended 3 to read as follows: The ninety-one titles with chapters and sections designated as 5 the "Revised Code of Washington" and attested by the secretary of 6 the senate and the chief clerk of the house of representatives of 7 the legislature of the state of Washington, are hereby enacted and 8 designated as the "Revised Code of Washington." Said code is 9 intended to embrace in a revised, consolidated, and codified form 10 and arrangement all the laws of the state of a general and permanent 11 nature. 12 13 Sec. 2. RCW 1.04.013 and 1951 c 5 s 1 are each amended to read 14 as follows: 15 The titles, chapters, and sections designated as the "1950 16 Supplement to the Revised Code of Washington" attested by the 17 secretary of the senate and the chief clerk of the house of 18 representatives of the legislature of the state of Washington, and 19 filed with the secretary of state, are hereby enacted and 20 consolidated into and with the Revised Code of Washington. Said 1950 21 supplement is intended to embrace (1) in a revised and codified 22 form, all those laws of the state of Washington of a general and 23 permanent nature enacted since January 1, 1949, (2) revision and 24 recodification of certain of the titles, chapters, and sections of 25 the revised code, and (3) application of a new system of numbering 26 to all of the sections and certain of the chapters of the revised 27 code, subject to RCW 1.04.014.

1 Sec. 3. RCW 1.04.014 and 1951 c 5 s 3 are each amended to read 2 as follows: 3 The system of numbering employed in the 1950 supplement is 4 hereby adopted as the general system to be followed in designating 5 sections of the revised code. Specific numbers, in accordance with 6 such system, are authorized to be assigned to sections of the 7 revised code as follows: Those chapters and sections of the revised code expressly 9 numbered or renumbered in the 1950 supplement are authorized to be 10 numbered or renumbered to the new number respectively shown in the 11 1950 supplement. All other sections of the revised code now existing 12 are authorized to be renumbered by tens according to the plan 13 generally used in the 1950 supplement, using the number of the 14 title, the new number, if any, of the chapter in which the section 15 occurs, and adding the digit "0" to the terminal end of the number 16 marking the position of the section within the chapter. The 17 secretary of state shall, before publication of any laws enacted at 18 this session of the legislature which are by their terms expressly 19 amendatory of any section or sections contained in the revised code 20 or the 1950 supplement, renumber each section and correlate the 21 numbers of sections so renumbered, in accordance with this 22 provision, so that each such section when published bears or is 23 referred to by its proper new number. - 14 number for such new section shall be created by the insertion of an

- 19 **Sec. 6.** RCW 1.04.020 and 1951 c 5 s 6 are each amended to read 20 as follows:
- 21 The contents of the Revised Code of Washington, after striking
- 22 therefrom sections repealed or superseded by laws of the state of
- 23 Washington enacted since January 1, 1949, as the revised code is
- 24 supplemented or modified in the 1950 supplement, shall establish the
- 25 laws of this state of a general and permanent nature in effect on
- 26 January 1, 1951; except, that nothing herein shall be construed as
- 27 changing the meaning of any such laws and, as a rule of
- 28 construction, in case of any omissions or any inconsistency between
- 29 any of the provisions of the revised code as so supplemented or
- 30 modified and the laws existing immediately preceding this enactment,
- 31 the previously existing laws shall control. Any section of the
- 32 Revised Code of Washington (as supplemented or modified by the 1950

- 7 of this state of a general and permanent nature in effect on January
- 8 1, 1949, but nothing herein shall be construed as changing the
- 9 meaning of any such laws. In case of any omissions, or any
- 10 inconsistency between any of the provisions of said code and the
- 11 laws existing immediately preceding this enactment, the previously
- 12 existing laws shall control.

- 14 **Sec. 8.** RCW 1.04.030 and 1950 ex.s. c 16 s 3 are each amended
- 15 to read as follows:
- 16 All laws of a general and permanent nature enacted after January
- 17 1, 1949, shall, from time to time, be incorporated into and become a
- 18 part of said code.

- 20 **Sec. 9.** RCW 1.04.040 and 1950 ex.s. c 16 s 4 are each amended
- 21 to read as follows:
- The code may be cited by the abbreviation "RCW."
