1 AN ACT Relating to modifying placement and salary matching
2 requirements for the state work-study program; and amending RCW
3 28B.12.030, 28B.12.040, and 28B.12.050.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 28B.12.030 and 2019 c 406 s 26 are each amended to
6 read as follows:

7 The definitions in this section apply throughout this chapter
8 unless the context clearly requires otherwise.

9 (1) "Eligible institution" means any postsecondary institution in
10 this state accredited by the Northwest Association of Schools and
11 Colleges, or a campus of a member institution of an accrediting
12 association recognized by rule of the student achievement council for
13 purposes of this section, that is eligible for federal student
14 financial aid assistance and has operated as a nonprofit college or
15 university delivering on-site classroom instruction for a minimum of
16 twenty consecutive years within the state of Washington, or any
17 public technical college in the state.

18 (2) "Financial need" has the same meaning as in RCW 28B.92.030.

19 (3) "Office" means the office of student financial assistance.

1 **Sec. 2.** RCW 28B.12.040 and 2012 c 229 s 520 are each amended to
2 read as follows:

3 The (~~student achievement council~~) office shall develop and
4 administer the state work-study program. The (~~council shall be~~
5 ~~authorized to~~) office may create and enter into agreements with
6 employers and eligible institutions (~~for the operation of the~~
7 ~~program. These agreements shall include such provisions as the~~
8 ~~council may deem necessary or appropriate to carry out the purposes~~
9 ~~of this chapter.~~

10 ~~With the exception of off-campus community service placements,~~
11 ~~the share from moneys disbursed under the state work-study program of~~

18 **Sec. 3.** RCW 28B.12.050 and 2011 1st sp.s. c 11 s 144 are each
19 amended to read as follows:

20 (1) The office (of student financial assistance) shall disburse
21 state work-study funds. In performing its duties under this section,
22 the office shall consult eligible institutions and postsecondary
23 education advisory and governing bodies. The office shall establish
24 criteria designed to achieve such distribution of assistance under
25 this chapter among students attending eligible institutions as will
26 most effectively carry out the purposes of this chapter.

27 (2) Funds appropriated for compensation of students placed at
28 state work-study employers must not exceed 80 percent of the total
29 compensation paid to students, subject to the following exceptions:

30 (a) Off-campus community service placements; and
31 (b) Placements at public and nonprofit employers that seek to
32 increase postsecondary enrollment for high school students.

33 (3) The office shall define and approve, and may determine salary
34 matching requirements for, community service placements and
35 placements at public and nonprofit employers that seek to increase
36 postsecondary enrollment for high school students.
