1 AN ACT Relating to the creation of a data dashboard to track
2 policies, funding, and program and health outcomes related to the
3 sale, consumption, and use of regulated substances; and adding a new
4 section to chapter 66.08 RCW.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** A new section is added to chapter 66.08
7 RCW to read as follows:

8 (1) The board, in consultation with the department of health, the
9 health care authority, and other agencies the board deems
10 appropriate, shall publish in a conspicuous location on the board's
11 website and update, at least annually, the information identified in
12 subsection (2) of this section.

13 (2) The following information must be published under this
14 section:

15 (a) Compliance rates regarding the board's enforcement of laws or
16 rules prohibiting the sale of liquor, cannabis, cigarettes, tobacco
17 products, and vapor products to persons under 21 years of age;

18 (b) The number of citations issued annually for violations of
19 laws or rules prohibiting the sale of liquor, cannabis, cigarettes,
20 tobacco products, or vapor products to persons under 21 years of age;

1 (c) The number of citations issued annually for violations of
2 laws or rules prohibiting the sale, service, or delivery of liquor to
3 an intoxicated person or a person who is apparently under the
4 influence of liquor, and for violations of laws or rules prohibiting
5 the purchase or consumption of liquor by a person who is apparently
6 under the influence of liquor;

7 (d) Data from the healthy youth survey about youth use, access,
8 and perceptions of liquor, cannabis, cigarettes, tobacco products,
9 and vapor products in Washington;

10 (e) Information reported to the board from the department of
11 health or the health care authority about the prevalence in
12 Washington state of the use of alcohol, cannabis, cigarettes, tobacco
13 products, and vapor products;

14 (f) Information reported to the board by the department of health
15 and the health care authority about the amount and source of funding
16 appropriated or available per fiscal year to the department of health
17 and the health care authority for programs for preventing and
18 deterring the use of liquor, cannabis, cigarettes, tobacco products,
19 and vapor products and treating substance use disorders related to
20 these regulated substances;

21 (g) Available data reported to the board by the department of
22 health or the health care authority about:

23 (i) Annual health care expenditures in the state caused by
24 liquor, cannabis, cigarettes, tobacco products, and vapor products;

25 (ii) Annual state medicaid total health expenditures caused by
26 consumption or use of liquor, cannabis, cigarettes, tobacco products,
27 and vapor products;

28 (iii) Cessation expenditures for cigarettes or tobacco products
29 through the school employees' benefits board and the public
30 employees' benefits board;

31 (iv) Annual deaths in Washington caused by smoking or consuming
32 cigarettes, tobacco products, alcohol, vapor products, or cannabis;

33 (v) State spending on tobacco prevention and cessation funding as
34 compared to funding levels recommended by the United States centers
35 for disease control and prevention;

36 (vi) Health equity metrics including disparities in the rates of
37 diseases or disorders caused by or associated with the consumption or
38 use of alcohol, cannabis, cigarettes, tobacco products, and vapor
39 products; and

1 (vii) Demographic impact metrics including disparities in the
2 rates of consumption or use of alcohol, cannabis, cigarettes, tobacco
3 products, and vapor products; and
4 (h) The amount of the following taxes, fees, and penalties
5 collected by the state in the most recent fiscal year:
6 (i) Taxes collected from the sale of liquor, cannabis,
7 cigarettes, tobacco products, and vapor products;
8 (ii) License fees collected related to the manufacture,
9 distribution, and sale of liquor, cannabis, cigarettes, tobacco
10 products, and vapor products; and
11 (iii) Money received from penalties imposed by the board on
12 licensees for violations of laws related to the manufacture,
13 distribution, or sale of liquor, cannabis, cigarettes, tobacco
14 products, or vapor products.
