1 AN ACT Relating to the capital budget; amending RCW 70A.65.240  
2 and 70A.65.305; amending 2023 c 474 ss 1013, 1022, 1025, 1032, 6076,

10       The appropriations in this section are subject to the following  
11 conditions and limitations:

12       (1) (a) \$50,000,000 of the state building construction account—  
13 state appropriation and \$11,390,000 of the public works assistance  
14 account—state appropriation in this section (~~is~~) are provided  
15 solely as match for federal authority allocated under this section  
16 and section 7017 of this act for the statewide broadband office to  
17 administer the broadband equity, access, and deployment state grants  
18 program in section 60102 of P.L. 117-58 (infrastructure investment  
19 and jobs act). Expenditure of the amounts in this subsection (~~is~~)  
20 are contingent on the receipt of this grant funding.

21       (b) To the extent permitted by federal law, the office shall  
22 provide state match only for projects where the lead applicant is a  
23 public entity.

24       (c) The legislature intends to provide sufficient funds to match  
25 federal funds available during the 2025-2027 fiscal biennium.

26       (2) In addition to scoring and weighting criteria established

7 infrastructure; dig-once policies; streamlined permitting processes;  
8 and cost-effective access to poles, conduits, easements, and rights-  
9 of-way. To the extent permitted under federal law, the office must  
10 consider creating a pool of grant funds dedicated to pole costs.

4        Communities of Concern (40000603)

5        The appropriations in this section are subject to the following  
6    conditions and limitations:

7        (1) The department shall not expend the appropriation in this  
8    section unless and until the nonstate share of project costs have  
9    been either expended or firmly committed, or both, in an amount  
10   sufficient to complete the project or a distinct phase of the project  
11   that is useable to the public for the purpose intended by the  
12   legislature. This requirement does not apply to projects where a  
13   share of the appropriation is for design costs only.

14        (2) Prior to receiving funds, project recipients must demonstrate  
15   that the project site is under control for a minimum of 10 years,  
16   either through ownership or a long-term lease. This requirement does  
17   not apply to appropriations for preconstruction activities or  
18   appropriations in which the sole purpose is to purchase real property  
19   that does not include a construction or renovation component.

20        (3) Projects funded in this section may be required to comply  
21   with Washington's high performance building standards under chapter  
22   39.35D RCW.

23        (4) Project funds are available on a reimbursement basis only and  
24   may not be advanced under any circumstances.

25        (5) In contracts for grants authorized under this section, the  
26   department shall include provisions that require that capital  
27   improvements be held by the grantee for a specified period of time  
28   appropriate to the amount of the grant and that facilities be used  
29   for the express purpose of the grant. If the grantee is found to be  
30   out of compliance with provisions of the contract, the grantee shall

38        (7) The department must comply with the requirements set forth in

2 historic properties. Consultation with the department of archaeology  
3 and historic preservation and affected tribes must be initiated

29 Green Jobs and Infrastructure Catalytic Funds (40000604)

30 The appropriation in this section is subject to the following  
31 conditions and limitations:

32 (1) The appropriation in this section is provided solely for  
33 grants to eligible entities that help mitigate and reverse the  
34 effects of climate change, help communities meet their energy and  
35 climate change regulatory requirements, bring increased federal and  
36 private investment to the state, help develop the advanced workforce  
37 of the future, and ensure Washington state maintains or grows its  
38 position as a world leader in developing the projects and processes

1 that are used to fight climate change globally. Eligible activities  
2 under this section include, but are not limited to, planning  
3 predevelopment, design, engineering, and construction of clean  
4 technology projects.

5 (2) Entities eligible for grants under this section include, but  
6 are not limited to, local governments, federally recognized tribal  
7 governments and tribes' contracted service providers, public and  
8 private utilities, ports, associate development organizations, for-  
9 profit entities, academic and research institutions, nonprofit  
10 organizations, and state agencies.

11 (3) Projects eligible for funding must be physically located in  
12 Washington state. Eligible projects must be consistent with the state  
13 energy strategy adopted under chapter 43.21F RCW and clean energy  
14 policies under chapter 19.405 RCW. Projects must further the goals of  
15 the climate commitment act as described in RCW 70A.65.260(1)(j).

16 (4) The department must consider equity and environmental justice  
17 when developing the program structures and opportunities for  
18 applicant participation and must follow principles established in its  
19 community engagement plan adopted under RCW 70A.02.050.

20 (5) Except for match funds allocated in subsection (7) of this  
21 section, when soliciting and evaluating grant application proposals,  
22 awarding contracts, and monitoring projects under this section, the  
23 department must:

24 (a) Use competitive processes to select all projects, except as  
25 otherwise noted in this section. The department must design a  
26 competitive process to allow provision of grant award to projects in  
27 a timely manner and consistent with the project timeline.  
28 Applications must be accepted on a rolling basis, and final  
29 determination must be made by the department;

30 (b) Ensure compliance with all applicable laws related to the  
31 project selection process, project monitoring, and contracting; and

32 (c) Prioritize projects that leverage the greatest amount of  
33 matching funds, such as local levy funding or private investment in  
34 advanced manufacturing capability.

35 (6) Project applicants must disclose all sources of public  
36 funding invested in a project. Grant contracts must provide that if,  
37 after a grant has been awarded, the department finds that a grantee  
38 has violated chapter 42.52 RCW, either in procuring or performing  
39 under the grant, the department in its sole discretion may terminate  
40 the grant funding by written notice, and that, if the grant is

1 terminated, the department will reserve its right to pursue all  
2 available remedies under law to address the violation.

3 (7) \$80,000,000 of the appropriation in this section is provided  
4 solely for grants to be used as state match for competitive federal  
5 funding and for formula grants that require state match. To the  
6 extent practicable, the department shall prioritize grants that  
7 provide benefit to vulnerable populations in overburdened  
8 communities, with a goal of directing at least 20 percent of funds to  
9 this purpose.

10 (8) \$50,000,000 of the appropriation in this section is provided  
11 solely for grants to projects that demonstrate high-wage, clean job  
12 creation in Washington, provide risk reduction for investments in  
13 public and private infrastructure to enhance industrial lands in  
14 order to increase a community's capacity for clean manufacturing, or  
15 provide investments in workforce development to attract and train the  
16 workforce required to grow the clean energy economy.

17 (9) \$6,500,000 of the appropriation in this section is provided  
18 solely for the department to support access to and to flexibly  
19 administer the program. The department may use these funds to hire  
20 full-time equivalent positions within the department, as well as  
21 contract for additional capacity and subject matter expertise.

22 (10) The department must strive to allocate all of the amounts  
23 appropriated in this section within the 2023-2025 fiscal biennium in  
24 the manner prescribed in each subsection. However, no sooner than  
25 January 1, 2025, if upon review of applications the department  
26 determines there are not adequate suitable projects in a category,  
27 the department may reallocate funding among the purposes of

29 the department must provide quarterly notice of any funding

3 The appropriation in this section is subject to the following

5 (1) The appropriation in this section is provided solely for the  
6 department to administer noncompetitive grants to nonprofit  
7 organizations, local governments, federally recognized tribal  
8 governments and tribal entities, state agencies, housing authorities,  
9 ports, transit agencies, research organizations, and eligible third-  
10 party administrators for planning, design, and implementation of  
11 capital projects and clean energy technologies that reduce greenhouse  
12 gas emissions in vulnerable, overburdened, and tribal communities  
13 identified by the department. The department must prioritize grants  
14 providing meaningful benefit to vulnerable populations in  
15 overburdened communities as defined under RCW 70A.02.010.

16 (2) Eligible uses of grant funds include, but are not limited to,  
17 planning for sustainable communities and predesign work, energy  
18 efficiency improvements, renewable energy generation, increasing the  
19 supply of affordable, energy efficient housing, developing resilient  
20 and sustainable infrastructure systems, zero-emission, active  
21 mobility, and micromobility transportation infrastructure, education  
22 and engagement, and workforce development.

23 (3) Up to five percent of the appropriation in this section is  
24 for the department to administer the grant program. Administration  
25 includes, but is not limited to, identifying eligible communities and  
26 third-party administrators, providing technical assistance, managing  
27 contracts, reporting, and providing planning and implementation  
28 assistance.

29 (4) For the purposes of this section, "eligible third-party  
30 administrators" means entities that have sufficient expertise and  
31 relationships within the identified community to help plan for,  
32 design, or implement capital projects that reduce greenhouse gases or  
33 develop clean energy resources for the community.

14 The appropriation in this section is subject to the following  
15 conditions and limitations:

16 (1) \$80,000,000 of the appropriation in this section is provided  
17 solely for eligible organizations defined under RCW 43.185A.040 to  
18 acquire, renovate, and prepare real property for rapid conversion  
19 into enhanced emergency shelters, permanent supportive housing,  
20 transitional housing, permanent housing, youth housing, or shelter  
21 for extremely low-income people, as well as individuals, families,  
22 unaccompanied youth, and young people experiencing sheltered and  
23 unsheltered homelessness. Acquisitions completed with temporary  
24 financing are eligible for funding provided in this section. The  
25 department may only approve funding for projects that result in  
26 increased shelter or housing capacity.

27 (a) Acquisition of multifamily housing is a priority, and the  
28 department shall prioritize housing projects that rapidly move people  
29 experiencing unsheltered homelessness into housing, including, but  
30 not limited to, individuals living in unsanctioned encampments, the  
31 public rights-of-way, or other public spaces.

32 (b) Amounts provided in this section may not be used for  
33 operating or maintenance costs, supportive services, or debt service.

34 (2) \$5,000,000 of the appropriation in this section is provided

36 transitional tiny homes or similar housing. Awards may be made to

16 other rights and interests in tribal lands and lands within which a  
17 tribe or tribes possess rights reserved or protected by federal  
18 treaty, statute, or executive order. The consultation is independent  
19 of, and in addition to, any public participation process required by  
20 federal or state law, or by a federal or state agency, including the  
21 requirements of Executive Order 21-02 related to archaeological and  
22 cultural resources, and regardless of whether the agency receives a  
23 request for consultation from a federally recognized tribe. The goal  
24 of the consultation process is to identify tribal resources or rights  
25 potentially affected by the funding decisions and funding programs,  
26 assess their effects, and seek ways to avoid, minimize, or mitigate  
27 any adverse effects on tribal resources or rights.

28 (2) At the earliest possible date prior to submittal of an  
29 application, applicants for funding from the accounts created in RCW  
30 70A.65.250, 70A.65.260, and 70A.65.270 shall engage in a  
31 preapplication process with all affected federally recognized tribes  
32 within the project area. During the 2023-2025 fiscal biennium, salmon  
33 habitat and climate resilience projects funded from the natural  
34 climate solutions account created in RCW 70A.65.270 that went through  
35 the application and prioritization process before July 1, 2023, are  
36 exempt from the preapplication requirements under this subsection.

37 (a) The preapplication process must include the applicant  
38 notifying the department of archaeology and historic preservation,  
39 the department of fish and wildlife, and all affected federally

1 recognized tribes within the project area. The notification must  
2 include geographical location, detailed scope of the proposed  
3 project, preliminary application details available to federal, state,  
4 or local governmental jurisdictions, and all publicly available  
5 materials, including public funding sources.

6 (b) The applicant must also offer to discuss the project with the  
7 department of archaeology and historic preservation, the department  
8 of fish and wildlife, and all affected federally recognized tribes  
9 within the project area. Discussions may include the project's impact  
10 to tribal resources, including tribal cultural resources,  
11 archaeological sites, sacred sites, fisheries, or other rights and  
12 interests in tribal lands and lands within which a tribe or tribes  
13 possess rights reserved or protected by federal treaty, statute, or  
14 executive order.

15 (c) All affected federally recognized tribes may submit to the  
16 appropriate agency or agencies a summary of tribal issues, questions,  
17 concerns, or other statements regarding the project, which must  
18 become part of the official application file. The summary does not  
19 limit what issues affected federally recognized tribes may raise in  
20 the consultation process identified in subsections (1), (3) through  
21 (7), and (9) of this section.

22 (d) The notification and offer to initiate discussion must be  
23 documented with the application when it is filed, and a copy of the  
24 application must be delivered to the department of archaeology and  
25 historic preservation, the department of fish and wildlife, and to  
26 the affected federally recognized tribe or tribes. If the discussions  
27 pursuant to (b) of this subsection do not occur, the applicant must  
28 document the reason why the discussion or discussions did not occur.

29 (e) Nothing in this section may be interpreted to require the  
30 disclosure of information that is exempt from disclosure pursuant to  
31 RCW 42.56.300 or federal law, including section 304 of the national  
32 historic preservation act of 1966. Any information that is exempt  
33 from disclosure pursuant to RCW 42.56.300 or federal law, including  
34 section 304 of the national historic preservation act of 1966, shall  
35 not become part of the official application file.

36 (3) If any funding decision, program, project, or activity that  
37 may impact tribal resources, including tribal cultural resources,  
38 archaeological sites, sacred sites, fisheries, or other rights and  
39 interests in tribal lands and lands within which a tribe or tribes  
40 possess rights reserved by federal treaty, statute, or executive

1 order is funded from the accounts created in RCW 70A.65.250,  
2 70A.65.260, and 70A.65.270 without such a consultation with an  
3 affected federally recognized tribe, the affected federally  
4 recognized tribe may request that all further action on the decision,  
5 program, project, or activity cease until meaningful consultation is  
6 completed. Upon receipt of such a request by an agency or agencies  
7 with the authority to allocate funding or administer grant programs  
8 from the accounts listed in subsection (1) of this section in support  
9 of the proposed project, further action by the agency or agencies on  
10 any decision, program, project, or activity that would result in  
11 significant physical disturbance of the tribal resource or resources  
12 described in this subsection must cease until the consultation has  
13 been completed.

14 (4) Upon completion of agency and tribal consultation, an  
15 affected federally recognized tribe may request a formal review of  
16 the consultation by submitting a request to the governor's office of  
17 Indian affairs and notifying the appropriate agencies and the  
18 department of archaeology and historic preservation. The state  
19 agencies and tribe must meet to initiate discussion within no more  
20 than 20 days of the request. This consultation must be offered and  
21 conducted separately with each affected federally recognized tribe,  
22 unless the tribes agree to conduct a joint consultation with the  
23 state.

24 (5) After the state agencies and tribe or tribes have conducted a  
25 formal review under subsection (4) of this section, an affected  
26 federally recognized tribe or state agency may request that the  
27 governor and an elected tribal leader or leaders of a federally  
28 recognized tribal government meet to formally consider the  
29 recommendations from the parties. If requested, this meeting must  
30 occur within 30 days of the request, except that a federally  
31 recognized tribe may choose to opt out of the meeting. This timeline  
32 may be extended by mutual agreement between the governor and the  
33 tribal leaders.

34 (6) After the meeting identified in subsection (5) of this  
35 section has occurred, the governor or an elected tribal leader of a  
36 federally recognized tribe may call for the state and tribe or tribes  
37 to enter into formal mediation, except that a federally recognized  
38 tribe may choose to opt out of the mediation. If entered into, the  
39 mediation must be conducted as a government-to-government proceeding,  
40 with each sovereign government retaining their right to a final

1 decision that meets their separate obligations and interests.  
2 Mediators must be jointly selected by the parties to the mediation.  
3 An agreement between the governor and a tribal leader or leaders  
4 resulting from the mediation is formally recognized and binding on  
5 the signatory parties. Absent an agreement, participation in  
6 mediation does not preclude any additional steps that any party can  
7 initiate, including legal review, to resolve a continuing  
8 disagreement.

9 (7) During the proceedings outlined in subsections (4) through  
10 (6) of this section, the agency or agencies with the authority to  
11 allocate funding or administer grant programs from the accounts  
12 listed in subsection (1) of this section in support of the proposed  
13 project may not approve or release funding, or make other formal  
14 decisions, including permitting, that advance the proposed project  
15 except where required by law.

16 (8) By June 30, 2023, the governor's office of Indian affairs, in  
17 coordination with the department of archaeology and historic  
18 preservation and federally recognized tribes, shall develop a state  
19 agency tribal consultation process, including best practices for  
20 early, meaningful, and effective consultation, early notification and  
21 engagement by applicants with federally recognized tribes as a part  
22 of the preapplication process in subsection (2) of this section, and  
23 protocols for communication and collaboration with federally  
24 recognized tribes. The consultation process developed under this  
25 section must be periodically reviewed and updated in coordination  
26 with federally recognized tribes. The governor's office of Indian  
27 affairs must provide training and other technical assistance to state  
28 agencies, as they implement the required consultation.  
29 Notwithstanding the governor's office of Indian affairs' ongoing work

3 (11) Subject to the availability of amounts appropriated for this  
4 specific purpose, the department must establish a tribal capacity  
5 grant program to provide funding to federally recognized tribes for  
6 the costs of implementing this section.

7 NEW SECTION. **Sec. 8006.** If any provision of this act or its  
8 application to any person or circumstance is held invalid, the  
9 remainder of the act or the application of the provision to other  
10 persons or circumstances is not affected.

11 NEW SECTION. **Sec. 8007.** This act is necessary for the immediate  
12 preservation of the public peace, health, or safety, or support of  
13 the state government and its existing public institutions, and takes  
14 effect immediately.
