1 AN ACT Relating to recognizing election day; amending RCW 2 1.16.050; adding a new section to chapter 29A.04 RCW; and creating a 3 new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

Sec. 1. The legislature finds that free and fair 5 NEW SECTION. 6 elections are the cornerstone of American democracy, and the 7 corresponding right to vote is among the most fundamental privileges of American citizenship. Holding steadfast to these principles, the 8 state of Washington has a long history of protecting Washingtonians' 9 right to vote in elections, easing barriers to participation, 10 11 combating attempts to suppress turnout, and promoting civic engagement. As a result, Washington routinely ranks among the highest 12 13 states in the nation in voter participation, and it has some of the 14 most accessible voting policies in the nation.

The legislature believes that celebrating election day serves as an important reminder of the crucial role of elections in our society. Further, the legislature believes that celebrating election day encourages participation in the democratic process and instills civic values in Washingtonians. Therefore, to increase awareness and participation in elections, and to commemorate this foundational

American institution, the legislature intends to recognize the first
Tuesday after the first Monday of November as "election day."

Sec. 2. RCW 1.16.050 and 2024 c 76 s 3 are each amended to read 3 as follows: 4 5 (1) The following are state legal holidays: 6 (a) Sunday; 7 (b) The first day of January, commonly called New Year's Day; (c) The third Monday of January, celebrated as the anniversary of 8 the birth of Martin Luther King, Jr.; 9 10 (d) The third Monday of February, to be known as Presidents' Day and celebrated as the anniversary of the births of Abraham Lincoln 11 12 and George Washington; 13 (e) The last Monday of May, commonly known as Memorial Day; (f) The nineteenth day of June, recognized as Juneteenth, a day 14 of remembrance for the day the African slaves learned of their 15 16 freedom; 17 (g) The fourth day of July, the anniversary of the Declaration of Independence; 18 19 (h) The first Monday in September, to be known as Labor Day; 20 (i) The eleventh day of November, to be known as Veterans Day; (j) The fourth Thursday in November, to be known as Thanksgiving 21 22 Day; 23 (k) The Friday immediately following the fourth Thursday in 24 November, to be known as Native American Heritage Day; and 25 (1) The twenty-fifth day of December, commonly called Christmas 26 Day. (2) Employees of the state and its political subdivisions, except 27 employees of school districts and except those nonclassified 28 employees of institutions of higher education who hold appointments 29 30 or are employed under contracts to perform services for periods of less than twelve consecutive months, are entitled to one paid holiday 31 per calendar year in addition to those specified in this section. 32 Each employee of the state or its political subdivisions may select 33 the day on which the employee desires to take the additional holiday 34 35 provided for in this section after consultation with the employer pursuant to guidelines to be promulgated by rule of the appropriate 36 personnel authority, or in the case of local government by ordinance 37 or resolution of the legislative authority. 38

1 (3) Employees of the state and its political subdivisions, including employees of school districts and those nonclassified 2 employees of institutions of higher education who hold appointments 3 or are employed under contracts to perform services for periods of 4 less than twelve consecutive months, are entitled to two unpaid 5 6 holidays per calendar year for a reason of faith or conscience or an organized activity conducted under the auspices of a religious 7 denomination, church, or religious organization. This includes 8 employees of public institutions of higher education, including 9 community colleges, technical colleges, and workforce training 10 11 programs. The employee may select the days on which the employee 12 desires to take the two unpaid holidays after consultation with the employer pursuant to guidelines to be promulgated by rule of the 13 appropriate personnel authority, or in the case of local government 14 by ordinance or resolution of the legislative authority. If an 15 16 employee prefers to take the two unpaid holidays on specific days for 17 a reason of faith or conscience, or an organized activity conducted under the auspices of a religious denomination, church, or religious 18 organization, the employer must allow the employee to do so unless 19 the employee's absence would impose an undue hardship on the employer 20 21 or the employee is necessary to maintain public safety. Undue 22 hardship shall have the meaning established in rule by the office of 23 financial management under RCW 43.41.109.

(4) If any of the state legal holidays specified in this section 24 25 are also federal legal holidays but observed on different dates, only 26 the state legal holidays are recognized as a paid legal holiday for employees of the state and its political subdivisions. However, for 27 28 port districts and the law enforcement and public transit employees 29 of municipal corporations, either the federal or the state legal holiday is recognized as a paid legal holiday, but in no case may 30 31 both holidays be recognized as a paid legal holiday for employees.

(5) Whenever any state legal holiday:

(a) Other than Sunday, falls upon a Sunday, the following Mondayis the legal holiday; or

35 (b) Falls upon a Saturday, the preceding Friday is the legal 36 holiday.

37 (6) Nothing in this section may be construed to have the effect 38 of adding or deleting the number of paid holidays provided for in an 39 agreement between employees and employers of political subdivisions

1 of the state or as established by ordinance or resolution of the 2 local government legislative authority. (7) The legislature declares that the following days are 3 recognized as provided in this subsection, but may not be considered 4 legal holidays for any purpose: 5 6 (a) The thirteenth day of January, recognized as Korean-American 7 day; (b) The twelfth day of October, recognized as Columbus day; 8 9 (c) The ninth day of April, recognized as former prisoner of war

10 recognition day;

11 (d) The twenty-sixth day of January, recognized as Washington 12 army and air national guard day;

13 (e) The seventh day of August, recognized as purple heart 14 recipient recognition day;

15 (f) The second Sunday in October, recognized as Washington state 16 children's day;

(g) The sixteenth day of April, recognized as Mother Joseph day;

18 (h) The fourth day of September, recognized as Marcus Whitman 19 day;

20 (i) The seventh day of December, recognized as Pearl Harbor 21 remembrance day;

(j) The twenty-seventh day of July, recognized as national Korean war veterans armistice day;

(k) The nineteenth day of February, recognized as civil libertiesday of remembrance;

26 (1) The thirtieth day of March, recognized as welcome home 27 Vietnam veterans day;

28 (m) The eleventh day of January, recognized as human trafficking 29 awareness day;

30 (n) The thirty-first day of March, recognized as Cesar Chavez 31 day;

32 (o) The tenth day of April, recognized as Dolores Huerta day;

33 (p) The fourth Saturday of September, recognized as public lands 34 day;

35 (q) The eighteenth day of December, recognized as blood donor 36 day;

37 (r) The fifteenth day of May, recognized as water safety day;

38 (s) The ninth day of March, recognized as Billy Frank Jr. day; 39 ((and))

1 (t) The date corresponding with the second new moon following the 2 winter solstice, or the third new moon following the winter solstice 3 should an intercalary month intervene, recognized as the lunar new 4 year; and

5 <u>(u) The first Tuesday after the first Monday of November,</u> 6 <u>recognized as election day</u>.

7 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 29A.04 8 RCW to read as follows:

9 The legislature encourages state governmental entities, local 10 governments, schools and institutions of higher education, and 11 cultural organizations to recognize election day and engage in 12 educational programming related to democracy and voting. For purposes 13 of this section, "election day" is the first Tuesday after the first 14 Monday of November.
