29 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

30 NEW SECTION. **Sec. 1.** RCW 1.08.025 directs the code reviser,
31 with the approval of the statute law committee, to prepare
32 legislation for submission to the legislature "concerning
33 deficiencies, conflicts, or obsolete provisions" in statutes. This
34 act makes technical, nonsubstantive amendments as follows:

35 (1) Section 1001 of this act places legislatively recognized days
36 in calendar order.

37 (2) Section 1002 of this act corrects a cross reference
38 concerning the sentencing of sex offenders.

1 (3) Section 1003 of this act corrects a drafting error concerning
2 the number of hours of supervised experience for licensed advanced
3 social workers.

4 (4) Section 1004 of this act renumbers a definition section in
5 order to combine two subsections defining the term "commercial
6 telephone solicitor."

7 (5) Sections 1005 through 1007 of this act correct errors in
8 internal references of the Washington business corporation act.

9 (6) Section 1008 of this act removes a duplicative cross
10 reference created by merging multiple amendments.

11 (7) Section 1009 of this act corrects a cross reference
12 concerning the definition of liquor retailers.

13 (8) Section 1010 of this act decodifies sections relating to
14 various groups whose work has concluded.

15 (9) Section 1011 of this act repeals a session law section
16 omitted in error from the repeal of RCW 10.31.115 by chapter 1, Laws
17 of 2023 sp. sess.

18 (10) Sections 2001 through 2051 of this act adjust cross
19 references to reflect recodification of sections and changes in
20 subsection numbering.

21 (11) Sections 3001 through 3011 of this act merge multiple
22 amendments created when sections were amended without reference to
23 other amendments made in the same session.

24 (12) Sections 4001 through 4010 of this act change the term
25 "marijuana" to "cannabis" in uncodified notes published in the
26 Revised Code of Washington.

27 (13) Sections 5001 through 5172 of this act change the term
28 "nursing care quality assurance commission" to "state board of
29 nursing," in accordance with chapter 123, Laws of 2023, and "advanced
30 registered nurse practitioner" to "advanced practice registered
31 nurse," in accordance with chapter 239, Laws of 2024.

32 **PART I**

33 **GENERAL CORRECTIONS**

34 **Sec. 1001.** RCW 1.16.050 and 2024 c 76 s 3 are each amended to
35 read as follows:

36 (1) The following are state legal holidays:

37 (a) Sunday;

38 (b) The first day of January, commonly called New Year's Day;

1 (c) The third Monday of January, celebrated as the anniversary of
2 the birth of Martin Luther King, Jr.;

3 (d) The third Monday of February, to be known as Presidents' Day
4 and celebrated as the anniversary of the births of Abraham Lincoln
5 and George Washington;

6 (e) The last Monday of May, commonly known as Memorial Day;

7 (f) The nineteenth day of June, recognized as Juneteenth, a day
8 of remembrance for the day the African slaves learned of their
9 freedom;

10 (g) The fourth day of July, the anniversary of the Declaration of
11 Independence;

12 (h) The first Monday in September, to be known as Labor Day;

13 (i) The eleventh day of November, to be known as Veterans Day;

14 (j) The fourth Thursday in November, to be known as Thanksgiving
15 Day;

16 (k) The Friday immediately following the fourth Thursday in
17 November, to be known as Native American Heritage Day; and

18 (l) The twenty-fifth day of December, commonly called Christmas
19 Day.

20 (2) Employees of the state and its political subdivisions, except
21 employees of school districts and except those nonclassified
22 employees of institutions of higher education who hold appointments
23 or are employed under contracts to perform services for periods of
24 less than twelve consecutive months, are entitled to one paid holiday
25 per calendar year in addition to those specified in this section.
26 Each employee of the state or its political subdivisions may select
27 the day on which the employee desires to take the additional holiday
28 provided for in this section after consultation with the employer
29 pursuant to guidelines to be promulgated by rule of the appropriate
30 personnel authority, or in the case of local government by ordinance
31 or resolution of the legislative authority.

32 (3) Employees of the state and its political subdivisions,
33 including employees of school districts and those nonclassified
34 employees of institutions of higher education who hold appointments
35 or are employed under contracts to perform services for periods of
36 less than twelve consecutive months, are entitled to two unpaid
37 holidays per calendar year for a reason of faith or conscience or an
38 organized activity conducted under the auspices of a religious
39 denomination, church, or religious organization. This includes
40 employees of public institutions of higher education, including

1 community colleges, technical colleges, and workforce training
2 programs. The employee may select the days on which the employee
3 desires to take the two unpaid holidays after consultation with the
4 employer pursuant to guidelines to be promulgated by rule of the
5 appropriate personnel authority, or in the case of local government
6 by ordinance or resolution of the legislative authority. If an
7 employee prefers to take the two unpaid holidays on specific days for
8 a reason of faith or conscience, or an organized activity conducted
9 under the auspices of a religious denomination, church, or religious
10 organization, the employer must allow the employee to do so unless
11 the employee's absence would impose an undue hardship on the employer
12 or the employee is necessary to maintain public safety. Undue
13 hardship shall have the meaning established in rule by the office of
14 financial management under RCW 43.41.109.

15 (4) If any of the state legal holidays specified in this section
16 are also federal legal holidays but observed on different dates, only
17 the state legal holidays are recognized as a paid legal holiday for
18 employees of the state and its political subdivisions. However, for
19 port districts and the law enforcement and public transit employees
20 of municipal corporations, either the federal or the state legal
21 holiday is recognized as a paid legal holiday, but in no case may
22 both holidays be recognized as a paid legal holiday for employees.

23 (5) Whenever any state legal holiday:

24 (a) Other than Sunday, falls upon a Sunday, the following Monday
25 is the legal holiday; or

26 (b) Falls upon a Saturday, the preceding Friday is the legal
27 holiday.

28 (6) Nothing in this section may be construed to have the effect
29 of adding or deleting the number of paid holidays provided for in an
30 agreement between employees and employers of political subdivisions
31 of the state or as established by ordinance or resolution of the
32 local government legislative authority.

33 (7) The legislature declares that the following days are
34 recognized as provided in this subsection, but may not be considered
35 legal holidays for any purpose:

30 **Sec. 1002.** RCW 9.94A.507 and 2008 c 231 s 33 are each amended to
31 read as follows:

32 (1) An offender who is not a persistent offender shall be
33 sentenced under this section if the offender:

34 (a) Is convicted of:

35 (i) Rape in the first degree, rape in the second degree, rape of
36 a child in the first degree, child molestation in the first degree,
37 rape of a child in the second degree, or indecent liberties by
38 forcible compulsion;

1 (ii) Any of the following offenses with a finding of sexual
2 motivation: Murder in the first degree, murder in the second degree,
3 homicide by abuse, kidnapping in the first degree, kidnapping in the
4 second degree, assault in the first degree, assault in the second
5 degree, assault of a child in the first degree, assault of a child in
6 the second degree, or burglary in the first degree; or

7 (iii) An attempt to commit any crime listed in this subsection
8 (1)(a); or

9 (b) Has a prior conviction for an offense listed in RCW
10 9.94A.030(~~(31)(b)~~) (37)(b), and is convicted of any sex offense
11 other than failure to register.

12 (2) An offender convicted of rape of a child in the first or
13 second degree or child molestation in the first degree who was
14 seventeen years of age or younger at the time of the offense shall
15 not be sentenced under this section.

16 (3)(a) Upon a finding that the offender is subject to sentencing
17 under this section, the court shall impose a sentence to a maximum
18 term and a minimum term.

19 (b) The maximum term shall consist of the statutory maximum
20 sentence for the offense.

21 (c)(i) Except as provided in (c)(ii) of this subsection, the
22 minimum term shall be either within the standard sentence range for
23 the offense, or outside the standard sentence range pursuant to RCW
24 9.94A.535, if the offender is otherwise eligible for such a sentence.

25 (ii) If the offense that caused the offender to be sentenced
26 under this section was rape of a child in the first degree, rape of a
27 child in the second degree, or child molestation in the first degree,
28 and there has been a finding that the offense was predatory under RCW
29 9.94A.836, the minimum term shall be either the maximum of the
30 standard sentence range for the offense or twenty-five years,
31 whichever is greater. If the offense that caused the offender to be
32 sentenced under this section was rape in the first degree, rape in
33 the second degree, indecent liberties by forcible compulsion, or
34 kidnapping in the first degree with sexual motivation, and there has
35 been a finding that the victim was under the age of fifteen at the
36 time of the offense under RCW 9.94A.837, the minimum term shall be
37 either the maximum of the standard sentence range for the offense or
38 twenty-five years, whichever is greater. If the offense that caused
39 the offender to be sentenced under this section is rape in the first
40 degree, rape in the second degree with forcible compulsion, indecent

1 liberties with forcible compulsion, or kidnapping in the first degree
2 with sexual motivation, and there has been a finding under RCW
3 9.94A.838 that the victim was, at the time of the offense,
4 developmentally disabled, mentally disordered, or a frail elder or
5 vulnerable adult, the minimum sentence shall be either the maximum of
6 the standard sentence range for the offense or twenty-five years,
7 whichever is greater.

8 (d) The minimum terms in (c)(ii) of this subsection do not apply
9 to a juvenile tried as an adult pursuant to RCW 13.04.030(1)(e) (i)
10 or (v). The minimum term for such a juvenile shall be imposed under
11 (c)(i) of this subsection.

12 (4) A person sentenced under subsection (3) of this section shall
13 serve the sentence in a facility or institution operated, or utilized
14 under contract, by the state.

15 (5) When a court sentences a person to the custody of the
16 department under this section, the court shall, in addition to the
17 other terms of the sentence, sentence the offender to community
18 custody under the supervision of the department and the authority of
19 the board for any period of time the person is released from total
20 confinement before the expiration of the maximum sentence.

21 (6)(a) As part of any sentence under this section, the court
22 shall also require the offender to comply with any conditions imposed
23 by the board under RCW 9.95.420 through 9.95.435.

24 (b) An offender released by the board under RCW 9.95.420 is
25 subject to the supervision of the department until the expiration of
26 the maximum term of the sentence. The department shall monitor the
27 offender's compliance with conditions of community custody imposed by
28 the court, department, or board, and promptly report any violations
29 to the board. Any violation of conditions of community custody
30 established or modified by the board are subject to the provisions of
31 RCW 9.95.425 through 9.95.440.

32 **Sec. 1003.** RCW 18.225.090 and 2024 c 371 s 14 are each amended
33 to read as follows:

34 (1) The secretary shall issue a license to any applicant who
35 demonstrates to the satisfaction of the secretary that the applicant
36 meets the following education and experience requirements for the
37 applicant's practice area.

38 (a) Licensed social work classifications:

39 (i) Licensed advanced social worker:

1 (A) Graduation from a master's social work educational program
2 accredited by the council on social work education or a social work
3 doctorate program at a university accredited by a recognized
4 accrediting organization, and approved by the secretary based upon
5 nationally recognized standards;

6 (B) Successful completion of an approved examination;

7 (C) Successful completion of a supervised experience requirement.

8 The supervised experience requirement consists of a minimum of
9 (~~3,200~~ [~~3,000~~]) 3,000 hours with supervision by an approved
10 supervisor who has been licensed for at least two years. Of those
11 supervised hours:

12 (I) At least 90 hours must include direct supervision as
13 specified in this subsection by a licensed independent clinical
14 social worker, a licensed advanced social worker, or an equally
15 qualified licensed mental health professional. Of those hours of
16 directly supervised experience at least 40 hours must be in one-to-
17 one supervision and 50 hours may be in one-to-one supervision or
18 group supervision; and

19 (II) 800 hours must be in direct client contact; and

20 (D) Successful completion of continuing education requirements
21 established in rule by the secretary in consultation with the
22 committee, including a minimum number of hours in professional
23 ethics.

24 (ii) Licensed independent clinical social worker:

25 (A) Graduation from a master's level social work educational
26 program accredited by the council on social work education or a
27 social work doctorate program at a university accredited by a
28 recognized accrediting organization, and approved by the secretary
29 based upon nationally recognized standards;

30 (B) Successful completion of an approved examination;

31 (C) Successful completion of a supervised experience requirement.

32 The supervised experience requirement consists of a minimum of 3,000
33 hours of experience, over a period of not less than two years, with
34 supervision by an approved supervisor who has been licensed for at
35 least two years and, as specified in this subsection, may be either a
36 licensed independent clinical social worker who has had at least one
37 year of experience in supervising the clinical social work of others
38 or an equally qualified licensed mental health practitioner. Of those
39 supervised hours:

40 (I) At least 1,000 hours must be direct client contact; and

1 (II) Hours of direct supervision must include:
2 (1) At least 100 hours by a licensed mental health practitioner;
3 (2) At least 70 hours of supervision with a licensed independent
4 clinical social worker meeting the qualifications under this
5 subsection (1)(a)(ii)(C); the remaining hours may be supervised by an
6 equally qualified licensed mental health practitioner; and
7 (3) At least 60 hours must be in one-to-one supervision and the
8 remaining hours may be in one-to-one supervision or group
9 supervision; and
10 (D) Successful completion of continuing education requirements
11 established in rule by the secretary in consultation with the
12 committee, including a minimum number of hours in professional
13 ethics.
14 (b) Licensed mental health counselor:
15 (i)(A) Graduation from a master's or doctoral level educational
16 program in counseling that consists of at least 60 semester hours or
17 90 quarter hours, or includes at least 60 semester hours or 90
18 quarter hours of graduate coursework that includes the following
19 topic areas:
20 (I) Mental health counseling orientation and ethical practice;
21 (II) Social and cultural diversity;
22 (III) Human growth and development;
23 (IV) Career development;
24 (V) Counseling and helping relationships;
25 (VI) Group counseling and group work;
26 (VII) Diagnosis and treatment;
27 (VIII) Assessment and testing; and
28 (IX) Research and program evaluation; or
29 (B) Graduation from a master's or doctoral level educational
30 program in a related discipline from a college or university approved
31 by the secretary based upon nationally recognized standards. An
32 applicant who satisfies the educational requirements for licensure
33 under this subsection (1)(b)(i)(B) is not qualified to exercise the
34 privilege to practice under the counseling compact established in
35 chapter 18.17 RCW unless the master's or doctoral level educational
36 program in a related discipline consists of at least 60 semester
37 hours or 90 quarter hours, or includes at least 60 semester hours or
38 90 quarter hours of graduate coursework that includes the topic areas
39 specified in (b)(i)(A)(I) through (IX) of this subsection;
40 (ii) Successful completion of an approved examination;

1 (iii) Successful completion of a supervised experience
2 requirement. The experience requirement consists of a minimum of 36
3 months full-time counseling or 3,000 hours of postgraduate mental
4 health counseling under the supervision of a qualified licensed
5 mental health counselor or equally qualified licensed mental health
6 practitioner, in an approved setting. The 3,000 hours of required
7 experience includes a minimum of 100 hours spent in immediate
8 supervision with the qualified licensed mental health counselor, and
9 includes a minimum of 1,200 hours of direct counseling with
10 individuals, couples, families, or groups; and

11 (iv) Successful completion of continuing education requirements
12 established in rule by the secretary in consultation with the
13 committee, including a minimum number of hours in professional
14 ethics.

15 (c) Licensed marriage and family therapist:

16 (i) Graduation from a master's degree or doctoral degree
17 educational program in marriage and family therapy or graduation from
18 an educational program in an allied field equivalent to a master's
19 degree or doctoral degree in marriage and family therapy approved by
20 the secretary based upon nationally recognized standards;

21 (ii) Successful passage of an approved examination;

22 (iii) Successful completion of a supervised experience
23 requirement. The experience requirement consists of a minimum of

6 (11) "Predatory" means acts directed toward strangers,
7 individuals with whom a relationship has been established or promoted
8 for the primary purpose of victimization, or casual acquaintances
9 with whom no substantial personal relationship exists. Predatory
10 behavior may be characterized by planning and/or rehearsing the act,
11 stalking, and/or grooming the victim.

12 (12) "Qualified professional" means a person with at least three
13 years' prior experience working with individuals with developmental
14 disabilities, and: (a) If the person being assessed has demonstrated
15 sexually aggressive or sexually violent behavior, that person must be
16 assessed by a qualified professional who is a certified sex offender
17 treatment provider, or affiliate sex offender treatment provider
18 working under the supervision of a certified sex offender treatment
19 provider; or (b) if the person being assessed has demonstrated
20 violent, dangerous, or aggressive behavior, that person must be
21 assessed by a licensed psychologist or psychiatrist who has received
22 specialized training in the treatment of or has at least three years'
23 prior experience treating violent or aggressive behavior.

24 (13) "Treatment team" means the program participant and the group
25 of people responsible for the development, implementation, and
26 monitoring of the person's individualized supports and services. This
27 group may include, but is not limited to, the case resource manager,
28 therapist, residential provider, employment/day program provider, and
29 the person's legal representative and/or family, provided the person
30 consents to the family member's involvement.

31 (14) "Violent offense" means any felony defined as a violent
32 offense in RCW 9.94A.030.

33 (15) "Waiver" means the community-based funding under section
34 1915 of Title XIX of the federal social security act.

15 and conclusions regarding the consistency of the proposal with the

18 either approve the proposal as submitted, recommend specific changes
19 necessary to make the proposal approvable, or deny approval of the
20 proposal in those instances where no alteration of the proposal

23 be provided to the local government, and made available to all
24 interested persons, parties, groups, and agencies of record on the

28 the written findings and conclusions to the local government, the
29 local government may:

30 (i) Agree to the proposed changes by written notice to the

32 (ii) Submit an alternative proposal. If, in the opinion of the
33 department, the alternative is consistent with the purpose and intent
34 of the changes originally submitted by the department and with this
35 chapter it shall approve the changes and provide notice to all
36 recipients of the written findings and conclusions. If the department

2 relating to shorelines unless it determines that the submitted
3 segments are not consistent with the policy of RCW 90.58.020 and the

5 (4) The department shall approve the segment of a master program
6 relating to critical areas as defined by RCW 36.70A.030(~~(+5)~~)
7 provided the master program segment is consistent with RCW 90.58.020
8 and applicable shoreline guidelines, and if the segment provides a
9 level of protection of critical areas at least equal to that provided
10 by the local government's critical areas ordinances adopted and
11 thereafter amended pursuant to RCW 36.70A.060(2).

12 (5) The department shall approve those segments of the master
13 program relating to shorelines of statewide significance only after
14 determining the program provides the optimum implementation of the
15 policy of this chapter to satisfy the statewide interest. If the
16 department does not approve a segment of a local government master
17 program relating to a shoreline of statewide significance, the
18 department may develop and by rule adopt an alternative to the local
19 government's proposal.

20 (6) In the event a local government has not complied with the

22 to the department elect to adopt a master program for the shorelines
23 within its jurisdiction, in which event it shall comply with the
24 provisions established by this chapter for the adoption of a master

29 (7) A master program or amendment to a master program takes

28 the disciplining authority determines that the unprofessional conduct
29 may be the result of an applicable impairing or potentially impairing
30 health condition, the disciplining authority may refer the license
31 holder to a physician health program or a voluntary substance use
32 disorder monitoring program approved by the disciplining authority.

33 The cost of evaluation and treatment shall be the responsibility
34 of the license holder, but the responsibility does not preclude
35 payment by an employer, existing insurance coverage, or other
36 sources. Evaluation and treatment shall be provided by providers
37 approved by the entity or the commission. The disciplining authority

1 may also approve the use of out-of-state programs. Referral of the
2 license holder to the physician health program or voluntary substance
3 use disorder monitoring program shall be done only with the consent
4 of the license holder. Referral to the physician health program or
5 voluntary substance use disorder monitoring program may also include
6 probationary conditions for a designated period of time. If the
7 license holder does not consent to be referred to the program or does
8 not successfully complete the program, the disciplining authority may
9 take appropriate action under RCW 18.130.160 which includes
10 suspension of the license unless or until the disciplining authority,
11 in consultation with the director of the applicable program,
12 determines the license holder is able to practice safely. The
13 secretary shall adopt uniform rules for the evaluation by the
14 disciplining authority of return to substance use or program
15 violation on the part of a license holder in the program. The
16 evaluation shall encourage program participation with additional
17 conditions, in lieu of disciplinary action, when the disciplining
18 authority determines that the license holder is able to continue to
19 practice with reasonable skill and safety.

20 (2) In addition to approving the physician health program or the
21 voluntary substance use disorder monitoring program that may receive
22 referrals from the disciplining authority, the disciplining authority
23 may establish by rule requirements for participation of license
24 holders who are not being investigated or monitored by the
25 disciplining authority. License holders voluntarily participating in
26 the approved programs without being referred by the disciplining
27 authority shall not be subject to disciplinary action under RCW

39 opinion of the program, is unable to practice with reasonable skill
40 or safety. License holders shall report to the disciplining authority

1 if they fail to comply with this section or do not complete the
2 program's requirements. License holders may, upon the agreement of
3 the program and disciplining authority, reenter the program if they
4 have previously failed to comply with this section.

5 (4) Program records including, but not limited to, case notes,
6 progress notes, laboratory reports, evaluation and treatment records,
7 electronic and written correspondence within the program, and between
8 the program and the participant or other involved entities including,
9 but not limited to, employers, credentialing bodies, referents, or
10 other collateral sources, relating to license holders referred to or
11 voluntarily participating in approved programs are confidential and
12 exempt from disclosure under chapter 42.56 RCW and shall not be
13 subject to discovery by subpoena or admissible as evidence except:

14 (a) To defend any civil action by a license holder regarding the
15 restriction or revocation of that individual's clinical or staff
16 privileges, or termination of a license holder's employment. In such
17 an action, the program will, upon subpoena issued by either party to
18 the action, and upon the requesting party seeking a protective order
19 for the requested disclosure, provide to both parties of the action
20 written disclosure that includes the following information:

21 (i) Verification of a health care professional's participation in

23 monitoring program as it relates to aspects of program involvement at

4 climate active transportation account created in RCW 46.68.490, or
5 administering grants or programs funded by the accounts, agencies
6 shall conduct an environmental justice assessment consistent with the
7 requirements of RCW 70A.02.060 and establish a minimum of not less
8 than 35 percent and a goal of 40 percent of total investments that
9 provide direct and meaningful benefits to vulnerable populations
10 within the boundaries of overburdened communities through: (a) The
11 direct reduction of environmental burdens in overburdened
12 communities; (b) the reduction of disproportionate, cumulative risk
13 from environmental burdens, including those associated with climate
14 change; (c) the support of community led project development,
15 planning, and participation costs; or (d) meeting a community need
16 identified by the community that is consistent with the intent of
17 this chapter or RCW 70A.02.010.

18 (2) The allocation of funding under subsection (1) of this
19 section must adhere to the following principles, additional to the
20 requirements of RCW 70A.02.080: (a) Benefits and programs should be
21 directed to areas and targeted to vulnerable populations and
22 overburdened communities to reduce statewide disparities; (b)
23 investments and benefits should be made roughly proportional to the
24 health disparities that a specific community experiences, with a goal
25 of eliminating the disparities; (c) investments and programs should
26 focus on creating environmental benefits, including eliminating
27 health burdens, creating community and population resilience, and
28 raising the quality of life of those in the community; and (d)
29 efforts should be made to balance investments and benefits across the
30 state and within counties, local jurisdictions, and unincorporated
31 areas as appropriate to reduce disparities by location and to ensure
32 efforts contribute to a reduction in disparities that exist based on
33 race or ethnicity, socioeconomic status, or other factors.

34 (3) Except as provided in subsection (4) of this section, state
35 agencies allocating funds or administering grants or programs from
36 the carbon emissions reduction account created in RCW 70A.65.240, the
37 climate commitment account created in RCW 70A.65.260, the natural
38 climate solutions account created in RCW 70A.65.270, the climate
39 investment account created in RCW 70A.65.250, the air quality and
40 health disparities improvement account created in RCW 70A.65.280, the

1 climate transit programs account created in RCW 46.68.500, or the
2 climate active transportation account created in RCW 46.68.490, must:

3 (a) Report annually to the environmental justice council created
4 in RCW 70A.02.110 regarding progress toward meeting environmental
5 justice and environmental health goals;

6 (b) Consider recommendations by the environmental justice
7 council; and

8 (c)(i) If the agency is not a covered agency subject to the
9 requirements of chapter 70A.02 RCW, create and adopt a community
10 engagement plan to describe how it will engage with overburdened
11 communities and vulnerable populations in allocating funds or
12 administering grants or programs from the climate investment account.

13 (ii) The plan must include methods for outreach and communication
14 with those who face barriers, language or otherwise, to
15 participation.

16 (4) During the 2023-2025 fiscal biennium:

17 (a) The requirement of subsection (1) of this section to conduct
18 an environmental justice assessment applies only to covered agencies
19 as defined in RCW 70A.02.010 and to significant agency actions as
20 defined in RCW 70A.02.010.

21 (b) Agencies shall coordinate with the department and the office
22 of financial management to achieve total statewide spending from the
23 accounts listed in subsection (1) of this section of not less than 35
24 percent and a goal of 40 percent of total investments that provide
25 direct and meaningful benefits to vulnerable populations within the
26 boundaries of overburdened communities as otherwise described in
27 subsection (1)(a) through (d) of this section and in accordance with
28 RCW 70A.65.230.

29 (c) The requirements of subsection (3)(c) of this section for
30 agencies other than covered agencies to create and adopt community
31 engagement plans apply only to executive branch agencies and
32 institutions of higher education, as defined in RCW 28B.10.016,
33 receiving total appropriations of more than \$2,000,000 for the
34 2023-2025 fiscal biennium from the accounts listed in subsection (1)
35 of this section.

37 **CANNABIS TERMINOLOGY CONFORMING AMENDMENTS**

1 **Sec. 4001.** 2021 c 167 s 1 (uncodified) is amended to read as
2 follows:

3 (1) The legislature finds that student behavioral health issues
4 have become a crisis in Washington state, necessitating the
5 deployment of behavioral health resources in schools throughout the
6 state. The legislature's concerns are based on the following facts:

7 (a) According to the healthy youth survey conducted by the office
8 of the superintendent of public instruction in 2018, one in five
9 students in eighth, 10th, and 12th grades considered attempting
10 suicide in the past year while just half of those surveyed had an
11 adult to turn to when feeling sad or hopeless;

12 (b) According to the national institute for mental health, more
13 than one in 25 adolescents between 13 and 18 years of age are
14 experiencing an eating disorder;

15 (c) According to the national institute of drug abuse, nearly
16 half of 12th grade students have used illicit drugs, six in 10 have
17 drunk alcohol, and four in 10 have used (~~marijuana~~[cannabis])
18 cannabis;

19 (d) The COVID-19 pandemic has increased the prevalence of and
20 exacerbated existing behavioral health disorders for minors across
21 the state; and

22 (e) A major barrier to behavioral health support for minors is
23 lack of awareness and access to information about existing services.

24 (2) The legislature intends to require that contact information
25 for a suicide prevention organization, depression or anxiety support
26 organization, eating disorder support organization, substance abuse
27 support organization, and a mental health referral service for
28 children and teens be listed on the home page of each public school
29 website for the following reasons:

30 (a) Immediate access to behavioral health services often prevents
31 suicide, attempted suicide, and other self-harm; and

32 (b) Students in public schools often have access to and spend
33 time on the website for their school.

34 **Sec. 4002.** 2015 c 207 s 1 (uncodified) is amended to read as
35 follows:

36 The legislature intends to further the government-to-government
37 relationship between the state of Washington and federally recognized
38 Indian tribes in the state of Washington by authorizing the governor
39 to enter into agreements concerning the regulation of (~~marijuana~~

1 ~~[cannabis])~~) cannabis. Such agreements may include provisions
2 pertaining to: The lawful commercial production, processing, sale,
3 and possession of (~~(marijuana—[cannabis])~~) cannabis for both
4 recreational and medical purposes; (~~(marijuana—[cannabis])~~) cannabis-
5 related research activities; law enforcement, both criminal and
6 civil; and taxation. The legislature finds that these agreements will
7 facilitate and promote a cooperative and mutually beneficial
8 relationship between the state and the tribes regarding matters
9 relating to the legalization of (~~(marijuana—[cannabis])~~) cannabis,
10 particularly in light of the fact that federal Indian law precludes
11 the state from enforcing its civil regulatory laws in Indian country.
12 Such cooperative agreements will enhance public health and safety,
13 ensure a lawful and well-regulated (~~(marijuana—[cannabis])~~) cannabis
14 market, encourage economic development, and provide fiscal benefits
15 to both the tribes and the state.

16 **Sec. 4003.** 2015 c 70 s 2 (uncodified) is amended to read as
17 follows:

18 The legislature finds that since voters approved Initiative
19 Measure No. 692 in 1998, it has been the public policy of the state
20 to permit the medical use of (~~(marijuana—[cannabis])~~) cannabis.
21 Between 1998 and the present day, there have been multiple
22 legislative attempts to clarify what is meant by the medical use of
23 (~~(marijuana—[cannabis])~~) cannabis and to ensure qualifying patients
24 have a safe, consistent, and adequate source of (~~(marijuana~~
25 ~~[cannabis])~~) cannabis for their medical needs.

26 The legislature further finds that qualifying patients are people
27 with serious medical conditions and have been responsible for finding
28 their own source of (~~(marijuana—[cannabis])~~) cannabis for their own
29 personal medical use. Either by growing it themselves, designating
30 someone to grow for them, or participating in collective gardens,
31 patients have developed methods of access in spite of continued
32 federal opposition to the medical use of (~~(marijuana—[cannabis])~~)
33 cannabis. In a time when access itself was an issue and no safe,
34 consistent source of (~~(marijuana—[cannabis])~~) cannabis was available,
35 this unregulated system was permitted by the state to ensure some,
36 albeit limited, access to (~~(marijuana—[cannabis])~~) cannabis for
37 medical use. Also permitted were personal possession limits of
38 fifteen plants and twenty-four ounces of useable (~~(marijuana~~
39 ~~[cannabis])~~) cannabis, which was deemed to be the amount of

1 ((~~marijuana~~ [~~cannabis~~])) cannabis needed for a sixty-day supply. In a
2 time when supply was not consistent, this amount of ((~~marijuana~~
3 [~~cannabis~~])) cannabis was necessary to ensure patients would be able
4 to address their immediate medical needs.

5 The legislature further finds that while possession amounts are
6 provided in statute, these do not amount to protection from arrest
7 and prosecution for patients. In fact, patients in compliance with
8 state law are not provided arrest protection. They may be arrested
9 and their only remedy is to assert an affirmative defense at trial
10 that they are in compliance with the law and have a medical need. Too
11 many patients using ((~~marijuana~~ [~~cannabis~~])) cannabis for medical
12 purposes today do not know this; many falsely believe they cannot be
13 arrested so long as their health care provider has authorized them
14 for the medical use of ((~~marijuana~~ [~~cannabis~~])) cannabis.

15 The legislature further finds that in 2012 voters passed
16 Initiative Measure No. 502 which permitted the recreational use of
17 ((~~marijuana~~ [~~cannabis~~])) cannabis. For the first time in our nation's
18 history, ((~~marijuana~~ [~~cannabis~~])) cannabis would be regulated, taxed,
19 and sold for recreational consumption. Initiative Measure No. 502
20 provides for strict regulation on the production, processing, and
21 distribution of ((~~marijuana~~ [~~cannabis~~])) cannabis. Under Initiative
22 Measure No. 502, ((~~marijuana~~ [~~cannabis~~])) cannabis is trackable from
23 seed to sale and may only be sold or grown under license. ((~~Marijuana~~
24 [~~Cannabis~~])) Cannabis must be tested for impurities and purchasers of
25 ((~~marijuana~~ [~~cannabis~~])) cannabis must be informed of the THC level
26 in the ((~~marijuana~~ [~~cannabis~~])) cannabis. Since its passage, two
27 hundred fifty producer/processor licenses and sixty-three retail
28 licenses have been issued, covering the majority of the state. With
29 the current product canopy exceeding 2.9 million square feet, and
30 retailers in place, the state now has a system of safe, consistent,
31 and adequate access to ((~~marijuana~~ [~~cannabis~~])) cannabis; the
32 marketplace is not the same marketplace envisioned by the voters in
33 1998. While medical needs remain, the state is in the untenable
34 position of having a recreational product that is tested and subject
35 to production standards that ensure safe access for recreational
36 users. No such standards exist for medical users and, consequently,
37 the very people originally meant to be helped through the medical use
38 of ((~~marijuana~~ [~~cannabis~~])) cannabis do not know if their product has
39 been tested for molds, do not know where their ((~~marijuana~~
40 [~~cannabis~~])) cannabis has been grown, have no certainty in the level

1 of THC or CBD in their products, and have no assurances that their
2 products have been handled through quality assurance measures. It is
3 not the public policy of the state to allow qualifying patients to
4 only have access to products that may be endangering their health.

5 The legislature, therefore, intends to adopt a comprehensive act
6 that uses the regulations in place for the recreational market to
7 provide regulation for the medical use of ((~~marijuana~~—[~~cannabis~~]))
8 cannabis. It intends to ensure that patients retain their ability to
9 grow their own ((~~marijuana~~—[~~cannabis~~])) cannabis for their own
10 medical use and it intends to ensure that patients have the ability
11 to possess more ((~~marijuana~~—[~~cannabis~~])) cannabis-infused products,
12 useable ((~~marijuana~~—[~~cannabis~~])) cannabis, and ((~~marijuana~~
13 [~~cannabis~~])) cannabis concentrates than what is available to a
14 nonmedical user. It further intends that medical specific regulations
15 be adopted as needed and under consultation of the departments of
16 health and agriculture so that safe handling practices will be
17 adopted and so that testing standards for medical products meet or
18 exceed those standards in use in the recreational market.

19 The legislature further intends that the costs associated with
20 implementing and administering the medical ((~~marijuana~~—[~~cannabis~~]))
21 cannabis authorization database shall be financed from the health
22 professions account and that these funds shall be restored to the
23 health professions account through future appropriations using funds
24 derived from the dedicated ((~~marijuana~~—[~~cannabis~~])) cannabis account.

25 **Sec. 4004.** 2013 c 3 s 1 (uncodified) is amended to read as
26 follows:

27 The people intend to stop treating adult ((~~marijuana~~—[~~cannabis~~]))
28 cannabis use as a crime and try a new approach that:

29 (1) Allows law enforcement resources to be focused on violent and
30 property crimes;

31 (2) Generates new state and local tax revenue for education,
32 health care, research, and substance abuse prevention; and

33 (3) Takes ((~~marijuana~~—[~~cannabis~~])) cannabis out of the hands of
34 illegal drug organizations and brings it under a tightly regulated,
35 state-licensed system similar to that for controlling hard alcohol.

36 This measure authorizes the state liquor control board to
37 regulate and tax ((~~marijuana~~—[~~cannabis~~])) cannabis for persons
38 twenty-one years of age and older, and add a new threshold for
39 driving under the influence of ((~~marijuana~~—[~~cannabis~~])) cannabis.

1 **Sec. 4005.** 2017 c 317 s 12 (uncodified) is amended to read as
2 follows:

3 The legislature finds that protecting the state's children,
4 youth, and young adults under the legal age to purchase and consume
5 ((~~marijuana~~—[~~cannabis~~])) cannabis, by establishing limited
6 restrictions on the advertising of ((~~marijuana~~—[~~cannabis~~])) cannabis
7 and ((~~marijuana~~—[~~cannabis~~])) cannabis products, is necessary to
8 assist the state's efforts to discourage and prevent underage
9 consumption and the potential risks associated with underage
10 consumption. The legislature finds that these restrictions assist the
11 state in maintaining a strong and effective regulatory and
12 enforcement system as specified by the federal government. The
13 legislature finds this act leaves ample opportunities for licensed
14 ((~~marijuana~~—[~~cannabis~~])) cannabis businesses to market their products
15 to those who are of legal age to purchase them, without infringing on
16 the free speech rights of business owners. Finally, the legislature
17 finds that the state has a substantial and compelling interest in
18 enacting this act aimed at protecting Washington's children, youth,
19 and young adults.

20 **Sec. 4006.** 2015 2nd sp.s. c 4 s 101 (uncodified) is amended to
21 read as follows:

22 (1)(a) The legislature finds the implementation of Initiative
23 Measure No. 502 has established a clearly disadvantaged regulated
24 legal market with respect to prices and the ability to compete with
25 the unregulated medical dispensary market and the illicit market. The
26 legislature further finds that it is crucial that the state continues
27 to ensure a safe, highly regulated system in Washington that protects
28 valuable state revenues while continuing efforts towards disbanding
29 the unregulated ((~~marijuana~~—[~~cannabis~~])) cannabis markets. The
30 legislature further finds that ongoing evaluation on the impact of
31 meaningful ((~~marijuana~~—[~~cannabis~~])) cannabis tax reform for the
32 purpose of stabilizing revenues is crucial to the overall effort of
33 protecting the citizens and resources of this state. The legislature
34 further finds that a partnership with local jurisdictions in this
35 effort is imperative to the success of the legislature's policy
36 objective. The legislature further finds that sharing revenues to
37 promote a successful partnership in achieving the legislature's
38 intent should be transparent and hold local jurisdictions accountable
39 for their use of state shared revenues. Therefore, the legislature

1 intends to reform the current tax structure for the regulated legal
2 (~~marijuana~~[cannabis]) cannabis system to create price parity with
3 the large medical and illicit markets with the specific objective of
4 increasing the market share of the legal and highly regulated
5 (~~marijuana~~[cannabis]) cannabis market. The legislature further
6 intends to share (~~marijuana~~[cannabis]) cannabis tax revenues with
7 local jurisdictions for public safety purposes and to facilitate the
8 ongoing process of ensuring a safe regulated (~~marijuana~~[cannabis])
9 cannabis market in all communities across the state.

10 (b) The legislature further finds (~~marijuana~~[cannabis])
11 cannabis use for qualifying patients is a valid and necessary option
12 health care professionals may recommend for their patients. The
13 legislature further finds that while recognizing the difference
14 between recreational and medical use of (~~marijuana~~[cannabis])
15 cannabis, it is also imperative to distinguish that the authorization
16 for medical use of (~~marijuana~~[cannabis]) cannabis is different
17 from a valid prescription provided by a doctor to a patient. The
18 legislature further finds the authorization for medical use of
19 (~~marijuana~~[cannabis]) cannabis is unlike over-the-counter
20 medications that require no oversight by a health care professional.
21 The legislature further finds that due to the unique characterization
22 of authorizations for the medical use of (~~marijuana~~[cannabis])
23 cannabis, the policy of providing a tax preference benefit for
24 patients using an authorization should in no way be construed as
25 precedent for changes in the treatment of prescription medications or
26 over-the-counter medications. Therefore, the legislature intends to
27 provide qualifying patients and their designated providers a retail
28 sales and use tax exemption on (~~marijuana~~[cannabis]) cannabis
29 purchased or obtained for medical use when authorized by a health
30 care professional.

31 (2) (a) This subsection is the tax preference performance
32 statement for the retail sales and use tax exemption for (~~marijuana~~
33 ~~[cannabis]~~) cannabis purchased or obtained by qualifying patients or
34 their designated providers provided in RCW 82.08.9998(1) and
35 82.12.9998(1). The performance statement is only intended to be used
36 for subsequent evaluation of the tax preference. It is not intended
37 to create a private right of action by any party or be used to
38 determine eligibility for preferential tax treatment.

1 (b) The legislature categorizes the tax preference as one
2 intended to accomplish the general purposes indicated in RCW
3 82.32.808(2)(e).

4 (c) It is the legislature's specific public policy objective to
5 provide qualifying patients and their designated providers a retail
6 sales and use tax exemption on (~~marijuana~~[~~cannabis~~]) cannabis
7 purchased or obtained for medical use when authorized by a health
8 care professional.

9 (d) To measure the effectiveness of the exemption provided in
10 chapter 4, Laws of 2015 2nd sp. sess. in achieving the specific
11 public policy objective described in (c) of this subsection, the
12 department of revenue must provide the necessary data and assistance
13 to the state liquor and cannabis board for the report required in RCW
14 69.50.535.

15 **Sec. 4007.** 2020 c 236 s 1 (uncodified) is amended to read as
16 follows:

17 (1) The legislature finds that additional efforts are necessary
18 to reduce barriers to entry to the cannabis industry for individuals
19 and communities most adversely impacted by the enforcement of
20 cannabis-related laws. In the interest of establishing a cannabis
21 industry that is equitable and accessible to those most adversely
22 impacted by the enforcement of drug-related laws, including cannabis-
23 related laws, the legislature finds a social equity program should be
24 created.

25 (2) The legislature finds that individuals who have been arrested
26 or incarcerated due to drug laws, and those who have resided in areas
27 of high poverty, suffer long-lasting adverse consequences, including
28 impacts to employment, business ownership, housing, health, and long-
29 term financial well-being. The legislature also finds that family
30 members, especially children, and communities of those who have been
31 arrested or incarcerated due to drug laws, suffer from emotional,
32 psychological, and financial harms as a result of such arrests and
33 incarceration. The legislature further finds that individuals in
34 disproportionately impacted areas suffered the harms of enforcement
35 of cannabis-related laws. Those communities face greater difficulties
36 accessing traditional banking systems and capital for establishing
37 businesses.

38 (3) The legislature therefore finds that in the interest of
39 remedying harms resulting from the enforcement of cannabis-related

1 laws in disproportionately impacted areas, creating a social equity
2 program will further an equitable cannabis industry by promoting
3 business ownership among individuals who have resided in areas of
4 high poverty and high enforcement of cannabis-related laws. The
5 social equity program should offer, among other things, financial and
6 technical assistance and license application benefits to individuals
7 most directly and adversely impacted by the enforcement of cannabis-
8 related laws who are interested in starting cannabis business
9 enterprises. It is the intent of the legislature that implementation
10 of the social equity program authorized by this act not result in an
11 increase in the number of (~~marijuana~~~~[cannabis]~~) cannabis retailer
12 licenses above the limit on the number of (~~marijuana~~~~[cannabis]~~)
13 cannabis retailer licenses in the state established by the
14 (~~Washington state liquor and cannabis~~) Washington state liquor
15 and cannabis board before January 1, 2020.

16 **Sec. 4008.** 2020 c 133 s 1 (uncodified) is amended to read as
17 follows:

18 The legislature finds that recent reports of lung illnesses
19 associated with vapor products demand serious attention by the state
20 in the interest of protecting public health and preventing youth
21 access. While state law grants the liquor and cannabis board broad
22 authority to regulate vapor products containing (~~marijuana~~~~[cannabis]~~)
23 cannabis, the legislature finds that risks to public
24 health and youth access can be mitigated by clarifying that the board
25 is granted specific authority to prohibit the use of any additive,
26 solvent, ingredient, or compound in (~~marijuana~~~~[cannabis]~~) cannabis
27 vapor product production and processing and to prohibit any device
28 used in conjunction with a (~~marijuana~~~~[cannabis]~~) cannabis vapor
29 product.

30 **Sec. 4009.** 2019 c 393 s 1 (uncodified) is amended to read as
31 follows:

32 The legislature intends to allow additional information on the
33 labels and labeling of (~~marijuana~~~~[cannabis]~~) cannabis products to
34 assist consumers in making purchases of these products.

35 The legislature declares that labels and labeling should not make
36 any disease claim indicating the product is intended for use in the
37 diagnosis, treatment, cure, or prevention of any disease.

1 The legislature recognizes that it may be useful for a label or
2 labeling to describe the intended role of a (~~(marijuana-[cannabis])~~)
3 cannabis product that contains nutrients or other dietary
4 ingredients, including herbs and other botanicals, to maintain a
5 structure or function of the body, or characterize the documented
6 mechanism by which the product acts to maintain such structure or
7 function, provided that the claim is truthful and not misleading.

8 **Sec. 4010.** 2007 c 371 s 1 (uncodified) is amended to read as
9 follows:

10 The legislature intends to clarify the law on medical (~~(marijuana~~
11 ~~[cannabis])~~) cannabis so that the lawful use of this substance is not
12 impaired and medical practitioners are able to exercise their best
13 professional judgment in the delivery of medical treatment,
14 qualifying patients may fully participate in the medical use of
15 (~~(marijuana-[cannabis])~~) cannabis, and designated providers may
16 assist patients in the manner provided by this act without fear of
17 state criminal prosecution. This act is also intended to provide
18 clarification to law enforcement and to all participants in the
19 judicial system.

21 **NURSING TERMINOLOGY CONFORMING AMENDMENTS**

22 **Sec. 5001.** RCW 18.20.230 and 2012 c 10 s 15 are each amended to
23 read as follows:

24 (1) The department of social and health services shall review, in
25 coordination with the department of health, the (~~(nursing-care~~
26 ~~quality-assurance-commission)~~) state board of nursing, adult family
27 home providers, assisted living facility providers, in-home personal
28 care providers, and long-term care consumers and advocates, training
29 standards for administrators and resident caregiving staff. Any
30 proposed enhancements shall be consistent with this section, shall
31 take into account and not duplicate other training requirements
32 applicable to assisted living facilities and staff, and shall be
33 developed with the input of assisted living facility and resident
34 representatives, health care professionals, and other vested interest
35 groups. Training standards and the delivery system shall be relevant
36 to the needs of residents served by the assisted living facility and
37 recipients of long-term in-home personal care services and shall be

1 sufficient to ensure that administrators and caregiving staff have
2 the skills and knowledge necessary to provide high quality,
3 appropriate care.

4 (2) The recommendations on training standards and the delivery
5 system developed under subsection (1) of this section shall be based
6 on a review and consideration of the following: Quality of care;
7 availability of training; affordability, including the training costs
8 incurred by the department of social and health services and private
9 providers; portability of existing training requirements; competency
10 testing; practical and clinical coursework; methods of delivery of
11 training; standards for management and caregiving staff training; and
12 necessary enhancements for special needs populations and resident
13 rights training. Residents with special needs include, but are not
14 limited to, residents with a diagnosis of mental illness, dementia,
15 or developmental disability.

16 **Sec. 5002.** RCW 18.50.032 and 1994 sp.s. c 9 s 704 are each
17 amended to read as follows:

18 Registered nurses and nurse midwives certified by the (~~nursing~~
19 ~~care quality assurance commission~~) state board of nursing under
20 chapter 18.79 RCW shall be exempt from the requirements and
21 provisions of this chapter.

22 **Sec. 5003.** RCW 18.79.010 and 1994 sp.s. c 9 s 401 are each
23 amended to read as follows:

24 It is the purpose of the (~~nursing care quality assurance~~

21 read as follows:

22 (1) A registered nurse under his or her license may perform for
23 compensation nursing care, as that term is usually understood, to
24 individuals with illnesses, injuries, or disabilities.

25 (2) A registered nurse may, at or under the general direction of
26 a licensed physician and surgeon, dentist, osteopathic physician and

34 assistance to state crime victim compensation programs. The federal
35 funds shall be deposited in the state general fund and may be
36 expended only for purposes authorized by applicable federal law.

37 (2) The director shall:

38 (a) Establish and adopt rules governing the administration of
39 this chapter in accordance with chapter 34.05 RCW;

1 (b) Regulate the proof of accident and extent thereof, the proof
2 of death, and the proof of relationship and the extent of dependency;

3 (c) Supervise the medical, surgical, and hospital treatment to
4 the intent that it may be in all cases efficient and up to the
5 recognized standard of modern surgery;

6 (d) Issue proper receipts for moneys received and certificates
7 for benefits accrued or accruing;

8 (e) Designate a medical director who is licensed under chapter
9 18.57 or 18.71 RCW;

10 (f) Supervise the providing of prompt and efficient care and
11 treatment, including care provided by physician assistants governed
12 by the provisions of chapter 18.71A RCW, including chiropractic care,
13 and including care provided by licensed advanced (~~registered nurse~~
14 ~~practitioners~~) practice registered nurses, to victims at the least
15 cost consistent with promptness and efficiency, without
16 discrimination or favoritism, and with as great uniformity as the
17 various and diverse surrounding circumstances and locations of
18 industries will permit and to that end shall, from time to time,
19 establish and adopt and supervise the administration of printed
20 forms, electronic communications, rules, regulations, and practices
21 for the furnishing of such care and treatment. The medical coverage
22 decisions of the department do not constitute a "rule" as used in RCW
23 34.05.010(16), nor are such decisions subject to the rule-making
24 provisions of chapter 34.05 RCW except that criteria for establishing

18 (i) If the department, using caseload estimates, projects a
19 deficit in funding for the program by July 15th for the following
20 fiscal year, the director shall notify the governor and the
21 appropriate committees of the legislature and request funding
22 sufficient to continue payments to not less than payments provided
23 for comparable services under the workers' compensation program. If
24 sufficient funding is not provided to continue payments to not less
25 than payments provided for comparable services under the workers'
26 compensation program, the director shall reduce the payments under
27 the fee schedule for the following fiscal year based on caseload
28 estimates and available funding, except payments may not be reduced
29 to less than seventy percent of payments for comparable services
30 under the workers' compensation program;

31 (ii) If an unforeseeable catastrophic event results in
32 insufficient funding to continue payments to not less than payments
33 provided for comparable services under the workers' compensation
34 program, the director shall reduce the payments under the fee
35 schedule to not less than seventy percent of payments provided for

37 that the reduction may not be more than necessary to fund benefits
38 under the program; and

12 (a) Have power to issue subpoenas to enforce the attendance and

15 connection with any claim made to the department or any billing
16 submitted to the department. The superior court has the power to
17 enforce any such subpoena by proper proceedings;

18 (b) (i) May apply for and obtain a superior court order approving
19 and authorizing a subpoena in advance of its issuance. The
20 application may be made in the county where the subpoenaed person
21 resides or is found, or the county where the subpoenaed records or
22 documents are located, or in Thurston county. The application must
23 (A) state that an order is sought pursuant to this subsection; (B)
24 adequately specify the records, documents, or testimony; and (C)
25 declare under oath that an investigation is being conducted for a
26 lawfully authorized purpose related to an investigation within the
27 department's authority and that the subpoenaed documents or testimony
28 are reasonably related to an investigation within the department's
29 authority.

30 (ii) Where the application under this subsection (3) (b) is made
31 to the satisfaction of the court, the court must issue an order
32 approving the subpoena. An order under this subsection constitutes
33 authority of law for the agency to subpoena the records or testimony.

34 (iii) The director and his or her authorized assistants may seek
35 approval and a court may issue an order under this subsection without
36 prior notice to any person, including the person to whom the subpoena
37 is directed and the person who is the subject of an investigation.

38 (4) In all hearings, actions, or proceedings before the
39 department, any physician or licensed advanced (~~registered nurse~~
40 ~~practitioner~~) practice registered nurse having theretofore examined

1 or treated the claimant may be required to testify fully regarding
2 such examination or treatment, and shall not be exempt from so
3 testifying by reason of the relation of the physician or licensed
4 advanced (~~registered nurse practitioner~~) practice registered nurse
5 to the patient.

39 "Distribute" also includes causing a firearm or large capacity
40 magazine to be delivered in this state.

1 (12) "Domestic violence" has the same meaning as provided in RCW
2 10.99.020.

3 (13) "Family or household member" has the same meaning as in RCW
4 7.105.010.

5 (14) "Federal firearms dealer" means a licensed dealer as defined
6 in 18 U.S.C. Sec. 921(a)(11).

7 (15) "Federal firearms importer" means a licensed importer as
8 defined in 18 U.S.C. Sec. 921(a)(9).

9 (16) "Federal firearms manufacturer" means a licensed
10 manufacturer as defined in 18 U.S.C. Sec. 921(a)(10).

11 (17) "Felony" means any felony offense under the laws of this
12 state or any federal or out-of-state offense comparable to a felony
13 offense under the laws of this state.

14 (18) "Felony firearm offender" means a person who has previously
15 been convicted or found not guilty by reason of insanity in this
16 state of any felony firearm offense. A person is not a felony firearm
17 offender under this chapter if any and all qualifying offenses have
18 been the subject of an expungement, pardon, annulment, certificate,
19 or rehabilitation, or other equivalent procedure based on a finding
20 of the rehabilitation of the person convicted or a pardon, annulment,
21 or other equivalent procedure based on a finding of innocence.

22 (19) "Felony firearm offense" means:

23 (a) Any felony offense that is a violation of this chapter;

24 (b) A violation of RCW 9A.36.045;

25 (c) A violation of RCW 9A.56.300;

26 (d) A violation of RCW 9A.56.310;

27 (e) Any felony offense if the offender was armed with a firearm
28 in the commission of the offense.

29 (20) "Firearm" means a weapon or device from which a projectile
30 or projectiles may be fired by an explosive such as gunpowder. For
31 the purposes of RCW 9.41.040, "firearm" also includes frames and
32 receivers. "Firearm" does not include a flare gun or other
33 pyrotechnic visual distress signaling device, or a powder-actuated
34 tool or other device designed solely to be used for construction
35 purposes.

36 (21)(a) "Frame or receiver" means a part of a firearm that, when
37 the complete firearm is assembled, is visible from the exterior and
38 provides housing or a structure designed to hold or integrate one or
39 more fire control components, even if pins or other attachments are
40 required to connect the fire control components. Any such part

1 identified with a serial number shall be presumed, absent an official
2 determination by the bureau of alcohol, tobacco, firearms, and
3 explosives or other reliable evidence to the contrary, to be a frame
4 or receiver.

5 (b) For purposes of this subsection, "fire control component"
6 means a component necessary for the firearm to initiate, complete, or
7 continue the firing sequence, including any of the following: Hammer,
8 bolt, bolt carrier, breechblock, cylinder, trigger mechanism, firing
9 pin, striker, or slide rails.

10 (22) "Gun" has the same meaning as firearm.

11 (23) "Import" means to move, transport, or receive an item from a
12 place outside the territorial limits of the state of Washington to a
13 place inside the territorial limits of the state of Washington.
14 "Import" does not mean situations where an individual possesses a
15 large capacity magazine or assault weapon when departing from, and
16 returning to, Washington state, so long as the individual is
17 returning to Washington in possession of the same large capacity
18 magazine or assault weapon the individual transported out of state.

19 (24) "Intimate partner" has the same meaning as provided in RCW
20 7.105.010.

21 (25) "Large capacity magazine" means an ammunition feeding device
22 with the capacity to accept more than 10 rounds of ammunition, or any
23 conversion kit, part, or combination of parts, from which such a
24 device can be assembled if those parts are in possession of or under
25 the control of the same person, but shall not be construed to include
26 any of the following:

27 (a) An ammunition feeding device that has been permanently
28 altered so that it cannot accommodate more than 10 rounds of
29 ammunition;

30 (b) A 22 caliber tube ammunition feeding device; or

31 (c) A tubular magazine that is contained in a lever-action
32 firearm.

33 (26) "Law enforcement officer" includes a general authority
34 Washington peace officer as defined in RCW 10.93.020, or a specially
35 commissioned Washington peace officer as defined in RCW 10.93.020.
36 "Law enforcement officer" also includes a limited authority
37 Washington peace officer as defined in RCW 10.93.020 if such officer
38 is duly authorized by his or her employer to carry a concealed
39 pistol.

1 (27) "Lawful permanent resident" has the same meaning afforded a
2 person "lawfully admitted for permanent residence" in 8 U.S.C. Sec.
3 1101(a)(20).

4 (28) "Licensed collector" means a person who is federally
5 licensed under 18 U.S.C. Sec. 923(b).

6 (29) "Licensed dealer" means a person who is federally licensed
7 under 18 U.S.C. Sec. 923(a).

8 (30) "Loaded" means:

9 (a) There is a cartridge in the chamber of the firearm;

10 (b) Cartridges are in a clip that is locked in place in the
11 firearm;

12 (c) There is a cartridge in the cylinder of the firearm, if the
13 firearm is a revolver;

14 (d) There is a cartridge in the tube or magazine that is inserted
15 in the action; or

16 (e) There is a ball in the barrel and the firearm is capped or
17 primed if the firearm is a muzzle loader.

18 (31) "Machine gun" means any firearm known as a machine gun,
19 mechanical rifle, submachine gun, or any other mechanism or
20 instrument not requiring that the trigger be pressed for each shot
21 and having a reservoir clip, disc, drum, belt, or other separable
22 mechanical device for storing, carrying, or supplying ammunition
23 which can be loaded into the firearm, mechanism, or instrument, and
24 fired therefrom at the rate of five or more shots per second.

25 (32) "Manufacture" means, with respect to a firearm or large
26 capacity magazine, the fabrication, making, formation, production, or
27 construction of a firearm or large capacity magazine, by manual labor
28 or by machinery.

29 (33) "Mental health professional" means a psychiatrist,
30 psychologist, or physician assistant working with a psychiatrist who
31 is acting as a participating physician as defined in RCW 18.71A.010,
32 psychiatric advanced ((~~registered nurse practitioner~~)) practice
33 registered nurse, psychiatric nurse, social worker, mental health
34 counselor, marriage and family therapist, or such other mental health
35 professionals as may be defined in statute or by rules adopted by the
36 department of health pursuant to the provisions of chapter 71.05 RCW.

37 (34) "Nonimmigrant alien" means a person defined as such in 8
38 U.S.C. Sec. 1101(a)(15).

1 (35) "Person" means any individual, corporation, company,
2 association, firm, partnership, club, organization, society, joint
3 stock company, or other legal entity.

4 (36) "Pistol" means any firearm with a barrel less than 16 inches
5 in length, or is designed to be held and fired by the use of a single
6 hand.

7 (37) "Rifle" means a weapon designed or redesigned, made or
8 remade, and intended to be fired from the shoulder and designed or
9 redesigned, made or remade, and intended to use the energy of the
10 explosive in a fixed metallic cartridge to fire only a single
11 projectile through a rifled bore for each single pull of the trigger.

12 (38) "Sale" and "sell" mean the actual approval of the delivery
13 of a firearm in consideration of payment or promise of payment.

14 (39) "Secure gun storage" means:

15 (a) A locked box, gun safe, or other secure locked storage space
16 that is designed to prevent unauthorized use or discharge of a
17 firearm; and

18 (b) The act of keeping an unloaded firearm stored by such means.

19 (40) "Semiautomatic" means any firearm which utilizes a portion
20 of the energy of a firing cartridge to extract the fired cartridge
21 case and chamber the next round, and which requires a separate pull
22 of the trigger to fire each cartridge.

23 (41)(a) "Semiautomatic assault rifle" means any rifle which
24 utilizes a portion of the energy of a firing cartridge to extract the
25 fired cartridge case and chamber the next round, and which requires a
26 separate pull of the trigger to fire each cartridge.

27 (b) "Semiautomatic assault rifle" does not include antique
28 firearms, any firearm that has been made permanently inoperable, or
29 any firearm that is manually operated by bolt, pump, lever, or slide
30 action.

31 (42) "Serious offense" means any of the following felonies or a
32 felony attempt to commit any of the following felonies, as now
33 existing or hereafter amended:

34 (a) Any crime of violence;

35 (b) Any felony violation of the uniform controlled substances
36 act, chapter 69.50 RCW, that is classified as a class B felony or
37 that has a maximum term of imprisonment of at least 10 years;

38 (c) Child molestation in the second degree;

39 (d) Incest when committed against a child under age 14;

40 (e) Indecent liberties;

- 1 (f) Leading organized crime;
- 2 (g) Promoting prostitution in the first degree;
- 3 (h) Rape in the third degree;
- 4 (i) Drive-by shooting;
- 5 (j) Sexual exploitation;
- 6 (k) Vehicular assault, when caused by the operation or driving of
7 a vehicle by a person while under the influence of intoxicating
8 liquor or any drug or by the operation or driving of a vehicle in a
9 reckless manner;
- 10 (l) Vehicular homicide, when proximately caused by the driving of
11 any vehicle by any person while under the influence of intoxicating
12 liquor or any drug as defined by RCW 46.61.502, or by the operation
13 of any vehicle in a reckless manner;
- 14 (m) Any other class B felony offense with a finding of sexual
15 motivation, as "sexual motivation" is defined under RCW 9.94A.030;
- 16 (n) Any other felony with a deadly weapon verdict under RCW
17 9.94A.825;
- 18 (o) Any felony offense in effect at any time prior to June 6,
19 1996, that is comparable to a serious offense, or any federal or out-
20 of-state conviction for an offense that under the laws of this state
21 would be a felony classified as a serious offense;
- 22 (p) Any felony conviction under RCW 9.41.115; or
- 23 (q) Any felony charged under RCW 46.61.502(6) or 46.61.504(6).
- 24 (43) "Sex offense" has the same meaning as provided in RCW
25 9.94A.030.
- 26 (44) "Short-barreled rifle" means a rifle having one or more
27 barrels less than 16 inches in length and any weapon made from a
28 rifle by any means of modification if such modified weapon has an
29 overall length of less than 26 inches.
- 30 (45) "Short-barreled shotgun" means a shotgun having one or more
31 barrels less than 18 inches in length and any weapon made from a
32 shotgun by any means of modification if such modified weapon has an
33 overall length of less than 26 inches.
- 34 (46) "Shotgun" means a weapon with one or more barrels, designed
35 or redesigned, made or remade, and intended to be fired from the
36 shoulder and designed or redesigned, made or remade, and intended to
37 use the energy of the explosive in a fixed shotgun shell to fire
38 through a smooth bore either a number of ball shot or a single
39 projectile for each single pull of the trigger.

1 (47) "Substance use disorder professional" means a person
2 certified under chapter 18.205 RCW.

3 (48) "Transfer" means the intended delivery of a firearm to
4 another person without consideration of payment or promise of payment
5 including, but not limited to, gifts and loans. "Transfer" does not
6 include the delivery of a firearm owned or leased by an entity
7 licensed or qualified to do business in the state of Washington to,
8 or return of such a firearm by, any of that entity's employees or
9 agents, defined to include volunteers participating in an honor
10 guard, for lawful purposes in the ordinary course of business.

11 (49) "Undetectable firearm" means any firearm that is not as
12 detectable as 3.7 ounces of 17-4 PH stainless steel by walk-through
13 metal detectors or magnetometers commonly used at airports or any
14 firearm where the barrel, the slide or cylinder, or the frame or
15 receiver of the firearm would not generate an image that accurately
16 depicts the shape of the part when examined by the types of X-ray
17 machines commonly used at airports.

18 (50)(a) "Unfinished frame or receiver" means a frame or receiver
19 that is partially complete, disassembled, or inoperable, that: (i)
20 Has reached a stage in manufacture where it may readily be completed,
21 assembled, converted, or restored to a functional state; or (ii) is
22 marketed or sold to the public to become or be used as the frame or
23 receiver of a functional firearm once finished or completed,
24 including without limitation products marketed or sold to the public
25 as an 80 percent frame or receiver or unfinished frame or receiver.

26 (b) For purposes of this subsection:

27 (i) "Readily" means a process that is fairly or reasonably
28 efficient, quick, and easy, but not necessarily the most efficient,
29 speedy, or easy process. Factors relevant in making this
30 determination, with no single one controlling, include the following:
31 (A) Time, i.e., how long it takes to finish the process; (B) ease,
32 i.e., how difficult it is to do so; (C) expertise, i.e., what
33 knowledge and skills are required; (D) equipment, i.e., what tools
34 are required; (E) availability, i.e., whether additional parts are
35 required, and how easily they can be obtained; (F) expense, i.e., how
36 much it costs; (G) scope, i.e., the extent to which the subject of
37 the process must be changed to finish it; and (H) feasibility, i.e.,
38 whether the process would damage or destroy the subject of the
39 process, or cause it to malfunction.

1 (ii) "Partially complete," as it modifies frame or receiver,
2 means a forging, casting, printing, extrusion, machined body, or
3 similar article that has reached a stage in manufacture where it is
4 clearly identifiable as an unfinished component part of a firearm.

5 (51) "Unlicensed person" means any person who is not a licensed
6 dealer under this chapter.

7 (52) "Untraceable firearm" means any firearm manufactured after
8 July 1, 2019, that is not an antique firearm and that cannot be
9 traced by law enforcement by means of a serial number affixed to the
10 firearm by a federal firearms manufacturer, federal firearms
11 importer, or federal firearms dealer in compliance with all federal
12 laws and regulations.

13 (53) "Washington state patrol firearms background check program"
14 means the division within the state patrol that conducts background
15 checks for all firearm transfers and the disposition of firearms.

16 **Sec. 5065.** RCW 10.77.010 and 2023 c 453 s 2 and 2023 c 120 s 5
17 are each reenacted and amended to read as follows:

18 As used in this chapter:

19 (1) "Admission" means acceptance based on medical necessity, of a
20 person as a patient.

21 (2) "Authority" means the Washington state health care authority.

22 (3) "Clinical intervention specialist" means a licensed
23 professional with prescribing authority who is employed by or
24 contracted with the department to provide direct services, enhanced
25 oversight and monitoring of the behavioral health status of in-
26 custody defendants who have been referred for evaluation or
27 restoration services related to competency to stand trial and who
28 coordinate treatment options with forensic navigators, the
29 department, and jail health services.

30 (4) "Commitment" means the determination by a court that a person
31 should be detained for a period of either evaluation or treatment, or

34 "licensed or certified behavioral health agency" defined in RCW
35 71.24.025.

36 (6) "Conditional release" means modification of a court-ordered
37 commitment, which may be revoked upon violation of any of its terms.

38 (7) A "criminally insane" person means any person who has been
39 acquitted of a crime charged by reason of insanity, and thereupon

1 found to be a substantial danger to other persons or to present a
2 substantial likelihood of committing criminal acts jeopardizing
3 public safety or security unless kept under further control by the
4 court or other persons or institutions.

5 (8) "Department" means the state department of social and health
6 services.

7 (9) "Designated crisis responder" has the same meaning as
8 provided in RCW 71.05.020.

9 (10) "Detention" or "detain" means the lawful confinement of a
10 person, under the provisions of this chapter, pending evaluation.

11 (11) "Developmental disabilities professional" means a person who
12 has specialized training and experience in directly treating or
13 working with persons with developmental disabilities and is a
14 psychiatrist or psychologist, or a social worker, and such other
15 developmental disabilities professionals as may be defined by rules
16 adopted by the secretary.

17 (12) "Developmental disability" means the condition as defined in
18 RCW 71A.10.020.

19 (13) "Discharge" means the termination of hospital medical
20 authority. The commitment may remain in place, be terminated, or be
21 amended by court order.

22 (14) "Furlough" means an authorized leave of absence for a
23 resident of a state institution operated by the department designated
24 for the custody, care, and treatment of the criminally insane,
25 consistent with an order of conditional release from the court under
26 this chapter, without any requirement that the resident be
27 accompanied by, or be in the custody of, any law enforcement or
28 institutional staff, while on such unescorted leave.

29 (15) "Genuine doubt as to competency" means that there is
30 reasonable cause to believe, based upon actual interactions with or
31 observations of the defendant or information provided by counsel,
32 that a defendant is incompetent to stand trial.

33 (16) "Habilitative services" means those services provided by
34 program personnel to assist persons in acquiring and maintaining life
35 skills and in raising their levels of physical, mental, social, and
36 vocational functioning. Habilitative services include education,
37 training for employment, and therapy. The habilitative process shall
38 be undertaken with recognition of the risk to the public safety
39 presented by the person being assisted as manifested by prior charged
40 criminal conduct.

1 (17) "History of one or more violent acts" means violent acts
2 committed during: (a) The 10-year period of time prior to the filing
3 of criminal charges; plus (b) the amount of time equal to time spent
4 during the 10-year period in a mental health facility or in
5 confinement as a result of a criminal conviction.

6 (18) "Immediate family member" means a spouse, child, stepchild,
7 parent, stepparent, grandparent, sibling, or domestic partner.

8 (19) "Incompetency" means a person lacks the capacity to
9 understand the nature of the proceedings against him or her or to
10 assist in his or her own defense as a result of mental disease or
11 defect.

12 (20) "Indigent" means any person who is indigent as defined in
13 RCW 10.101.010, or financially unable to obtain counsel or other
14 necessary expert or professional services without causing substantial
15 hardship to the person or his or her family.

16 (21) "Individualized service plan" means a plan prepared by a
17 developmental disabilities professional with other professionals as a
18 team, for an individual with developmental disabilities, which shall
19 state:

20 (a) The nature of the person's specific problems, prior charged
21 criminal behavior, and habilitation needs;

22 (b) The conditions and strategies necessary to achieve the
23 purposes of habilitation;

24 (c) The intermediate and long-range goals of the habilitation
25 program, with a projected timetable for the attainment;

26 (d) The rationale for using this plan of habilitation to achieve
27 those intermediate and long-range goals;

28 (e) The staff responsible for carrying out the plan;

29 (f) Where relevant in light of past criminal behavior and due
30 consideration for public safety, the criteria for proposed movement
31 to less-restrictive settings, criteria for proposed eventual release,
32 and a projected possible date for release; and

33 (g) The type of residence immediately anticipated for the person
34 and possible future types of residences.

35 (22) "Professional person" means:

36 (a) A psychiatrist licensed as a physician and surgeon in this
37 state who has, in addition, completed three years of graduate
38 training in psychiatry in a program approved by the American medical
39 association or the American osteopathic association and is certified
40 or eligible to be certified by the American board of psychiatry and

1 neurology or the American osteopathic board of neurology and
2 psychiatry;

3 (b) A psychologist licensed as a psychologist pursuant to chapter
4 18.83 RCW;

5 (c) A psychiatric advanced (~~registered nurse practitioner~~)
6 practice registered nurse, as defined in RCW 71.05.020; or

7 (d) A social worker with a master's or further advanced degree
8 from a social work educational program accredited and approved as
9 provided in RCW 18.320.010.

10 (23) "Release" means legal termination of the court-ordered
11 commitment under the provisions of this chapter.

12 (24) "Secretary" means the secretary of the department of social
13 and health services or his or her designee.

14 (25) "Treatment" means any currently standardized medical or
15 mental health procedure including medication.

16 (26) "Treatment records" include registration and all other
17 records concerning persons who are receiving or who at any time have
18 received services for mental illness, which are maintained by the
19 department, by behavioral health administrative services
20 organizations and their staffs, by managed care organizations and
21 their staffs, and by treatment facilities. Treatment records do not
22 include notes or records maintained for personal use by a person
23 providing treatment services for the department, behavioral health
24 administrative services organizations, managed care organizations, or
25 a treatment facility if the notes or records are not available to
26 others.

27 (27) "Violent act" means behavior that: (a) (i) Resulted in; (ii)
28 if completed as intended would have resulted in; or (iii) was
29 threatened to be carried out by a person who had the intent and
30 opportunity to carry out the threat and would have resulted in,
31 homicide, nonfatal injuries, or substantial damage to property; or
32 (b) recklessly creates an immediate risk of serious physical injury
33 to another person. As used in this subsection, "nonfatal injuries"
34 means physical pain or injury, illness, or an impairment of physical
35 condition. "Nonfatal injuries" shall be construed to be consistent
36 with the definition of "bodily injury," as defined in RCW 9A.04.110.

1 (1) Conditional release planning should start at admission and
2 proceed in coordination between the department and the person's
3 managed care organization, or behavioral health administrative
4 services organization if the person is not eligible for medical
5 assistance under chapter 74.09 RCW. If needed, the department shall
6 assist the person to enroll in medical assistance in suspense status
7 under RCW 74.09.670. The state hospital liaison for the managed care
8 organization or behavioral health administrative services
9 organization shall facilitate conditional release planning in

11 (2) Less restrictive alternative treatment pursuant to a
12 conditional release order, at a minimum, includes the following

14 (a) Assignment of a care coordinator;

18 evaluation, or both;

19 (d) A schedule of regular contacts with the provider of the less

25 (g) Consultation about the formation of a mental health advance
26 directive under chapter 71.32 RCW;

27 (h) Appointment of a transition team under RCW 10.77.150; and

28 (i) Notification to the care coordinator assigned in (a) of this
29 subsection and to the transition team as provided in RCW 10.77.150 if
30 reasonable efforts to engage the client fail to produce substantial
31 compliance with court-ordered treatment conditions.

32 (3) Less restrictive alternative treatment pursuant to a
33 conditional release order may additionally include requirements to
34 participate in the following services:

35 (a) Medication management;

36 (b) Psychotherapy;

37 (c) Nursing;

38 (d) Substance use disorder counseling;

39 (e) Residential treatment;

40 (f) Partial hospitalization;

1 (g) Intensive outpatient treatment;

2 (h) Support for housing, benefits, education, and employment; and

3 (i) Periodic court review.

4 (4) Nothing in this section prohibits items in subsection (2) of
5 this section from beginning before the conditional release of the
6 individual.

7 (5) If the person was provided with involuntary medication under
8 RCW 10.77.094 or pursuant to a judicial order during the involuntary
9 commitment period, the less restrictive alternative treatment
10 pursuant to the conditional release order may authorize the less
11 restrictive alternative treatment provider or its designee to
12 administer involuntary antipsychotic medication to the person if the
13 provider has attempted and failed to obtain the informed consent of
14 the person and there is a concurring medical opinion approving the
15 medication by a psychiatrist, physician assistant working with a
16 psychiatrist who is acting as a participating physician as defined in
17 RCW 18.71A.010, psychiatric advanced (~~registered—nurse~~
18 ~~practitioner~~) practice registered nurse, or physician or physician
19 assistant in consultation with an independent mental health
20 professional with prescribing authority.

21 (6) Less restrictive alternative treatment pursuant to a
22 conditional release order must be administered by a provider that is
23 certified or licensed to provide or coordinate the full scope of
24 services required under the less restrictive alternative order and
25 that has agreed to assume this responsibility.

26 (7) The care coordinator assigned to a person ordered to less
27 restrictive alternative treatment pursuant to a conditional release
28 order must submit an individualized plan for the person's treatment
29 services to the court that entered the order. An initial plan must be
30 submitted as soon as possible following the intake evaluation and a
31 revised plan must be submitted upon any subsequent modification in
32 which a type of service is removed from or added to the treatment
33 plan.

34 (8) A care coordinator may disclose information and records
35 related to mental health treatment under RCW 70.02.230(2)(k) for
36 purposes of implementing less restrictive alternative treatment
37 pursuant to a conditional release order.

38 (9) For the purpose of this section, "care coordinator" means a
39 representative from the department of social and health services who
40 coordinates the activities of less restrictive alternative treatment

1 pursuant to a conditional release order. The care coordinator
2 coordinates activities with the person's transition team that are
3 necessary for enforcement and continuation of the conditional release
4 order and is responsible for coordinating service activities with
5 other agencies and establishing and maintaining a therapeutic
6 relationship with the individual on a continuing basis.

8 (III) Such individual is customarily engaged in an independently
9 established trade, occupation, profession, or business, of the same

28 (E) On the effective date of the contract of service, or within a
29 reasonable period after the effective date of the contract, the
30 individual has an active and valid certificate of registration with
31 the department of revenue, and an active and valid account with any

20 (20) "Premium" or "premiums" means the payments required by RCW
21 50A.10.030 and paid to the department for deposit in the family and

23 (21) "Qualifying period" means the first four of the last five
24 completed calendar quarters or, if eligibility is not established,
25 the last four completed calendar quarters immediately preceding the
26 application for leave.

27 (22)(a) "Remuneration" means all compensation paid for personal
28 services including commissions and bonuses and the cash value of all
29 compensation paid in any medium other than cash.

30 (b) Previously accrued compensation, other than severance pay or
31 payments received pursuant to plant closure agreements, when assigned
32 to a specific period of time by virtue of a collective bargaining
33 agreement, individual employment contract, customary trade practice,

14 (23)(a) "Serious health condition" means an illness, injury,
15 impairment, or physical or mental condition that involves:

16 (i) Inpatient care in a hospital, hospice, or residential medical
17 care facility, including any period of incapacity; or

18 (ii) Continuing treatment by a health care provider. A serious
19 health condition involving continuing treatment by a health care
20 provider includes any one or more of the following:

21 (A) A period of incapacity of more than three consecutive, full
22 calendar days, and any subsequent treatment or period of incapacity
23 relating to the same condition, that also involves:

24 (I) Treatment two or more times, within thirty days of the first
25 day of incapacity, unless extenuating circumstances exist, by a
26 health care provider, by a nurse or physician's assistant under
27 direct supervision of a health care provider, or by a provider of
28 health care services, such as a physical therapist, under orders of,
29 or on referral by, a health care provider; or

30 (II) Treatment by a health care provider on at least one occasion
31 which results in a regimen of continuing treatment under the
32 supervision of the health care provider;

33 (B) Any period of incapacity due to pregnancy, or for prenatal
34 care;

35 (C) Any period of incapacity or treatment for such incapacity due
36 to a chronic serious health condition. A chronic serious health
37 condition is one which:

38 (I) Requires periodic visits, defined as at least twice a year,
39 for treatment by a health care provider, or by a nurse under direct
40 supervision of a health care provider;

1 (II) Continues over an extended period of time, including
2 recurring episodes of a single underlying condition; and

3 (III) May cause episodic rather than a continuing period of
4 incapacity, including asthma, diabetes, and epilepsy;

5 (D) A period of incapacity which is permanent or long term due to
6 a condition for which treatment may not be effective. The employee or
7 family member must be under the continuing supervision of, but need
8 not be receiving active treatment by, a health care provider,
9 including Alzheimer's, a severe stroke, or the terminal stages of a
10 disease; or

11 (E) Any period of absence to receive multiple treatments,
12 including any period of recovery from the treatments, by a health
13 care provider or by a provider of health care services under orders
14 of, or on referral by, a health care provider, either for: (I)
15 Restorative surgery after an accident or other injury; or (II) a
16 condition that would likely result in a period of incapacity of more
17 than three consecutive, full calendar days in the absence of medical
18 intervention or treatment, such as cancer, severe arthritis, or
19 kidney disease.

20 (b) The requirement in (a)(i) and (ii) of this subsection for
21 treatment by a health care provider means an in-person visit to a
22 health care provider. The first, or only, in-person treatment visit
23 must take place within seven days of the first day of incapacity.

24 (c) Whether additional treatment visits or a regimen of
25 continuing treatment is necessary within the thirty-day period shall
26 be determined by the health care provider.

27 (d) The term extenuating circumstances in (a)(ii)(A)(I) of this
28 subsection means circumstances beyond the employee's control that
29 prevent the follow-up visit from occurring as planned by the health
30 care provider. Whether a given set of circumstances are extenuating
31 depends on the facts. For example, extenuating circumstances exist if
32 a health care provider determines that a second in-person visit is
33 needed within the thirty-day period, but the health care provider
34 does not have any available appointments during that time period.

35 (e) Treatment for purposes of (a) of this subsection includes,
36 but is not limited to, examinations to determine if a serious health
37 condition exists and evaluations of the condition. Treatment does not
38 include routine physical examinations, eye examinations, or dental
39 examinations. Under (a)(ii)(A)(II) of this subsection, a regimen of
40 continuing treatment includes, but is not limited to, a course of

1 prescription medication, such as an antibiotic, or therapy requiring
2 special equipment to resolve or alleviate the health condition, such
3 as oxygen. A regimen of continuing treatment that includes taking
4 over-the-counter medications, such as aspirin, antihistamines, or
5 salves, or bed rest, drinking fluids, exercise, and other similar
6 activities that can be initiated without a visit to a health care
7 provider, is not, by itself, sufficient to constitute a regimen of
8 continuing treatment for purposes of this title.

9 (f) Conditions for which cosmetic treatments are administered,
10 such as most treatments for acne or plastic surgery, are not serious
11 health conditions unless inpatient hospital care is required or
12 unless complications develop. Ordinarily, unless complications arise,
13 the common cold, the flu, ear aches, upset stomach, minor ulcers,
14 headaches other than migraines, routine dental or orthodontia
15 problems, and periodontal disease are examples of conditions that are
16 not serious health conditions and do not qualify for leave under this
17 title. Restorative dental or plastic surgery after an injury or
18 removal of cancerous growths are serious health conditions provided
19 all the other conditions of this section are met. Mental illness
20 resulting from stress or allergies may be serious health conditions,
21 but only if all the conditions of this section are met.

22 (g)(i) Substance abuse may be a serious health condition if the
23 conditions of this section are met. However, leave may only be taken
24 for treatment for substance abuse by a health care provider or by a
25 licensed substance abuse treatment provider. Absence because of the
26 employee's use of the substance, rather than for treatment, does not
27 qualify for leave under this title.

28 (ii) Treatment for substance abuse does not prevent an employer
29 from taking employment action against an employee. The employer may
30 not take action against the employee because the employee has
31 exercised his or her right to take medical leave for treatment.
32 However, if the employer has an established policy, applied in a
33 nondiscriminatory manner that has been communicated to all employees,
34 that provides under certain circumstances an employee may be
35 terminated for substance abuse, pursuant to that policy the employee
36 may be terminated whether or not the employee is presently taking
37 medical leave. An employee may also take family leave to care for a
38 covered family member who is receiving treatment for substance abuse.
39 The employer may not take action against an employee who is providing

1 care for a covered family member receiving treatment for substance
2 abuse.

3 (h) Absences attributable to incapacity under (a)(ii)(B) or (C)
4 of this subsection qualify for leave under this title even though the
5 employee or the family member does not receive treatment from a
6 health care provider during the absence, and even if the absence does
7 not last more than three consecutive, full calendar days. For
8 example, an employee with asthma may be unable to report for work due
9 to the onset of an asthma attack or because the employee's health
10 care provider has advised the employee to stay home when the pollen
11 count exceeds a certain level. An employee who is pregnant may be
12 unable to report to work because of severe morning sickness.

13 (24) "Service is localized in this state" has the same meaning as
14 described in RCW 50.04.120.

15 (25) "Spouse" means a husband or wife, as the case may be, or
16 state registered domestic partner.

17 (26) "State average weekly wage" means the most recent average
18 weekly wage calculated under RCW 50.04.355 and available on January
19 1st of each year.

20 (27) "Supplemental benefit payments" means payments made by an
21 employer to an employee as salary continuation or as paid time off.
22 Such payments must be in addition to any paid family or medical leave
23 benefits the employee is receiving.

24 (28) "Typical workweek hours" means:

25 (a) For an hourly employee, the average number of hours worked
26 per week by an employee within the qualifying period; and

27 (b) Forty hours for a salaried employee, regardless of the number
28 of hours the salaried employee typically works.

29 (29) "Wage" or "wages" means:

30 (a) For the purpose of premium assessment, the remuneration paid
31 by an employer to an employee. The maximum wages subject to a premium
32 assessment are those wages as set by the commissioner under RCW
33 50A.10.030;

34 (b) For the purpose of payment of benefits, the remuneration paid
35 by one or more employers to an employee for employment during the
36 employee's qualifying period. At the request of an employee, wages
37 may be calculated on the basis of remuneration payable. The
38 department shall notify each employee that wages are calculated on
39 the basis of remuneration paid, but at the employee's request a

1 redetermination may be performed and based on remuneration payable;
2 and

3 (c) For the purpose of a self-employed person electing coverage
4 under RCW 50A.10.010, the meaning is defined by rule.

12 nurses, to workers injured during the course of their employment at
13 the least cost consistent with promptness and efficiency, without
14 discrimination or favoritism, and with as great uniformity as the
15 various and diverse surrounding circumstances and locations of
16 industries will permit and to that end shall, from time to time,
17 establish and adopt and supervise the administration of printed
18 forms, rules, regulations, and practices for the furnishing of such
19 care and treatment: PROVIDED, That the medical coverage decisions of
20 the department do not constitute a "rule" as used in RCW
21 34.05.010(16), nor are such decisions subject to the rule-making
22 provisions of chapter 34.05 RCW except that criteria for establishing
23 medical coverage decisions shall be adopted by rule after
24 consultation with the workers' compensation advisory committee
25 established in RCW 51.04.110: PROVIDED FURTHER, That the department
26 may recommend to an injured worker particular health care services
27 and providers where specialized treatment is indicated or where cost-
28 effective payment levels or rates are obtained by the department: AND
29 PROVIDED FURTHER, That the department may enter into contracts for
30 goods and services including, but not limited to, durable medical
31 equipment so long as statewide access to quality service is
32 maintained for injured workers.

33 (2) The director shall, in consultation with interested persons,
34 establish and, in his or her discretion, periodically change as may
35 be necessary, and make available a fee schedule of the maximum
36 charges to be made by any physician, surgeon, chiropractor, hospital,
37 druggist, licensed advanced ((~~registered nurse practitioner~~))
38 practice registered nurse, physician assistants as defined in chapter
39 18.71A RCW, acting under the supervision of or in coordination with a

1 participating physician, as defined in RCW 18.71A.010, or other
2 agency or person rendering services to injured workers. The
3 department shall coordinate with other state purchasers of health
4 care services to establish as much consistency and uniformity in
5 billing and coding practices as possible, taking into account the
6 unique requirements and differences between programs. No service
7 covered under this title, including services provided to injured
8 workers, whether aliens or other injured workers, who are not
9 residing in the United States at the time of receiving the services,
10 shall be charged or paid at a rate or rates exceeding those specified
11 in such fee schedule, and no contract providing for greater fees
12 shall be valid as to the excess. The establishment of such a
13 schedule, exclusive of conversion factors, does not constitute
14 "agency action" as used in RCW 34.05.010(3), nor does such a fee
15 schedule and its associated billing or payment instructions and
16 policies constitute a "rule" as used in RCW 34.05.010(16).

17 (3) The director or self-insurer, as the case may be, shall make
18 a record of the commencement of every disability and the termination
19 thereof and, when bills are rendered for the care and treatment of
20 injured workers, shall approve and pay those which conform to the
21 adopted rules, regulations, established fee schedules, and practices
22 of the director and may reject any bill or item thereof incurred in
23 violation of the principles laid down in this section or the rules,
24 regulations, or the established fee schedules and rules and
25 regulations adopted under it.

26 **Sec. 5113.** RCW 51.28.010 and 2023 c 171 s 3 are each amended to
27 read as follows:

28 (1) Whenever any accident occurs to any worker it shall be the
29 duty of such worker or someone in his or her behalf to forthwith
30 report such accident to his or her employer, superintendent, or
31 supervisor in charge of the work, and of the employer to at once
32 report such accident and the injury resulting therefrom to the
33 department pursuant to RCW 51.28.025 where the worker has received
34 treatment from a physician, osteopathic physician, chiropractor,
35 naturopath, podiatric physician, optometrist, dentist, licensed
36 advanced (~~registered nurse practitioner~~) practice registered nurse,
37 physician assistant, or psychologist in claims solely for mental
38 health conditions, has been hospitalized, disabled from work, or has
39 died as the apparent result of such accident and injury.

1 (2) Upon receipt of such notice of accident, the department shall
2 immediately forward to the worker or his or her beneficiaries or
3 dependents notification, in nontechnical language, of their rights
4 under this title. The notice must specify the worker's right to
5 receive health services from a provider of the worker's choice under
6 RCW 51.36.010(2)(a), including chiropractic services under RCW
7 51.36.015, and must list the types of providers authorized to provide
8 these services.

9 (3) Employers shall not engage in claim suppression.

10 (4) For the purposes of this section, "claim suppression" means
11 intentionally:

12 (a) Inducing employees to fail to report injuries;

13 (b) Inducing employees to treat injuries in the course of
14 employment as off-the-job injuries; or

15 (c) Acting otherwise to suppress legitimate industrial insurance
16 claims.

17 (5) In determining whether an employer has engaged in claim
18 suppression, the department shall consider the employer's history of
19 compliance with industrial insurance reporting requirements, and
20 whether the employer has discouraged employees from reporting
21 injuries or filing claims. The department has the burden of proving
22 claim suppression by a preponderance of the evidence.

23 (6) Claim suppression does not include bona fide workplace safety
24 and accident prevention programs or an employer's provision at the
25 worksite of first aid as defined by the department. The department
26 shall adopt rules defining bona fide workplace safety and accident
27 prevention programs and defining first aid.

28 **Sec. 5114.** RCW 51.28.020 and 2023 c 171 s 4 are each amended to
29 read as follows:

30 (1)(a) Where a worker is entitled to compensation under this
31 title he or she shall file with the department or his or her self-
32 insured employer, as the case may be, his or her application for
33 such, together with the certificate of the physician, osteopathic
34 physician, chiropractor, naturopath, podiatric physician,
35 optometrist, dentist, licensed advanced (~~registered nurse~~
36 ~~practitioner~~) practice registered nurse, physician assistant, or
37 psychologist in claims solely for mental health conditions, who
38 attended him or her. An application form developed by the department
39 shall include a notice specifying the worker's right to receive

1 health services from a provider of the worker's choice under RCW
2 51.36.010(2)(a), and listing the types of providers authorized to

5 naturopath, podiatric physician, optometrist, dentist, licensed

9 injured worker of his or her rights under this title and lend all
10 necessary assistance in making this application for compensation and
11 such proof of other matters as required by the rules of the
12 department without charge to the worker. The department shall provide
13 a manual which outlines the procedures to be followed in applications
14 for compensation involving occupational diseases, and which describes
15 claimants' rights and responsibilities related to occupational
16 disease claims.

17 (2) If the application required by this section is:

18 (a) Made to the department and the employer has not received a
19 copy of the application, the department shall immediately send a copy
20 of the application to the employer; or

21 (b) Made to a self-insured employer, the employer shall forthwith
22 send a copy of the application to the department.

23 (3) The application required by this section may be transmitted
24 to the department electronically.

25 **Sec. 5115.** RCW 51.28.025 and 2007 c 77 s 2 are each amended to
26 read as follows:

27 (1) Whenever an employer has notice or knowledge of an injury or
28 occupational disease sustained by any worker in his or her employment
29 who has received treatment from a physician or a licensed advanced
30 (~~(registered nurse practitioner)~~) practice registered nurse, has been
31 hospitalized, disabled from work or has died as the apparent result
32 of such injury or occupational disease, the employer shall
33 immediately report the same to the department on forms prescribed by
34 it. The report shall include:

35 (a) The name, address, and business of the employer;

36 (b) The name, address, and occupation of the worker;

37 (c) The date, time, cause, and nature of the injury or
38 occupational disease;

1 (d) Whether the injury or occupational disease arose in the
2 course of the injured worker's employment;

3 (e) All available information pertaining to the nature of the
4 injury or occupational disease including but not limited to any
5 visible signs, any complaints of the worker, any time lost from work,
6 and the observable effect on the worker's bodily functions, so far as
7 is known; and

8 (f) Such other pertinent information as the department may
9 prescribe by regulation.

10 (2) The employer shall not engage in claim suppression. An
11 employer found to have engaged in claim suppression shall be subject
12 to a penalty of at least two hundred fifty dollars, not to exceed two
13 thousand five hundred dollars, for each offense. The penalty shall be
14 payable to the supplemental pension fund. The department shall adopt
15 rules establishing the amount of penalties, taking into account the
16 size of the employer and whether there are prior findings of claim
17 suppression. When a determination of claim suppression has been made,
18 the employer shall be prohibited from any current or future
19 participation in a retrospective rating program. If self-insured, the
20 director shall withdraw certification as provided in RCW 51.14.080.

21 (3) When a determination of claim suppression is made and the
22 penalty is assessed, the department shall serve the employer and any
23 affected retrospective rating group with a determination as provided
24 in RCW 51.52.050. The determination may be protested to the
25 department or appealed to the board of industrial insurance appeals.
26 Once the order is final, the amount due shall be collected in
27 accordance with the provisions of RCW 51.48.140 and 51.48.150.

28 (4) The director, or the director's designee, shall investigate
29 reports or complaints that an employer has engaged in claim
30 suppression as prohibited in RCW 51.28.010(3). The complaints or
31 allegations must be received in writing, and must include the name or
32 names of the individuals or organizations submitting the complaint.
33 In cases where the department can show probable cause, the director
34 may subpoena records from the employer, medical providers, and any
35 other entity that the director believes may have relevant

1 (5) If the director determines that an employer has engaged in
2 claim suppression and, as a result, the worker has not filed a claim
3 for industrial insurance benefits as prescribed by law, then the
4 director in his or her sole discretion may waive the time limits for
5 filing a claim provided in RCW 51.28.050, if the complaint or
6 allegation of claim suppression is received within two years of the
7 worker's accident or exposure. For the director to exercise this
8 discretion, the claim must be filed with the department within ninety
9 days of the date the determination of claim suppression is issued.

10 (6) For the purposes of this section, "claim suppression" has the
11 same meaning as in RCW 51.28.010(4).

12 **Sec. 5116.** RCW 51.28.055 and 2004 c 65 s 7 are each amended to
13 read as follows:

14 (1) Except as provided in subsection (2) of this section for
15 claims filed for occupational hearing loss, claims for occupational
16 disease or infection to be valid and compensable must be filed within
17 two years following the date the worker had written notice from a
18 physician or a licensed advanced (~~registered nurse practitioner~~)
19 practice registered nurse: (a) Of the existence of his or her
20 occupational disease, and (b) that a claim for disability benefits
21 may be filed. The notice shall also contain a statement that the

38 (3) The department may adopt rules to implement this section.

1 **Sec. 5117.** RCW 51.36.010 and 2023 c 171 s 9 are each amended to
2 read as follows:

3 (1) The legislature finds that high quality medical treatment and
4 adherence to occupational health best practices can prevent
5 disability and reduce loss of family income for workers, and lower
6 labor and insurance costs for employers. Injured workers deserve high
7 quality medical care in accordance with current health care best
8 practices. To this end, the department shall establish minimum
9 standards for providers who treat workers from both state fund and
10 self-insured employers. The department shall establish a health care
11 provider network to treat injured workers, and shall accept providers
12 into the network who meet those minimum standards. The department
13 shall convene an advisory group made up of representatives from or
14 designees of the workers' compensation advisory committee and the
15 industrial insurance medical and chiropractic advisory committees to
16 consider and advise the department related to implementation of this
17 section, including development of best practices treatment guidelines
18 for providers in the network. The department shall also seek the
19 input of various health care provider groups and associations
20 concerning the network's implementation. Network providers must be
21 required to follow the department's evidence-based coverage decisions
22 and treatment guidelines, policies, and must be expected to follow
23 other national treatment guidelines appropriate for their patient.
24 The department, in collaboration with the advisory group, shall also
25 establish additional best practice standards for providers to qualify
26 for a second tier within the network, based on demonstrated use of
27 occupational health best practices. This second tier is separate from
28 and in addition to the centers for occupational health and education
29 established under subsection (5) of this section.

30 (2) (a) Upon the occurrence of any injury to a worker entitled to
31 compensation under the provisions of this title, he or she shall
32 receive proper and necessary medical and surgical services at the
33 hands of a physician, osteopathic physician, chiropractor,
34 naturopath, podiatric physician, optometrist, dentist, licensed
35 advanced (~~registered nurse practitioner~~) practice registered nurse,
36 physician assistant, or psychologist in claims solely for mental
37 health conditions, of his or her own choice, if conveniently located,
38 except as provided in (b) of this subsection, and proper and
39 necessary hospital care and services during the period of his or her
40 disability from such injury.

1 (b) Once the provider network is established in the worker's
2 geographic area, an injured worker may receive care from a nonnetwork
3 provider only for an initial office or emergency room visit. However,
4 the department or self-insurer may limit reimbursement to the
5 department's standard fee for the services. The provider must comply
6 with all applicable billing policies and must accept the department's
7 fee schedule as payment in full.

8 (c) The department, in collaboration with the advisory group,
9 shall adopt policies for the development, credentialing,
10 accreditation, and continued oversight of a network of health care
11 providers approved to treat injured workers. Health care providers
12 shall apply to the network by completing the department's provider
13 application which shall have the force of a contract with the
14 department to treat injured workers. The advisory group shall
15 recommend minimum network standards for the department to approve a
16 provider's application, to remove a provider from the network, or to
17 require peer review such as, but not limited to:

18 (i) Current malpractice insurance coverage exceeding a dollar
19 amount threshold, number, or seriousness of malpractice suits over a
20 specific time frame;

21 (ii) Previous malpractice judgments or settlements that do not
22 exceed a dollar amount threshold recommended by the advisory group,
23 or a specific number or seriousness of malpractice suits over a
24 specific time frame;

25 (iii) No licensing or disciplinary action in any jurisdiction or
26 loss of treating or admitting privileges by any board, commission,
27 agency, public or private health care payer, or hospital;

28 (iv) For some specialties such as surgeons, privileges in at
29 least one hospital;

30 (v) Whether the provider has been credentialed by another health
31 plan that follows national quality assurance guidelines; and

32 (vi) Alternative criteria for providers that are not credentialed
33 by another health plan.

34 The department shall develop alternative criteria for providers
35 that are not credentialed by another health plan or as needed to
36 address access to care concerns in certain regions.

37 (d) Network provider contracts will automatically renew at the
38 end of the contract period unless the department provides written
39 notice of changes in contract provisions or the department or
40 provider provides written notice of contract termination. The

1 industrial insurance medical advisory committee shall develop
2 criteria for removal of a provider from the network to be presented
3 to the department and advisory group for consideration in the
4 development of contract terms.

5 (e) In order to monitor quality of care and assure efficient
6 management of the provider network, the department shall establish
7 additional criteria and terms for network participation including,
8 but not limited to, requiring compliance with administrative and
9 billing policies.

10 (f) The advisory group shall recommend best practices standards
11 to the department to use in determining second tier network
12 providers. The department shall develop and implement financial and
13 nonfinancial incentives for network providers who qualify for the
14 second tier. The department is authorized to certify and decertify
15 second tier providers.

16 (3) The department shall work with self-insurers and the
17 department utilization review provider to implement utilization
18 review for the self-insured community to ensure consistent quality,
19 cost-effective care for all injured workers and employers, and to
20 reduce administrative burden for providers.

21 (4) The department for state fund claims shall pay, in accordance
22 with the department's fee schedule, for any alleged injury for which
23 a worker files a claim, any initial prescription drugs provided in
24 relation to that initial visit, without regard to whether the
25 worker's claim for benefits is allowed. In all accepted claims,
26 treatment shall be limited in point of duration as follows:

27 In the case of permanent partial disability, not to extend beyond
28 the date when compensation shall be awarded him or her, except when
29 the worker returned to work before permanent partial disability award
30 is made, in such case not to extend beyond the time when monthly
31 allowances to him or her shall cease; in case of temporary disability
32 not to extend beyond the time when monthly allowances to him or her
33 shall cease: PROVIDED, That after any injured worker has returned to
34 his or her work his or her medical and surgical treatment may be
35 continued if, and so long as, such continuation is deemed necessary
36 by the supervisor of industrial insurance to be necessary to his or
37 her more complete recovery; in case of a permanent total disability
38 not to extend beyond the date on which a lump sum settlement is made
39 with him or her or he or she is placed upon the permanent pension
40 roll: PROVIDED, HOWEVER, That the supervisor of industrial insurance,

1 solely in his or her discretion, may authorize continued medical and
2 surgical treatment for conditions previously accepted by the
3 department when such medical and surgical treatment is deemed
4 necessary by the supervisor of industrial insurance to protect such
5 worker's life or provide for the administration of medical and
6 therapeutic measures including payment of prescription medications,
7 but not including those controlled substances currently scheduled by
8 the pharmacy quality assurance commission as Schedule I, II, III, or
9 IV substances under chapter 69.50 RCW, which are necessary to
10 alleviate continuing pain which results from the industrial injury.
11 In order to authorize such continued treatment the written order of
12 the supervisor of industrial insurance issued in advance of the
13 continuation shall be necessary.

14 The supervisor of industrial insurance, the supervisor's
15 designee, or a self-insurer, in his or her sole discretion, may
16 authorize inoculation or other immunological treatment in cases in
17 which a work-related activity has resulted in probable exposure of
18 the worker to a potential infectious occupational disease.
19 Authorization of such treatment does not bind the department or self-
20 insurer in any adjudication of a claim by the same worker or the
21 worker's beneficiary for an occupational disease.

22 (5) (a) The legislature finds that the department and its business
23 and labor partners have collaborated in establishing centers for
24 occupational health and education to promote best practices and
25 prevent preventable disability by focusing additional provider-based
26 resources during the first twelve weeks following an injury. The
27 centers for occupational health and education represent innovative
28 accountable care systems in an early stage of development consistent
29 with national health care reform efforts. Many Washington workers do
30 not yet have access to these innovative health care delivery models.

31 (b) To expand evidence-based occupational health best practices,
32 the department shall establish additional centers for occupational
33 health and education, with the goal of extending access to at least
34 fifty percent of injured and ill workers by December 2013 and to all
35 injured workers by December 2015. The department shall also develop
36 additional best practices and incentives that span the entire period
37 of recovery, not only the first twelve weeks.

38 (c) The department shall certify and decertify centers for
39 occupational health and education based on criteria including
40 institutional leadership and geographic areas covered by the center

1 for occupational health and education, occupational health leadership
2 and education, mix of participating health care providers necessary
3 to address the anticipated needs of injured workers, health services
4 coordination to deliver occupational health best practices,
5 indicators to measure the success of the center for occupational
6 health and education, and agreement that the center's providers
7 shall, if feasible, treat certain injured workers if referred by the
8 department or a self-insurer.

9 (d) Health care delivery organizations may apply to the
10 department for certification as a center for occupational health and
11 education. These may include, but are not limited to, hospitals and
12 affiliated clinics and providers, multispecialty clinics, health
13 maintenance organizations, and organized systems of network
14 physicians.

15 (e) The centers for occupational health and education shall
16 implement benchmark quality indicators of occupational health best
17 practices for individual providers, developed in collaboration with
18 the department. A center for occupational health and education shall
19 remove individual providers who do not consistently meet these
20 quality benchmarks.

21 (f) The department shall develop and implement financial and
22 nonfinancial incentives for center for occupational health and
23 education providers that are based on progressive and measurable
24 gains in occupational health best practices, and that are applicable
25 throughout the duration of an injured or ill worker's episode of
26 care.

27 (g) The department shall develop electronic methods of tracking
28 evidence-based quality measures to identify and improve outcomes for
29 injured workers at risk of developing prolonged disability. In
30 addition, these methods must be used to provide systematic feedback
31 to physicians regarding quality of care, to conduct appropriate
32 objective evaluation of progress in the centers for occupational
33 health and education, and to allow efficient coordination of
34 services.

35 (6) If a provider fails to meet the minimum network standards
36 established in subsection (2) of this section, the department is
37 authorized to remove the provider from the network or take other
38 appropriate action regarding a provider's participation. The
39 department may also require remedial steps as a condition for a
40 provider to participate in the network. The department, with input

1 from the advisory group, shall establish waiting periods that may be
2 imposed before a provider who has been denied or removed from the
3 network may reapply.

4 (7) The department may permanently remove a provider from the
5 network or take other appropriate action when the provider exhibits a
6 pattern of conduct of low quality care that exposes patients to risk
7 of physical or psychiatric harm or death. Patterns that qualify as
8 risk of harm include, but are not limited to, poor health care
9 outcomes evidenced by increased, chronic, or prolonged pain or
10 decreased function due to treatments that have not been shown to be
11 curative, safe, or effective or for which it has been shown that the
12 risks of harm exceed the benefits that can be reasonably expected
13 based on peer-reviewed opinion.

14 (8) The department may not remove a health care provider from the
15 network for an isolated instance of poor health and recovery outcomes
16 due to treatment by the provider.

17 (9) When the department terminates a provider from the network,
18 the department or self-insurer shall assist an injured worker
19 currently under the provider's care in identifying a new network
20 provider or providers from whom the worker can select an attending or
21 treating provider. In such a case, the department or self-insurer
22 shall notify the injured worker that he or she must choose a new
23 attending or treating provider.

24 (10) The department may adopt rules related to this section.

25 (11) The department shall report to the workers' compensation
26 advisory committee and to the appropriate committees of the
27 legislature on each December 1st, beginning in 2012 and ending in
28 2016, on the implementation of the provider network and expansion of
29 the centers for occupational health and education. The reports must
30 include a summary of actions taken, progress toward long-term goals,
31 outcomes of key initiatives, access to care issues, results of
32 disputes or controversies related to new provisions, and whether any
33 changes are needed to further improve the occupational health best
34 practices care of injured workers.

37 The director of the department of labor and industries or the
38 director's authorized representative shall have the authority to:

1 (1) Conduct audits and investigations of providers of medical,

4 conduct of such audits or investigations, the director or the
5 director's authorized representatives may examine all records, or
6 portions thereof, including patient records, for which services were
7 rendered by a health services provider and reimbursed by the

9 may make or purport to make such records privileged or confidential:
10 PROVIDED, That no original patient records shall be removed from the
11 premises of the health services provider, and that the disclosure of

14 constitutes a violation of RCW 42.52.050, unless such disclosure is
15 directly connected to the official duties of the department: AND
16 PROVIDED FURTHER, That the disclosure of patient information as
17 required under this section shall not subject any physician, licensed
18 advanced (~~((registered nurse practitioner))~~) practice registered nurse,
19 or other health services provider to any liability for breach of any
20 confidential relationships between the provider and the patient: AND
21 PROVIDED FURTHER, That the director or the director's authorized
22 representative shall destroy all copies of patient medical records in
23 their possession upon completion of the audit, investigation, or
24 proceedings;

25 (2) Approve or deny applications to participate as a provider of
26 services furnished to industrially injured workers pursuant to Title
27 51 RCW;

28 (3) Terminate or suspend eligibility to participate as a provider
29 of services furnished to industrially injured workers pursuant to
30 Title 51 RCW; and

31 (4) Pursue collection of unpaid overpayments and/or penalties
32 plus interest accrued from health care providers pursuant to RCW
33 51.32.240(6).

34 **Sec. 5119.** RCW 51.48.060 and 2020 c 277 s 5 are each amended to
35 read as follows:

36 Any physician or licensed advanced (~~((registered—nurse
37 practitioner))~~) practice registered nurse who fails, neglects or
38 refuses to file a report with the director, as required by this
39 title, within five days of the date of treatment, showing the

1 condition of the injured worker at the time of treatment, a
2 description of the treatment given, and an estimate of the probable
3 duration of the injury, or who fails or refuses to render all
4 necessary assistance to the injured worker, as required by this

38 (15) "Controlled substance" means a drug, substance, or immediate
39 precursor included in Schedules I through V as set forth in federal

1 or state laws, or federal or commission rules, but does not include
2 hemp or industrial hemp as defined in RCW 15.140.020.

3 (16) (a) "Controlled substance analog" means a substance the
4 chemical structure of which is substantially similar to the chemical
5 structure of a controlled substance in Schedule I or II and:

6 (i) that has a stimulant, depressant, or hallucinogenic effect on
7 the central nervous system substantially similar to the stimulant,
8 depressant, or hallucinogenic effect on the central nervous system of
9 a controlled substance included in Schedule I or II; or

10 (ii) with respect to a particular individual, that the individual
11 represents or intends to have a stimulant, depressant, or
12 hallucinogenic effect on the central nervous system substantially
13 similar to the stimulant, depressant, or hallucinogenic effect on the
14 central nervous system of a controlled substance included in Schedule
15 I or II.

16 (b) The term does not include:

17 (i) a controlled substance;

18 (ii) a substance for which there is an approved new drug
19 application;

20 (iii) a substance with respect to which an exemption is in effect
21 for investigational use by a particular person under Section 505 of
22 the federal food, drug, and cosmetic act, 21 U.S.C. Sec. 355, or
23 chapter 69.77 RCW to the extent conduct with respect to the substance
24 is pursuant to the exemption; or

25 (iv) any substance to the extent not intended for human
26 consumption before an exemption takes effect with respect to the
27 substance.

28 (17) "Deliver" or "delivery" means the actual or constructive
29 transfer from one person to another of a substance, whether or not
30 there is an agency relationship.

31 (18) "Department" means the department of health.

32 (19) "Designated provider" has the meaning provided in RCW
33 69.51A.010.

34 (20) "Dispense" means the interpretation of a prescription or
35 order for a controlled substance and, pursuant to that prescription
36 or order, the proper selection, measuring, compounding, labeling, or
37 packaging necessary to prepare that prescription or order for
38 delivery.

39 (21) "Dispenser" means a practitioner who dispenses.

1 (22) "Distribute" means to deliver other than by administering or
2 dispensing a controlled substance.

3 (23) "Distributor" means a person who distributes.

4 (24) "Drug" means (a) a controlled substance recognized as a drug
5 in the official United States pharmacopoeia/national formulary or the
6 official homeopathic pharmacopoeia of the United States, or any
7 supplement to them; (b) controlled substances intended for use in the
8 diagnosis, cure, mitigation, treatment, or prevention of disease in
9 individuals or animals; (c) controlled substances (other than food)
10 intended to affect the structure or any function of the body of
11 individuals or animals; and (d) controlled substances intended for
12 use as a component of any article specified in (a), (b), or (c) of
13 this subsection. The term does not include devices or their
14 components, parts, or accessories.

15 (25) "Drug enforcement administration" means the drug enforcement
16 administration in the United States Department of Justice, or its
17 successor agency.

18 (26) "Electronic communication of prescription information" means
19 the transmission of a prescription or refill authorization for a drug
20 of a practitioner using computer systems. The term does not include a
21 prescription or refill authorization verbally transmitted by
22 telephone nor a facsimile manually signed by the practitioner.

23 (27) "Immature plant or clone" means a plant or clone that has no
24 flowers, is less than twelve inches in height, and is less than
25 twelve inches in diameter.

26 (28) "Immediate precursor" means a substance:

27 (a) that the commission has found to be and by rule designates as
28 being the principal compound commonly used, or produced primarily for
29 use, in the manufacture of a controlled substance;

30 (b) that is an immediate chemical intermediary used or likely to
31 be used in the manufacture of a controlled substance; and

32 (c) the control of which is necessary to prevent, curtail, or
33 limit the manufacture of the controlled substance.

34 (29) "Isomer" means an optical isomer, but in subsection (33)(e)
35 of this section, RCW 69.50.204(1) (l) and (hh), and 69.50.206(2) (d),
36 the term includes any geometrical isomer; in RCW 69.50.204(1) (h) and
37 (pp) ((~~r~~)) and 69.50.210(3) ((~~r~~)), l the term includes any positional
38 isomer; and in RCW 69.50.204(1) (ii), 69.50.204(3), and 69.50.208(1)
39 ((~~r~~)), l the term includes any positional or geometric isomer.

1 (30) "Lot" means a definite quantity of cannabis, cannabis
2 concentrates, useable cannabis, or cannabis-infused product
3 identified by a lot number, every portion or package of which is
4 uniform within recognized tolerances for the factors that appear in
5 the labeling.

6 (31) "Lot number" must identify the licensee by business or trade
7 name and Washington state unified business identifier number, and the
8 date of harvest or processing for each lot of cannabis, cannabis
9 concentrates, useable cannabis, or cannabis-infused product.

10 (32) "Manufacture" means the production, preparation,
11 propagation, compounding, conversion, or processing of a controlled
12 substance, either directly or indirectly or by extraction from
13 substances of natural origin, or independently by means of chemical
14 synthesis, or by a combination of extraction and chemical synthesis,
15 and includes any packaging or repackaging of the substance or
16 labeling or relabeling of its container. The term does not include
17 the preparation, compounding, packaging, repackaging, labeling, or
18 relabeling of a controlled substance:

19 (a) by a practitioner as an incident to the practitioner's
20 administering or dispensing of a controlled substance in the course
21 of the practitioner's professional practice; or

26 (33) "Narcotic drug" means any of the following, whether produced

30 (a) Opium, opium derivative, and any derivative of opium or opium
31 derivative, including their salts, isomers, and salts of isomers,

35 (b) Synthetic opiate and any derivative of synthetic opiate,

4 (e) Cocaine, or any salt, isomer, or salt of isomer thereof.

5 (f) Cocaine base.

6 (g) Ecgonine, or any derivative, salt, isomer, or salt of isomer
7 thereof.

8 (h) Any compound, mixture, or preparation containing any quantity
9 of any substance referred to in (a) through (g) of this subsection.

10 (34) "Opiate" means any substance having an addiction-forming or
11 addiction-sustaining liability similar to morphine or being capable
12 of conversion into a drug having addiction-forming or addiction-
13 sustaining liability. The term includes opium, substances derived
14 from opium (opium derivatives), and synthetic opiates. The term does
15 not include, unless specifically designated as controlled under RCW
16 69.50.201, the dextrorotatory isomer of 3-methoxy-n-methylmorphinan
17 and its salts (dextromethorphan). The term includes the racemic and
18 levorotatory forms of dextromethorphan.

19 (35) "Opium poppy" means the plant of the species *Papaver*
20 *somniferum* L., except its seeds.

21 (36) "Package" means a container that has a single unit or group
22 of units.

23 (37) "Person" means individual, corporation, business trust,
24 estate, trust, partnership, association, joint venture, government,
25 governmental subdivision or agency, or any other legal or commercial
26 entity.

27 (38) "Plant" has the meaning provided in RCW 69.51A.010.

28 (39) "Poppy straw" means all parts, except the seeds, of the
29 opium poppy, after mowing.

30 (40) "Practitioner" means:

31 (a) A physician under chapter 18.71 RCW; a physician assistant
32 under chapter 18.71A RCW; an osteopathic physician and surgeon under
33 chapter 18.57 RCW; an optometrist licensed under chapter 18.53 RCW
34 who is certified by the optometry board under RCW 18.53.010 subject
35 to any limitations in RCW 18.53.010; a dentist under chapter 18.32
36 RCW; a podiatric physician and surgeon under chapter 18.22 RCW; a
37 veterinarian under chapter 18.92 RCW; a registered nurse, advanced
38 (~~registered nurse practitioner~~) practice registered nurse, or
39 licensed practical nurse under chapter 18.79 RCW; a naturopathic
40 physician under chapter 18.36A RCW who is licensed under RCW

1 18.36A.030 subject to any limitations in RCW 18.36A.040; a pharmacist
2 under chapter 18.64 RCW or a scientific investigator under this
3 chapter, licensed, registered or otherwise permitted insofar as is
4 consistent with those licensing laws to distribute, dispense, conduct
5 research with respect to or administer a controlled substance in the
6 course of their professional practice or research in this state.

7 (b) A pharmacy, hospital or other institution licensed,
8 registered, or otherwise permitted to distribute, dispense, conduct
9 research with respect to or to administer a controlled substance in
10 the course of professional practice or research in this state.

11 (c) A physician licensed to practice medicine and surgery, a
12 physician licensed to practice osteopathic medicine and surgery, a
13 dentist licensed to practice dentistry, a podiatric physician and
14 surgeon licensed to practice podiatric medicine and surgery, a
15 licensed physician assistant or a licensed osteopathic physician
16 assistant specifically approved to prescribe controlled substances by
17 his or her state's medical commission or equivalent and his or her

22 (41) "Prescription" means an order for controlled substances
23 issued by a practitioner duly authorized by law or rule in the state
24 of Washington to prescribe controlled substances within the scope of
25 his or her professional practice for a legitimate medical purpose.

26 (42) "Production" includes the manufacturing, planting,
27 cultivating, growing, or harvesting of a controlled substance.

28 (43) "Qualifying patient" has the meaning provided in RCW
29 69.51A.010.

30 (44) "Recognition card" has the meaning provided in RCW
31 69.51A.010.

32 (45) "Retail outlet" means a location licensed by the board for
33 the retail sale of cannabis concentrates, useable cannabis, and
34 cannabis-infused products.

35 (46) "Secretary" means the secretary of health or the secretary's
36 designee.

37 (47) "Social equity plan" means a plan that addresses at least
38 some of the elements outlined in this subsection (47), along with any
39 additional plan components or requirements approved by the board

1 following consultation with the task force created in RCW 69.50.336.

2 The plan may include:

3 (a) A statement that indicates how the cannabis licensee will
4 work to promote social equity goals in their community;

5 (b) A description of how the cannabis licensee will meet social
6 equity goals as defined in RCW 69.50.335;

7 (c) The composition of the workforce the licensee has employed or
8 intends to hire; and

9 (d) Business plans involving partnerships or assistance to
10 organizations or residents with connections to populations with a
11 history of high rates of enforcement of cannabis prohibition.

12 (48) "State," unless the context otherwise requires, means a
13 state of the United States, the District of Columbia, the
14 Commonwealth of Puerto Rico, or a territory or insular possession
15 subject to the jurisdiction of the United States.

16 (49) "THC concentration" means percent of tetrahydrocannabinol
17 content of any part of the plant *Cannabis*, or per volume or weight of
18 cannabis product, or the combined percent of tetrahydrocannabinol and
19 tetrahydrocannabinolic acid in any part of the plant *Cannabis*
20 regardless of moisture content.

21 (50) "Ultimate user" means an individual who lawfully possesses a
22 controlled substance for the individual's own use or for the use of a
23 member of the individual's household or for administering to an
24 animal owned by the individual or by a member of the individual's
25 household.

26 (51) "Unit" means an individual consumable item within a package
27 of one or more consumable items in solid, liquid, gas, or any form
28 intended for human consumption.

29 (52) "Useable cannabis" means dried cannabis flowers. The term
30 "useable cannabis" does not include either cannabis-infused products
31 or cannabis concentrates.

32 (53) "Youth access" means the level of interest persons under the
33 age of twenty-one may have in a vapor product, as well as the degree
34 to which the product is available or appealing to such persons, and
35 the likelihood of initiation, use, or addiction by adolescents and
36 young adults.

23 (9) "CBD concentration" means the percent of cannabidiol content
24 per dry weight of any part of the plant *Cannabis*, or per volume or
25 weight of cannabis product.

26 (10) "Department" means the department of health.

27 (11) "Designated provider" means a person who is twenty-one years
28 of age or older and:

29 (a) (i) Is the parent or guardian of a qualifying patient who is
30 under the age of eighteen and holds a recognition card; or

31 (ii) Has been designated in writing by a qualifying patient to
32 serve as the designated provider for that patient;

33 (b) (i) Has an authorization from the qualifying patient's health
34 care professional; or

26 (16) "Medical use of cannabis" means the manufacture, production,

29 patient in the treatment of his or her terminal or debilitating
30 medical condition.

31 (17) "Plant" means a cannabis plant having at least three
32 distinguishable and distinct leaves, each leaf being at least three
33 centimeters in diameter, and a readily observable root formation
34 consisting of at least two separate and distinct roots, each being at
35 least two centimeters in length. Multiple stalks emanating from the
36 same root ball or root system is considered part of the same single

39 (19) "Qualifying patient" means a person who:

40 (a) (i) Is a patient of a health care professional;

1 (ii) Has been diagnosed by that health care professional as
2 having a terminal or debilitating medical condition;

3 (iii) Is a resident of the state of Washington at the time of
4 such diagnosis;

5 (iv) Has been advised by that health care professional about the
6 risks and benefits of the medical use of cannabis;

7 (v) Has been advised by that health care professional that they
8 may benefit from the medical use of cannabis;

9 (vi) (A) Has an authorization from his or her health care

21 as in RCW 70.24.017.

22 (21) "Imminent" has the same meaning as in RCW 71.05.020.

23 (22) "Indian health care provider" has the same meaning as in RCW
24 43.71B.010(11).

25 (23) "Information and records related to mental health services"
26 means a type of health care information that relates to all
27 information and records compiled, obtained, or maintained in the
28 course of providing services by a mental health service agency or
29 mental health professional to persons who are receiving or have
30 received services for mental illness. The term includes mental health
31 information contained in a medical bill, registration records, and
32 all other records regarding the person maintained by the department,
33 by the authority, by behavioral health administrative services
34 organizations and their staff, managed care organizations contracted
35 with the authority under chapter 74.09 RCW and their staff, and by
36 treatment facilities. The term further includes documents of legal
37 proceedings under chapter 71.05, 71.34, or 10.77 RCW, or somatic
38 health care information. For health care information maintained by a
39 hospital as defined in RCW 70.41.020 or a health care facility or
40 health care provider that participates with a hospital in an

1 organized health care arrangement defined under federal law,
2 "information and records related to mental health services" is
3 limited to information and records of services provided by a mental
4 health professional or information and records of services created by
5 a hospital-operated community behavioral health program as defined in
6 RCW 71.24.025. The term does not include psychotherapy notes.

7 (24) "Information and records related to sexually transmitted
8 diseases" means a type of health care information that relates to the
9 identity of any person upon whom an HIV antibody test or other
10 sexually transmitted infection test is performed, the results of such
11 tests, and any information relating to diagnosis of or treatment for
12 any confirmed sexually transmitted infections.

13 (25) "Institutional review board" means any board, committee, or
14 other group formally designated by an institution, or authorized
15 under federal or state law, to review, approve the initiation of, or
16 conduct periodic review of research programs to assure the protection
17 of the rights and welfare of human research subjects.

18 (26) "Legal counsel" has the same meaning as in RCW 71.05.020.

19 (27) "Local public health officer" has the same meaning as the
20 term "local health officer" as defined in RCW 70.24.017.

21 (28) "Maintain," as related to health care information, means to
22 hold, possess, preserve, retain, store, or control that information.

23 (29) "Managed care organization" has the same meaning as provided
24 in RCW 71.24.025.

25 (30) "Mental health professional" means a psychiatrist,
26 psychologist, psychiatric advanced (~~registered nurse practitioner~~)
27 practice registered nurse, psychiatric nurse, or social worker, and
28 such other mental health professionals as may be defined by rules
29 adopted by the secretary of health under chapter 71.05 RCW, whether
30 that person works in a private or public setting.

31 (31) "Mental health service agency" means a public or private

5 (a) The activities undertaken by:

6 (i) A third-party payor to obtain premiums or to determine or
7 fulfill its responsibility for coverage and provision of benefits by
8 the third-party payor; or

9 (ii) A health care provider, health care facility, or third-party
10 payor, to obtain or provide reimbursement for the provision of health
11 care; and

12 (b) The activities in (a) of this subsection that relate to the
13 patient to whom health care is provided and that include, but are not
14 limited to:

15 (i) Determinations of eligibility or coverage, including
16 coordination of benefits or the determination of cost-sharing
17 amounts, and adjudication or subrogation of health benefit claims;

18 (ii) Risk adjusting amounts due based on enrollee health status
19 and demographic characteristics;

20 (iii) Billing, claims management, collection activities,
21 obtaining payment under a contract for reinsurance, including stop-

10 by a mental health professional documenting or analyzing the contents
11 of conversations during a private counseling session or group, joint,

14 prescription and monitoring, counseling session start and stop times,
15 the modalities and frequencies of treatment furnished, results of

7 (47) "Treatment" means the provision, coordination, or management

15 (4) The petitioner must allege specific facts based on personal
16 observation, evaluation, or investigation, and must consider the
17 reliability or credibility of any person providing information
18 material to the petition.

19 (5) The petition must include:

20 (a) A statement of the circumstances under which the person's
21 condition was made known and the basis for the opinion, from personal
22 observation or investigation, that the person is in need of assisted
23 outpatient treatment. The petitioner must state which specific facts
24 come from personal observation and specify what other sources of
25 information the petitioner has relied upon to form this belief;

26 (b) A declaration from a physician, physician assistant, advanced
27 (~~registered nurse practitioner~~) practice registered nurse, or the
28 person's treating mental health professional or substance use
29 disorder professional, who has examined the person no more than 10
30 days prior to the submission of the petition and who is willing to
31 testify in support of the petition, or who alternatively has made
32 appropriate attempts to examine the person within the same period but
33 has not been successful in obtaining the person's cooperation, and
34 who is willing to testify to the reasons they believe that the person
35 meets the criteria for assisted outpatient treatment. If the
36 declaration is provided by the person's treating mental health
37 professional or substance use disorder professional, it must be
38 cosigned by a supervising physician, physician assistant, or advanced
39 (~~registered nurse practitioner~~) practice registered nurse who
40 certifies that they have reviewed the declaration;

1 (c) The declarations of additional witnesses, if any, supporting
2 the petition for assisted outpatient treatment;

3 (d) The name of an agency, provider, or facility that agrees to
4 provide less restrictive alternative treatment if the petition is
5 granted by the court; and

6 (e) If the person is detained in a state hospital, inpatient
7 treatment facility, jail, or correctional facility at the time the
8 petition is filed, the anticipated release date of the person and any
9 other details needed to facilitate successful reentry and transition
10 into the community.

11 (6)(a) Upon receipt of a petition meeting all requirements of
12 this section, the court shall fix a date for a hearing:

13 (i) No sooner than three days or later than seven days after the
14 date of service or as stipulated by the parties or, upon a showing of
15 good cause, no later than 30 days after the date of service; or

16 (ii) If the respondent is hospitalized at the time of filing of
17 the petition, before discharge of the respondent and in sufficient
18 time to arrange for a continuous transition from inpatient treatment
19 to assisted outpatient treatment.

20 (b) A copy of the petition and notice of hearing shall be served,
21 in the same manner as a summons, on the petitioner, the respondent,

31 (e) If the respondent fails to appear at the hearing after
32 notice, the court may conduct the hearing in the respondent's

35 professional whose affidavit accompanied the petition, the court may
36 order a mental examination of the respondent. The examination of the
37 respondent may be performed by the qualified professional whose

1 professional shall be authorized to consult with the qualified
2 professional whose affidavit accompanied the petition.

3 (g) If the respondent has refused to be examined by a qualified

6 written order directing a peace officer who has completed crisis
7 intervention training to detain and transport the respondent to a

9 detained pursuant to this subsection shall be detained no longer than
10 necessary to complete the examination and in no event longer than 24
11 hours.

12 (7) If the petition involves a person whom the petitioner or
13 behavioral health administrative services organization knows, or has
14 reason to know, is an American Indian or Alaska Native who receives
15 medical or behavioral health services from a tribe within this state,
16 the petitioner or behavioral health administrative services
17 organization shall notify the tribe and Indian health care provider.
18 Notification shall be made in person or by telephonic or electronic
19 communication to the tribal contact listed in the authority's tribal
20 crisis coordination plan as soon as possible, but before the hearing
21 and no later than 24 hours from the time the petition is served upon
22 the person and the person's guardian. The notice to the tribe or
23 Indian health care provider must include a copy of the petition,
24 together with any orders issued by the court and a notice of the
25 tribe's right to intervene. The court clerk shall provide copies of
26 any court orders necessary for the petitioner or the behavioral
27 health administrative services organization to provide notice to the
28 tribe or Indian health care provider under this section.

29 (8) A petition for assisted outpatient treatment filed under this
30 section shall be adjudicated under RCW 71.05.240.

31 (9) After January 1, 2023, a petition for assisted outpatient
32 treatment must be filed on forms developed by the administrative
33 office of the courts.

36 If a person subject to evaluation under RCW 71.05.150 or

35 of which shall be prominently posted in all facilities, institutions,

15 treatment may be committed for not more than fourteen additional days

20 services has analyzed the person's condition and finds that the

35 conditions including overdose, infected abscesses, sepsis,
36 endocarditis, or other maladies, or a significant factor in behavior
37 which resulted in the adolescent's incarceration in a state, local,
38 or tribal correctional facility; or

1 (iii) Resulted in one or more violent acts, threats, or attempts
2 to cause serious physical harm to the adolescent or another within
3 the 48 months prior to the filing of the petition, provided that the
4 48-month period shall be extended by the length of any
5 hospitalization or incarceration of the person that occurred during
6 the 48-month period;

7 (d) Participation in an assisted outpatient treatment program
8 would be the least restrictive alternative necessary to ensure the
9 adolescent's recovery and stability; and

10 (e) The adolescent will benefit from assisted outpatient
11 treatment.

12 (2) The following individuals may directly file a petition for
13 less restrictive alternative treatment on the basis that an
14 adolescent is in need of assisted outpatient treatment:

15 (a) The director of a hospital where the adolescent is
16 hospitalized or the director's designee;

17 (b) The director of a behavioral health service provider
18 providing behavioral health care or residential services to the
19 adolescent or the director's designee;

20 (c) The adolescent's treating mental health professional or
21 substance use disorder professional or one who has evaluated the
22 person;

23 (d) A designated crisis responder;

24 (e) A release planner from a juvenile detention or rehabilitation
25 facility; or

26 (f) An emergency room physician.

27 (3) A court order for less restrictive alternative treatment on
28 the basis that the adolescent is in need of assisted outpatient
29 treatment may be effective for up to 18 months. The petitioner must
30 personally interview the adolescent, unless the adolescent refuses an
31 interview, to determine whether the adolescent will voluntarily
32 receive appropriate treatment.

33 (4) The petitioner must allege specific facts based on personal
34 observation, evaluation, or investigation, and must consider the
35 reliability or credibility of any person providing information
36 material to the petition.

37 (5) The petition must include:

38 (a) A statement of the circumstances under which the adolescent's
39 condition was made known and the basis for the opinion, from personal
40 observation or investigation, that the adolescent is in need of

1 assisted outpatient treatment. The petitioner must state which
2 specific facts come from personal observation and specify what other
3 sources of information the petitioner has relied upon to form this
4 belief;

5 (b) A declaration from a physician, physician assistant, or
6 advanced (~~(registered nurse practitioner)~~) practice registered nurse,
7 or the adolescent's treating mental health professional or substance
8 use disorder professional, who has examined the adolescent no more
9 than 10 days prior to the submission of the petition and who is
10 willing to testify in support of the petition, or who alternatively
11 has made appropriate attempts to examine the adolescent within the
12 same period but has not been successful in obtaining the adolescent's
13 cooperation, and who is willing to testify to the reasons they
14 believe that the adolescent meets the criteria for assisted
15 outpatient treatment. If the declaration is provided by the
16 adolescent's treating mental health professional or substance use
17 disorder professional, it must be cosigned by a supervising
18 physician, physician assistant, or advanced (~~(registered nurse~~
19 ~~practitioner)~~) practice registered nurse who certifies that they have
20 reviewed the declaration;

21 (c) The declarations of additional witnesses, if any, supporting
22 the petition for assisted outpatient treatment;

23 (d) The name of an agency, provider, or facility that agrees to
24 provide less restrictive alternative treatment if the petition is
25 granted by the court; and

26 (e) If the adolescent is detained in a state hospital, inpatient
27 treatment facility, or juvenile detention or rehabilitation facility
28 at the time the petition is filed, the anticipated release date of
29 the adolescent and any other details needed to facilitate successful
30 reentry and transition into the community.

31 (6)(a) Upon receipt of a petition meeting all requirements of
32 this section, the court shall fix a date for a hearing:

33 (i) No sooner than three days or later than seven days after the
34 date of service or as stipulated by the parties or, upon a showing of
35 good cause, no later than 30 days after the date of service; or

36 (ii) If the adolescent is hospitalized at the time of filing of
37 the petition, before discharge of the adolescent and in sufficient
38 time to arrange for a continuous transition from inpatient treatment
39 to assisted outpatient treatment.

1 (b) A copy of the petition and notice of hearing shall be served,
2 in the same manner as a summons, on the petitioner, the adolescent,
3 the qualified professional whose affidavit accompanied the petition,
4 a current provider, if any, and a surrogate decision maker or agent
5 under chapter 71.32 RCW, if any.

6 (c) If the adolescent has a surrogate decision maker or agent
7 under chapter 71.32 RCW who wishes to provide testimony at the
8 hearing, the court shall afford the surrogate decision maker or agent
9 an opportunity to testify.

10 (d) The adolescent shall be represented by counsel at all stages
11 of the proceedings.

12 (e) If the adolescent fails to appear at the hearing after
13 notice, the court may conduct the hearing in the adolescent's
14 absence; provided that the adolescent's counsel is present.

15 (f) If the adolescent has refused to be examined by the qualified
16 professional whose affidavit accompanied the petition, the court may
17 order a mental examination of the adolescent. The examination of the
18 adolescent may be performed by the qualified professional whose
19 affidavit accompanied the petition. If the examination is performed
20 by another qualified professional, the examining qualified
21 professional shall be authorized to consult with the qualified
22 professional whose affidavit accompanied the petition.

23 (g) If the adolescent has refused to be examined by a qualified
24 professional and the court finds reasonable grounds to believe that
25 the allegations of the petition are true, the court may issue a
26 written order directing a peace officer who has completed crisis
27 intervention training to detain and transport the adolescent to a
28 provider for examination by a qualified professional. An adolescent
29 detained pursuant to this subsection shall be detained no longer than
30 necessary to complete the examination and in no event longer than 24
31 hours. All papers in the court file must be provided to the
32 adolescent's designated attorney.

33 (7) If the petition involves an adolescent whom the petitioner or
34 behavioral health administrative services organization knows, or has
35 reason to know, is an American Indian or Alaska Native who receives
36 medical or behavioral health services from a tribe within this state,
37 the petitioner or behavioral health administrative services
38 organization shall notify the tribe and Indian health care provider.
39 Notification shall be made in person or by telephonic or electronic
40 communication to the tribal contact listed in the authority's tribal

1 crisis coordination plan as soon as possible, but before the hearing
2 and no later than 24 hours from the time the petition is served upon
3 the person and the person's guardian. The notice to the tribe or
4 Indian health care provider must include a copy of the petition,
5 together with any orders issued by the court and a notice of the
6 tribe's right to intervene. The court clerk shall provide copies of
7 any court orders necessary for the petitioner or the behavioral
8 health administrative services organization to provide notice to the
9 tribe or Indian health care provider under this section.

2 or provide funding for midwifery or doula services, or prevents the
3 department from adopting policy guidelines for the delivery of

14 who, for any month: Has coverage for the month under a medicare
15 prescription drug plan or medicare advantage plan with part D
16 coverage; and is determined eligible by the state for full medicaid
17 benefits for the month under any eligibility category in the state's
18 medicaid plan or a section 1115 demonstration waiver that provides
19 pharmacy benefits.

20 (11) "Health home" or "primary care health home" means
21 coordinated health care provided by a licensed primary care provider
22 coordinating all medical care services, and a multidisciplinary
23 health care team comprised of clinical and nonclinical staff. The
24 term "coordinating all medical care services" shall not be construed
25 to require prior authorization by a primary care provider in order
26 for a patient to receive treatment for covered services by an
27 optometrist licensed under chapter 18.53 RCW. Primary care health
28 home services shall include those services defined as health home

30 are not limited to:

31 (a) Comprehensive care management including, but not limited to,
32 chronic care treatment and management;

34 (c) Multiple ways for patients to communicate with the team,

37 promotion, including the use of patient decision aids;

39 from inpatient to other settings;

1 (f) Individual and family support including authorized

4 tests, generate patient registries, and provide clinical data; and

5 (h) Ongoing performance reporting and quality improvement.

6 (12) "Limited casualty program" means the medical care program
7 provided to medically needy persons as defined under Title XIX of the
8 federal social security act, and to medically indigent persons who
9 are without income or resources sufficient to secure necessary
10 medical services.

11 (13) "Managed care organization" means any health care
12 organization, including health care providers, insurers, health care
13 service contractors, health maintenance organizations, health
14 insuring organizations, or any other entity or combination thereof,
15 that provides directly or by contract health care services covered
16 under this chapter and rendered by licensed providers, on a prepaid
17 capitated basis and that meets the requirements of section
18 1903(m)(1)(A) of Title XIX of the federal social security act or
19 federal demonstration waivers granted under section 1115(a) of Title
20 XI of the federal social security act.

21 (14) "Medical assistance" means the federal aid medical care
22 program provided to categorically needy persons as defined under
23 Title XIX of the federal social security act.

25 financed by state funds and provided to persons who are not eligible
26 for medicaid under RCW 74.09.510 and who are eligible for the aged,
27 blind, or disabled assistance program authorized in RCW 74.62.030 or
28 the essential needs and housing support program pursuant to RCW
29 74.04.805.

30 (16) "Multidisciplinary health care team" means an
31 interdisciplinary team of health professionals which may include, but
32 is not limited to, medical specialists, nurses, pharmacists,
33 nutritionists, dieticians, social workers, behavioral and mental
