1 AN ACT Relating to authorizing a qualified county to impose a tax
2 for the funding of behavioral health diversion from the criminal
3 justice system; adding a new section to chapter 82.14 RCW; and
4 providing a contingent effective date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** A new section is added to chapter 82.14
7 RCW to read as follows:

8 (1) The legislative authority of any county meeting the
9 requirements of subsection (3) of this section may impose a sales and
10 use tax by resolution or ordinance in accordance with the terms of
11 this chapter. The tax must be collected from those persons who are
12 taxable by the state under chapters 82.08 and 82.12 RCW, upon the
13 occurrence of any taxable event within the county.

14 (2) The rate of the tax may not exceed 0.1 percent of the selling
15 price, in the case of a sales tax, or value of the article used, in
16 the case of a use tax.

17 (3) The county must have a behavioral health diversion plan, as
18 defined in chapter . . . (House Bill No. 1218), Laws of 2025, that is
19 approved by the secretary of the department of social and health
20 services before the adoption of the resolution or ordinance to impose
21 the tax authorized under this section.

1 (4) The proceeds of the tax imposed under this section must be
2 used for programs that either prevent individuals with behavioral
3 health needs from entering the criminal justice system or that
4 diverts these individuals away from the criminal justice system once
5 incarcerated. This includes, but is not limited to:

6 (a) Specific measures to reduce the number of individuals with
7 behavioral health needs whose highest charge is up to a class C
8 felony from entering or remaining in the criminal justice system;

9 (b) Specific measures to increase diversion of individuals with
10 behavioral health needs whose highest charge is up to a class C
11 felony away from the competency system;

12 (c) Specific measures to identify individuals for whom a court
13 has made multiple prior findings of nonrestorability, and strategies
14 to prevent future competency evaluation or restoration orders and
15 instead use diversion options for these individuals;

16 (d) Strategies to reduce recidivism for individuals with
17 behavioral health needs who are likely to be referred for a
18 competency service within the next six months based on history of
19 prior referrals, prior inpatient psychiatric treatment episodes,
20 criminal justice system involvement, or homelessness; and

21 (e) A strategic plan to create programming, supports, and
22 services along each intercept in the sequential intercept model for
23 the county. The plan must include strategies to address housing and
24 case management for people with significant behavioral health needs
25 who have or are at risk of having involvement with the criminal
26 justice system.

27 NEW SECTION. **Sec. 2.** This act takes effect only if
28 chapter . . . (House Bill No. 1218), Laws of 2025 is enacted by
29 August 1, 2025.
