- ABERNETHY CREEK:** Stream, 16.09 km (10 mi) long, heads at 46°18'38"N, 123°13'20"W, flows S to its confluence with the Columbia River; Cowlitz and Wahkiakum Cos., WA; starts in the NE 1/4 of Sec. 31, T 10 N, R 4 W and in Sec. 10, T 8 N, R 4 W, W.M.; 46°11'30"N, 123°10'00"W (ending). Approved 6-12-87.
- ACKERMAN ISLAND:** Island, 1.6 km (1 mi) long in the Columbia River, 322 m (0.2 mi) off NE end of Government Island and 4.5 km (2.8 mi) WSW of Camas; Clark Co., WA; Sec. 16 and 17, T 1 N, R 3 E, W.M.; 45°34'27"N, 122°27'30"W. Approved 9-13-85.
- ADAMS CREEK:** Stream, 17.7 km. (11 mi.) long, heads at 46°13'51"N, 121°31'33"W, at the base of Adams Glacier, flows NW to the Cispus River 19 km. (12 mi.) NW of Mount Adams; Skamania Co., Washington; 46°19'59"N, 121°23'10"W.
- ADELMA BEACH:** Populated place, on Quimper Peninsula on the E shore of Discovery Bay 8.9 km (5.5 mi.) SW of Port Townsend; Jefferson Co., WA; Sec. 32, T 30 N, R 1 W, W.M.; 48°02'57" N, 122°49'41" W. Approved 9/80.
- AGATE BAY:** Populated place (unincorporated) elevation 94 m (310 ft.), 10.6 km (6.6 mi) E of Bellingham, approx. 4 km (2.5 mi) S of Squalicum Lake on the NE shore of Lake Whatcom; Whatcom Co., Washington; Sec. 25, T38N, R3E and Sec. 30, T38N, R4E, W.M.; 48°45'22" N, 122° 21' 15" W. Approved by State Board 3/95; U.S. Board 7/95.
- ANT MOUNTAIN:** Small mountain, elevation 1.0 km (3,300 ft), W of Franklin D. Roosevelt Lake; Ferry Co., WA; Secs. 5, 6, 7, 8, T 34 N, R 36 E, W.M.; 48°28'56"N, 118°17'47"W. Approved 6-13-86.
- ARGONAUT PEAK:** Peak, elevation 2.58 km (8,453 ft) located 3.14 km (1.95 mi) ESE of Mount Stuart, in the Alpine Lakes Wilderness Area; Chelan Co., WA; Sec. 21, T 23 N, R 16 E, W.M.; 47°28'13"N, 120°51'38"W. Approved 12-13-85.
- ASGARD PASS:** Pass, elevation 728 m (2,390 ft), in the Cascade Mountains, N of Isolation Lake and 1.6 km (1 mi) SE of Colchuck Lake; Chelan Co., WA; Sec. 15, T 23 N, R 16 E, W.M.; 47°28'45"N, 120°49'15"W. Approved 3-14-86.
- ASHTON CREEK:** Stream, about 6.4 km (4 mi) long heading in the SE corner of Sec. 29, T 32 N, R 9 E, W.M.; and flowing almost due N to enter Squire Creek at Squire Creek Park, 402 m (0.25 mi) downstream from where Highway 530 crosses Squire Creek. This feature is in the Mount Baker National Forest; Snohomish Co., WA; 48°16'20"N, 121°40'30"W (ending), 48°13'35"N, 121°40'06"W (heading). Approved 12-11-87.
- AWTSKIN CANYON:** Locale. 5.1km (3.2mi) NW of the town of Rosalia, just E of Pine Creek; Whitman County, WA. Township 20N, Range 43E, Section(s) 6; W.M. 47.257N, -117.433W. Approved by WA State Board 9/21/2007. Approved by U.S. Board 3/13/2008.

**BABY ISLAND:** Island, 183 m. (600 ft.) long, in Saratoga Passage 9.7 km. (6 mi.) N of Freeland; Island Co., WA; Sec. 11, T 30 N, R 2 E, W.M.; 48°05'58" N, 122°31'35" W. Approved 12/76.

**BADGER MOUNTAIN:** Mountain, highest elevation 482 m. (1579 ft.), 46°14'00"N, 119°19'00"W; Benton County, WA; Sec. 28, T9N, R28E, W.M. Approved 6/74.

**BAGLEY CREEK:** Stream, 4.8 km (3 mi) flowing NE approximately 3 mi heading at the SE base of Mount Hermann where it joins the North Fork Nooksack River. Feature is in Mount Baker National Forest; Whatcom Co., WA; 48°53'40"N, 121°40'00"W (ending), 48°51'49"N, 121°41'40"W (heading). Approved 12-11-87.

**BALD EAGLE PEAK:** Peak, in the Cascade Mountains, 563 m (0.35 mi) NE of Bald Eagle Lake, in the Alpine Lakes Wilderness Area; King Co., WA; Sec. 33, T 25 N, R 12 E, W.M.; 47°34'36"N, 121°16'46"W. Approved 3-8-85.

**BALD MOUNTAIN:** Mountain, elevation 762 m. (2,501 ft.) 13.7 km. (8.5 mi.) E of Montborne; Skagit Co., WA; Sec. 9, T 33 N, R 6 E, W.M.; 48°22'00" N, 122°02'38" W. Approved 12/76.

**BARLOW POINT:** Peak, 982 m elevation (3,222 ft), in the Cascade Mountains, 1.1 km (0.7 mi) due N of Barlow Pass, 2.25 km (1.4 mi) NW of Sheep Mountain, in the Mount Baker National Forest; Snohomish Co., WA; Sec. 6, T 29 N, R 11 E, W.M.; 48°02'13"N, 121°24'03"W. Approved 9-13-85.

**BARNABY ISLAND:** Island, 1.6 km (1 mi) N of Barnaby Creek in the Columbia River. The island is about 305 m (1,000 ft) long and 152 m (500 ft) wide; Ferry Co., WA; Sec. 13, T 34 N, R 36 E, W.M.; 48°26'45"N, 118°12'47"W. Approved 6-14-85.

**BARNES CREEK:** Stream, 1.2 km (0.8 mi.) long, heads at 47° 24' 19" N, 122° 18' 32" W, flows S to Massey Creek, between Des Moines and Zenith, 0.3 km (0.2 mi.) E of Puget Sound; King Co.; Washington; Sec. 17, T22N, R4E, W.M.; 47° 24' 11" N, 122° 18' 08" W. Approved by State Board 3/92.

**BASIN CITY:** Town, located in northern Franklin County approximately 40.3 km (25 mi) N of Pasco, 29 km (18 mi) S of Othello, 9.7 km (6 mi) W of Mesa, and 32.2 km (20 mi) WSW of Connell; Franklin Co., WA; Sec. 23, T 13 N, R 29 E, W.M.; 46°35'39"N, 119°09'07"W. Approved 3-8-85.

**BEAN CANYON:** Canyon, approximately 6.4 km (4 mi) long; Lincoln Co., WA; trending SW in Sec. 9 and 30, T 27 N, R 36 E, W.M.; 47°48'53"N, 118°18'57"W (ending), 47°51'18"N, 118°16'43"W (heading). Approved 6-14-85.

**BEARE HILL:** Summit; 1,090 feet elevation, located 0.7 miles W of the town of Brookfield at 46°16'4.597"N, 123°34'19.782"W; name would replace Jim Crow Hill and commemorate Georgiana and John Beare, who purchased property in the area in the early 1900's; Wahkiakum County, Washington; Sec. 17, T9N, R7W, W.M.; 46°16'4.597"N, 123°34'19.782"W. Approved 10-13-2016.

**BEAVER CREEK:** Creek, 4.0 km (2.5 mi) long, heads in Sec. 18, T 5 N, R 10 E, W.M.; flows N to join Cave Creek in Sec. 32, T 6 N, R 10 E, W.M.; Klickitat Co., WA; 45°55'38"N, 121°35'53"W (heading), 45°57'24"N, 121°35'22"W (ending). Approved 12-9-83.

**BEEHIVE, THE:** Peak, elevation 3,353 m. (11,000 ft.) in Mt. Rainier National Park, on Cowlitz Cleaver on SE slope of Mt. Rainier; Pierce Co., WA; 46°50'18" N, 121°44'14" W. Approved by State Board 12/77; U.S. Board 1/78.

**BEEKS SPRING:** Spring, 2.78 km (2 mi) E of Satus Pass; Klickitat Co., WA; Sec. 30, T 6 N, R 18 E, W.M.; 45°58'57"N, 120°36'46"W. Approved 12-9-83.

**BELL CREEK:** Stream, 8.3 km. (5 mi.) long, heads at 48°53'08"N, 122°11'40"W, flows SE to Nooksack River, 5 km. (3 mi.) NE of Deming; Whatcom Co., WA.; Sec. 28, T39N, R5E, W.M.; 48°50'36"N, 122°09'20"W. Approved 6/75.

**BELL MOUNTAIN:** Summit, elevation 853 m (2,800 ft.), in Olympic National Forest, on W side of Quinault Ridge, 3.2 km (2 mi.) SSE of Quinault; Grays Harbor Co., WA; 47°2'22"N, 123°49'48"W. Approved by State Board 6/91; U.S. Board 1991.

**BEN NEVIS:** Summit, elevation 117 m (385 ft.) on Shaw Island 2.9 km (1.8 mi.) SW of Orcas; San Juan Co., Washington; Sec. 29, T36N, R2W, W.M.; 48° 34' 50" N, 122 ° 58' 22" W. Approved by State Board 12/91; U.S. Board 4/92.

**BEN URE SPIT:** Large spit located 1/2 mile W of Hope Island, on the E side of Whidbey Island; Island Co., WA; Sec. 32, T 34 N, R 2 E, W.M.; 48°23'41" N, 122°35'03" W. Approved 9/76.

**BENCH, THE:** Ridge, 2.1 km. (1.3 mi.) long, between Sawtooth Ridge and Whitetail Butte 1 km. (0.6 mi.) NNW of Mountain View; Asotin Co., Washington; Secs. 24 and 25, T7N, R43E, and Sec. 30, T7N, R44E, Willamette Meridian; 46°03'50"N, 117°21'42"W (N end), 46°02'47"N, 117°21'18"W (S end).

**BENCHMARK MOUNTAIN:** Mountain, elevation 1,773 m. (5,816 ft.), 24.1 km. (15 mi.) N of Scenic; Snohomish Co., WA; 47°55'28" N, 121°12'06" W. Approved 9/76.

**BERRY CREEK:** Stream, 1.5 km (0.9 mi) long; Skamania Co., WA; in Secs. 3, 10, T 4 N, R 9 E, W.M.; flows SE to join Little White Salmon River; 45°51'14"N, 121°39'03"W (ending), 45°51'46"N, 121°39'38"W (heading). Approved 12-9-83.

**BETH LAKE:** Lake, 0.12 km<sup>2</sup> (approx. 30 acres), its approximate center is near the S/16 corner between Secs. 23 and 24, T 39 N, R 30 E, W.M.; in the Okanogan National Forest; a campground on its shores is maintained by the U.S. Forest Service and is named Beth Lake Campground; Okanogan Co., WA; 48°52'00"N, 118°59'00"W. Approved 3-13-87.

**BEUSCH LAKE:** Lake, located on that branch of Summit Creek which heads in Dumbbell Lake in Cowlitz Pass. It is about 804 m (0.5 mi) W of Dumbbell Lake, 6 km (3.75 mi) N from White Pass, or 22.5 km (14 mi) ENE of Packwood; Lewis Co., WA; Sec. 23, T 14 N, R 11 E, W.M.; 46°41'37"N, 121°23'42"W. Approved 12-12-86.

**BIG BOTTOM:** Flat, 47 km (29.5 mi.) long, in Gifford Pinchot National Forest, extends along the Cowlitz River from Cowlitz Falls to junction of Muddy Fork and Clear Fork Cowlitz River; Lewis Co., WA; 46°28'00"N, 122°06'15"W (SW end) 46°39'45"N, 121°35'15"W, (NE end). Approved by State Board 9/89; U.S. Board 1991.

**BIVIN LAKE:** Lake, 198 m (650 ft.) long, 2.4 km (1.5 mi) SSW of Skyo Mountain and 6.9 km (4.3 mi.) SW of Packwood; Lewis Co., WA; 46°33'23"N, 121°43'21"W. Approved by State Board 9/89; U.S. Board 1990.

**BIZ POINT:** Point of land, on the SW end of Fidalgo Island 8.1 km. (5 mi.) SW of Anacortes; named for the tugboat "BIZ"; the crew of this boat landed at this point in 1900 and painted the name Biz Point on a large boulder; Skagit Co., WA; Sec. 10, T 34 N, R 1 E, W.M.; 48°26'37" N, 122°40'34" W. Approved 9/76.

**BLAIR WATERWAY:** Channel, 4 km. (2.5 mi.) long, in the city of Tacoma; Pierce Co., Washington; Secs. 1 and 2, T20N, and Secs. 27, 34 and 35, T21N, R3E, Willamette Meridian; 47°16'45"N, 122°24'50"W (NW end), 47°15'20"N, 122°22'30"W (SE end).

**BLAZER CREEK:** Stream, 1.6 km. (1 mi.), long, heads at 47°00'23" N, 123°57'12" W, flows SSW to Little Hoquiam River 5.6 km. (3.5 mi.) W of Hoquiam; named for the "Blazers," a 4-H club which assisted the Department of Fisheries in building a salmon spawning bed on this stream; Grays Harbor Co., WA; Sec. 5, T 17 N, R 10 W, W.M.; 46°59'29" N, 123°57'41" W. Approved by State Board 3/78; U.S. Board 7/78.

**BLEWETT PASS:** Gap, elevation 1,250 m (4,102 ft.) in Wenatchee National Forest in Wenatchee Mountains, 2.7 km (1.7 mi.) N of Diamond Head; Chelan and Kittitas Counties; Washington; Secs. 3 & 4, T21N, R18E, W.M.; 47° 20' 08" N, 120° 34' 40" W. Approved by State Board 9/92; U.S. Board 11/92.

**BLIZZARD PASS:** Pass, in Olympic National Park, on the SE slope of Mount Olympus between Hoh and Humes Glaciers; Jefferson Co., WA; 47°47'20"N, 123°40'00"W. Approved 3-14-86.

**BLOODGOOD CREEK:** Stream, 4 km (2.5 mi) long, heads at Bloodgood Spring in the NW 1/4 of Sec. 8, T 4 N, R 16 E, W.M.; flows S to Little Klickitat River 1.3 km (0.8 mi) WNW of Goldendale; Klickitat Co., WA; 45°49'29"N, 120°50'08"W. Approved 12-14-85.

**BLOODGOOD SPRING:** Spring, at the head of Bloodgood Creek, 3.86 km (2.4 mi) NNW of Goldendale; Klickitat Co.; WA; Sec. 8, T 4 N, R 16 E, W.M.; 45°51'11"N, 120°49'57"W. Approved 12-14-85.

**BLUE HERON LAKE:** Lake, 488 m (1,600 ft) by 61 m (200 ft) located 2.3 km (1.4 mi) W of the community of Rock Island, 0.3 km (0.2 mi) N of the Columbia River; Douglas Co., WA; Sec 26, T22N, R21E, W.M. 47°22'36" N, 120°10'16 W. Approved by State Board 12/95; U.S. Board 5/97.

**BOAT HARBOR:** Cove, 0.16 km. (0.1 mi.) wide, on the E side of Guemes Island 4.3 km. (2.7 mi.) NE of Anacortes; Skagit Co., WA; Sec. 5, T 35 N, R 2 E, W.M.; 48°32'52" N, 122°34'40" W. Approved 9/76.

**BOLSTER CREEK:** Creek, flowing generally NW to the confluence of Myers Creek, near the site of Bolster; Okanogan Co., WA; heading in SE 1/4 Sec. 23, T 40 N, R 30 E, W.M.; 48°58'22"N, 119°01'14"W (ending), 48°57'02"N, 118°59'06"W (heading). Approved 3-13-87.

**BOURGEAU LAKE:** Lake, approximately 804 m (0.5 mi) long and 402 m (0.25 mi) wide; 8.0 km (5 mi) S of Inchelium, 2.25 km (1.4 mi) NW of the W shore of Franklin D. Roosevelt Lake, 804 m (0.5 mi) N of

Stray Dog Canyon; Ferry Co., WA; Sec. 36, T 32 N, R 36 E, W.M.; 48°13'50"N, 118°12'55"W. Approved 6-14-85.

**BOWERMAN BASIN:** Estuary, 3.1 km (1.9 mi) W of Hoquiam, on the NE side of county; Grays Harbor County, WA; 46°58'42"N, 123°55'57"W. Approved 6-14-85.

**BOWMAN BAY:** Cove, on the SW end of Fidalgo Is. between Rosario and Reservation Heads, 10 km. (6.2 mi.) SSW of Anacortes; named for Amos Bowman, who founded Anacortes in 1876; Skagit Co., WA; Secs. 22 and 23, T 34 N, R 1 E, W.M.; 48°24'52" N, 122°39'30" W. Approved 12/76.

**BRECKENRIDGE CREEK:** Stream, 10.8 km. (6.5 mi.) long, heads at 48°57'15"N, 122°11'50"W to the Sumas River 0.7 km. (0.4 mi.) E of Nooksack; Whatcom Co., WA; Sec. 29, T40N, R4E, W.M.; 48°55'37"N, 122°18'42"W. Approved 6/75.

**BRETLAND:** Place, described as Lot 3, containing 0.19 km<sup>2</sup> (47.5 acres) with approximately 0.5 km (1,650 ft) of shoreline, located on the eastern shore of Camano Island facing Port Susan, approximately 4.7 km (2.9 mi) from Kayak Point; Island Co., WA; Sec. 4, T 30 N, R 3 E, W.M., 48°07'26"N, 122°25'37"W. Approved 3-13-87.

**BREVICOMIS CREEK:** Stream, 5.6 km (3.5 mi.) long in Okanogan National Forest, heads on NW slope of South Twentymile Peak at 48° 40' 34" N, 120° 04' 10" W, flows NW to the Chewuch River, 5.6 km (3.5 mi.) SE of Doe Mountain; Okanogan Co., Washington; 48° 41' 37" N, 120° 07' 46" W. Approved by State Board 12/90; U.S. Board 3/92.

**BRICKYARD CREEK:** Stream, 8.9 km (5.5 mi.) long, heads in Bottomless Lake at 48°31'49"N, 122°13'38"W, flows SW to end in a system of ditches 4.5 km (2.8 mi.) W of Sedro Woolley; Skagit Co., WA; Sec. 16, T 35 N, R 4 E, W.M.; 48°30'30"N, 122°17'30"W. Approved 9/80.

**BROCK CREEK:** Creek, that starts near the N section line of Sec. 4, T 8 N, R 3 W, W.M.; and proceeds through Secs. 3, 4 and 10 until flowing into Harmony Creek. Length of creek is slightly more than 2.78 km (2+ mi). The creek generally flows in a southerly direction and parallels Eufaula Heights Road; Cowlitz Co., WA; 46°10'55"N, 123°03'34"W (heading), 46°11'42"N, 123°02'56"W (ending). Approved 6-12-87.

**BROOKFIELD POINT:** Cape; 75 feet elevation, located 0.36 miles SW of the town of Brookfield at 46°15'38.166"N, 123°33'51.49"W; name would replace Jim Crow Point and is in reference to the nearby town of Brookfield; Wahkiakum County, Washington; Sec. 16, T9N, R7W, W.M.; 46°15'38.166"N, 123°33'51.49"W. Approved 10-13-2016.

**BROUGHTON REACH:** Reach, of the Columbia River, extends E 26 km. (16 mi.) from Flag Island to a point W of Pierce Island; named for Lieutenant William Robert Broughton, Royal Navy, Commander of the armed tender Chatham of the Vancouver expedition; he explored the Columbia River in 1792 to the vicinity of Point Vancouver and was able to determine from that location that the Columbia River did not originate at Mount Hood; Multnomah Co., Or. and Skamania Co., WA; 45°32'45"N, 122°19'50"W (W end), 45°36'50"N, 122°01'40"W (E end). Approved 5/75.

**BRYANT HILL:** Summit; Located 1.77 km (1.1 mi) W of Stimson Hill, 6.44 km (4 mi) W/SW of Lake Cavanaugh, 11.26 km (7 mi) N of Arlington;

Named for the nearby historic community of Bryant; Skagit County, WA; Sec. 36, T 33 N, R 5 E, W.M.; 48° 18' 14.255" N, 122° 6' 22.321" W. Approved 2/5/2013.

**BUCKHORN:** Community, on the N shore of Orcas Island 3.2 km. (2 mi.) NE of Eastsound; San Juan Co., WA; Sec. 7, T 37 N, R 1 W, W.M.; 48°42'25" N, 122°52'05" W. Approved 12/76.

**BULLEN, MOUNT:** Summit, elevation 1,821 m (5,974 ft.) in Mount Baker National Forest, 4.8 km (3 mi.) N of Big Bear Mountain; Snohomish Co., WA. Sec. 14, T 29 N, R 5 E, W.M.; 48°11'46"N, 121°41'52"W. No Action by State Board; U.S. Board 1989.

**BURLAP PASS:** Gap; Elevation 979.93 m (3,215 ft), located in Olympic National Forest between East Fork Humptulips River and West Fork Humptulips River, 8.52 km (5.3 mi) SW of Discovery Peak; Named for David L. "Burlap" Rabey (1938-2002), a lifelong resident of Grays Harbor County who camped, hunted, and fished in the Humptulips River drainage area; Grays Harbor County, WA; Sec. 25, T 23 N, R 8 W, W.M.; 47° 27' 23.527" N, 123° 38' 59.534" W. Approved 7/2/2013.

**BURPING BROOK:** Short perennial stream, heading in the SW 1/4 of Sec. 16, T 28 N, R 45 E, then flowing generally S to a confluence with Deadman Creek in the NE 1/4 of Sec. 28, T 28 N, R 45 E; Spokane Co., WA; 47°53'11" N, 117°07'47" W; 47°55'05" N, 117°07'20" W. Approved by State Board 9/76; U.S. Board 4/77.

**BURRI CREEK:** Stream, 1.6 km (1 mi.) long, heads at 47°59'32"N, 122°07'22"W, flows NW to Ebey Slough, 4 km (2.5 mi.) E of Everett and 2.4 km (1.5 mi.) N of Cavalero Corner; Snohomish Co., WA., Sec. 14, T 29 N, R 5 E, W.M.; 47°59'59"N, 122°08'10"W. Approved by State Board 9/89; U.S. Board 4/90.

**CAKE ROCK:** Island, 183 m. (600 ft.) long, in the Pacific Ocean 4.5 km. (2.8 mi.) NW of La Push; Clallam Co., WA; T 28 N, R 15 W, W.M.; 47°55'57" N, 124°41'00" W. Approved 12/76.

**CALAMITY PEAK:** Mountain, elevation 1.30 km (4,287 ft), located 3.6 km (2.25 mi) E of West Point and 4.4 km (2.75 mi) W of Bare Mountain; Skamania Co., WA; 45°55'00"N, 122°07'30"W. Approved 6-13-86.

**CALEDONIA:** Populated place, elevation 7 m (23 ft.), on the Puget Sound, between Dash Point and Browns Point, 4.8 km (3 mi) NE of Tacoma; Pierce Co., Washington; Sec. 16, T21N, R3E, W.M.; 47° 18' 34" N, 122° 25' 48" W. Approved by State Board 9/93; U.S. Board 4/94.

**CALEDONIA BEACH:** Beach, 0.8 km (0.5 mi), between Browns Point and Dash Point on the Puget Sound, 4.8 km (3 mi.) NE of Old Tacoma; Pierce Co., Washington; Sec. 16, T21N, R3E, W.M.; 47° 18' 32" N, 122° 25' 48" W. Approved by State Board 9/93; U.S. Board 4/94.

**CAMP MUIR:** Locality, in Mt. Rainier National Park, on Cowlitz Cleaver between Cowlitz Glacier and Muir Snowfield on SE slope of Mt. Rainier; Pierce Co., WA; 46°50'08" N, 121°43'55" W. Approved by State Board 12/77; U.S. Board 1/78.

**CANYON FALLS:** Falls, approximately 14 m (45 ft) high, on the South Fork Skykomish River, approximately 2.4 km (1.5 mi) upstream from Sunset Falls and 3.2 km (2 mi) downstream from Eagle Falls; Snohom-
