**WAC 246-915A-010 Physical therapy licensure compact—Compact commission rules.** (1) The physical therapy licensure compact (compact) is established in Washington under RCW 18.74.500. Its purpose is to facilitate interstate practice of physical therapy with the goal of improving public access to physical therapy services.

(2) The rules of the physical therapy compact commission, in effect as of June 17, 2024, are adopted and incorporated by reference.

(4) A licensee may exercise a compact privilege as provided in RCW 18.74.500, Article IV. Applicable fees are set forth in WAC 246-915A-990.

**WAC 246-915A-990 Physical therapist and physical therapist assistant compact privilege fees and renewal cycle.** (1) The compact privilege must be renewed no later than the expiration date of the home state license. The compact privilege holder must comply with all physical therapy licensure compact eligibility requirements in this chapter to maintain the compact privilege.
